- Western Pacific – No activity affecting U.S. interests during the next 48 hours

Significant Weather:

- Severe Thunderstorms possible – Plains to Great Lakes and Ohio Valley
- Flashing Flooding possible – Middle Mississippi Valley, Great Lakes, and Ohio Valley
- Space Weather:
 - Past 24 hours: None observed
 - Next 24 hours: None predicted

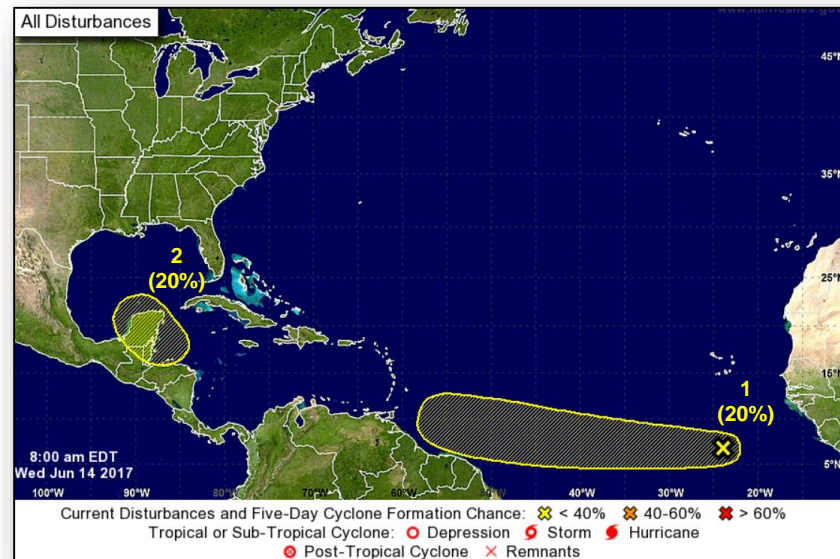


Disturbance 1 (as of 8:00 a.m. EDT)

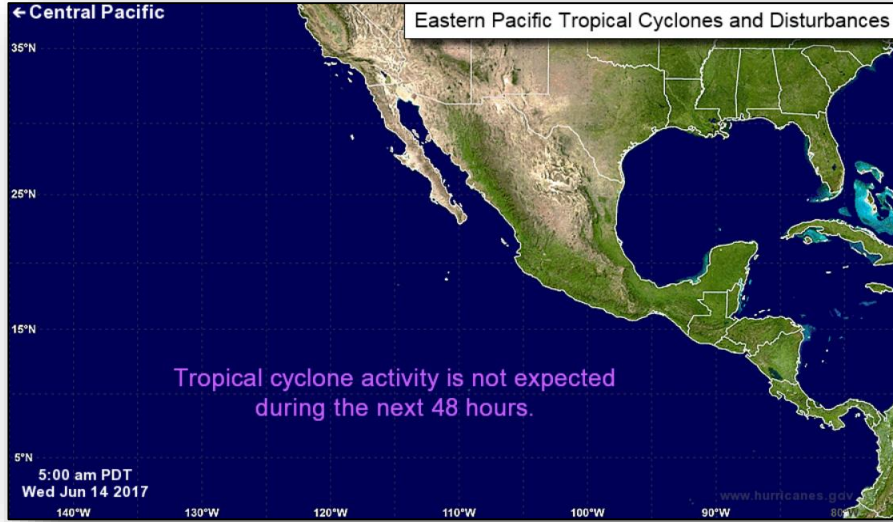
- Located south of the Cape Verde Islands

- Gradual development possible as it moves northwestward
- Formation chance through 48 hours: Low (near 0%)

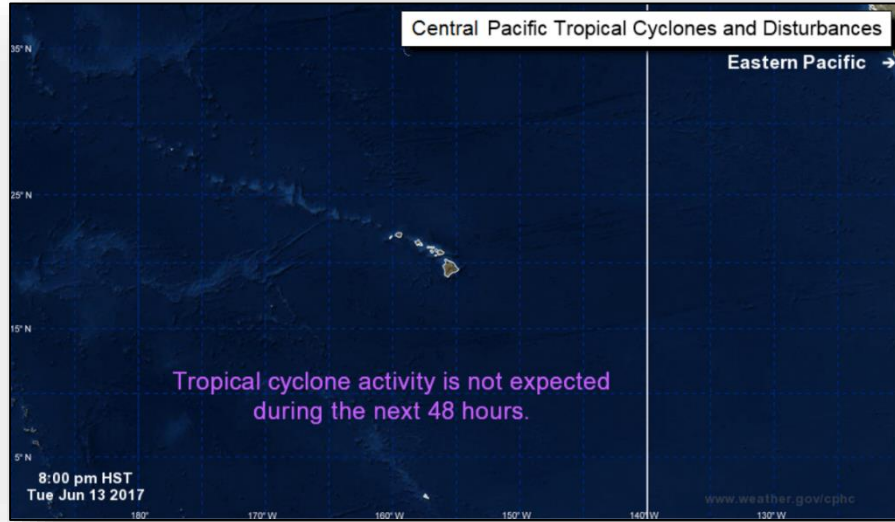


5 Day Outlook

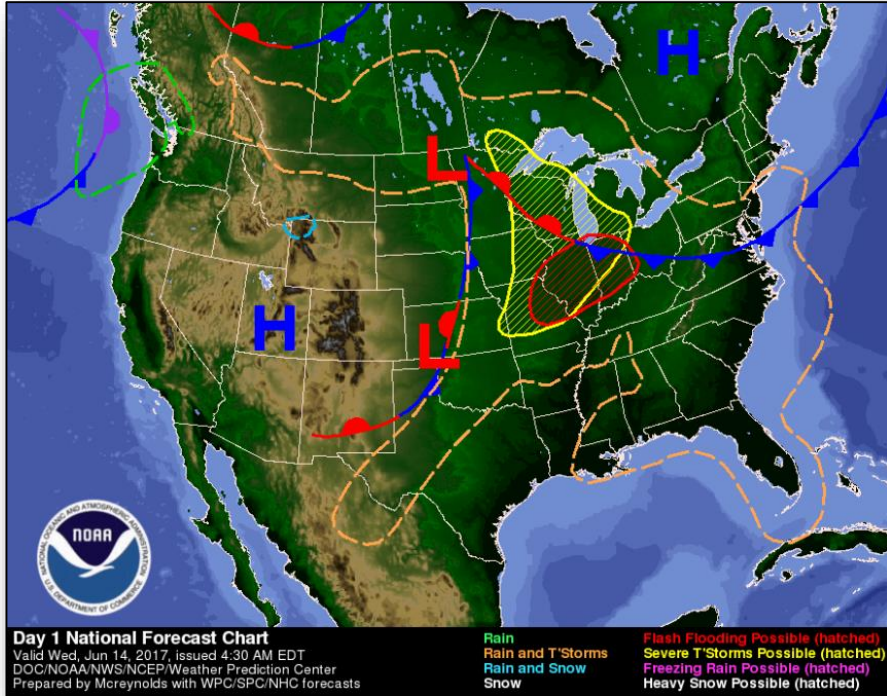

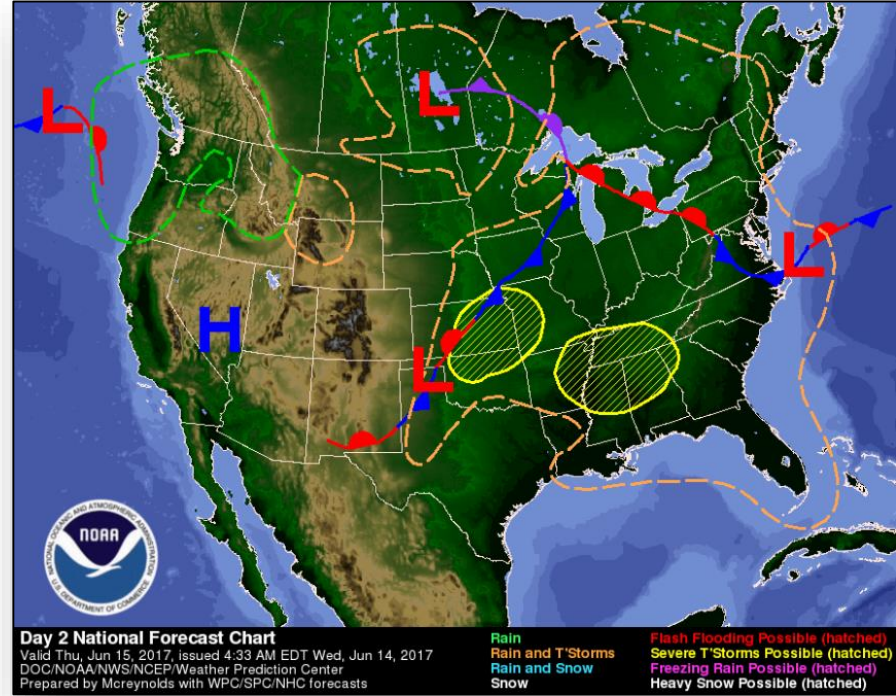

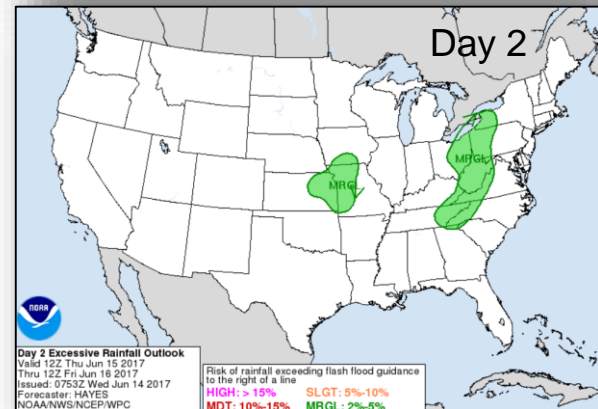
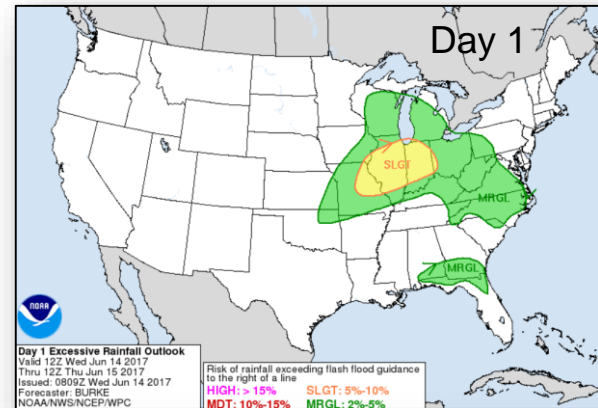
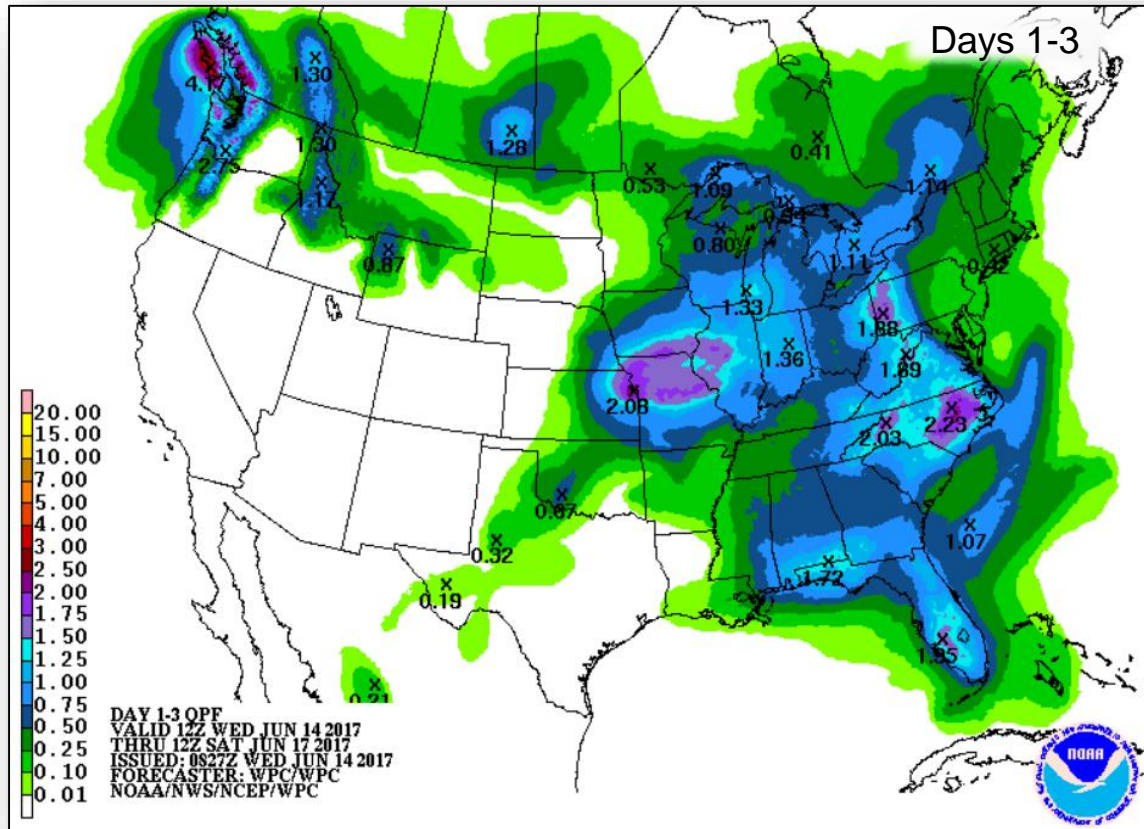
Severe Weather Outlook – Days 1-3



Precipitation Forecast / Flash Flood Risk



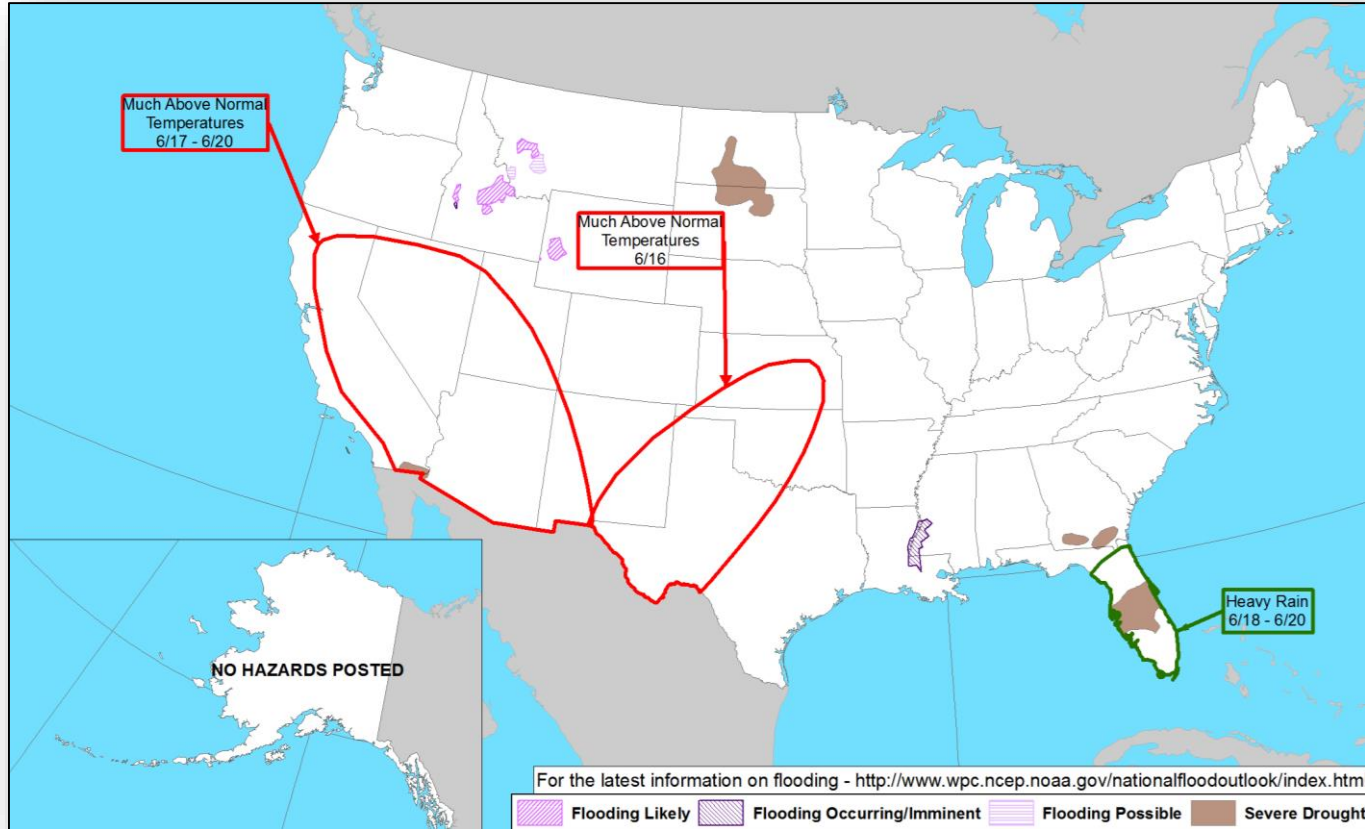

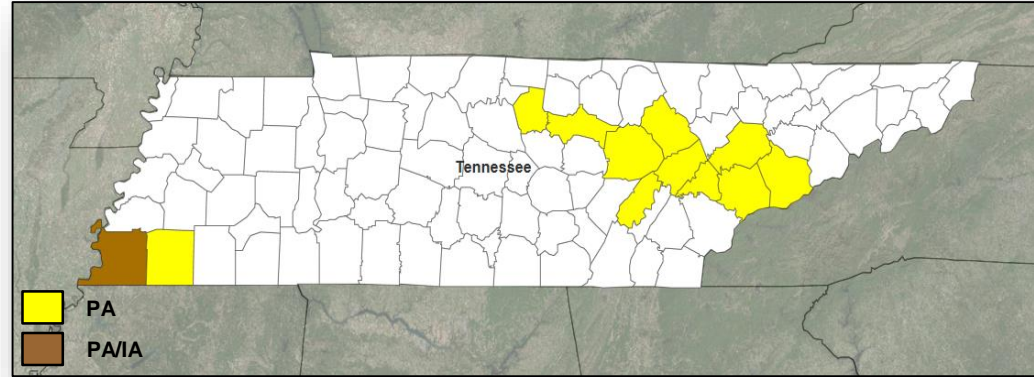
