# Significant Activity – June 23-24



**Significant Events:** Post-Tropical Cyclone Cindy - FINAL

**Tropical Activity:**

- Atlantic – No tropical cyclones expected during the next 48 hours
- Eastern Pacific – Disturbance 1: High (90%)
- Central Pacific – No tropical cyclones expected during the next 48 hours
- Western Pacific – No activity affecting U.S. interests during the next 48 hours

**Significant Weather:**

- Flash flooding possible – Southern Plains to Mid-Atlantic
- Isolated dry thunderstorms - CA
- Space Weather – Past 24 hours: None; Next 24 hours: None

**Earthquake Activity:** No significant activity

**Declaration Activity:**

- Amendment No. 1 to FEMA-4319-DR-KS
- Major Disaster Declaration approved - Tennessee

# Post-Tropical Cyclone Cindy - FINAL



## **Post-Tropical Cyclone Cindy** (Advisory 19 as of 5:00 am EDT)

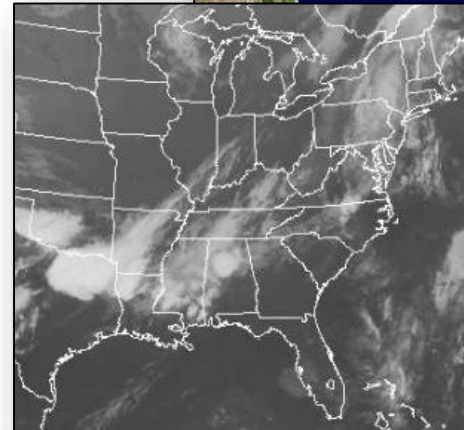
- Located 100 miles WSW of Philadelphia, PA
- Moving ENE at 45 mph
- Maximum sustained winds 25 mph
- Cindy has lost tropical characteristics, heavy rain potential spreading eastward into southern NY and southern New England
- Flash Flood Warnings in effect for parts of southern OH
- Additional rainfall of 1-2 inches with locally higher amounts possible across northern Mid-Atlantic and southern New England

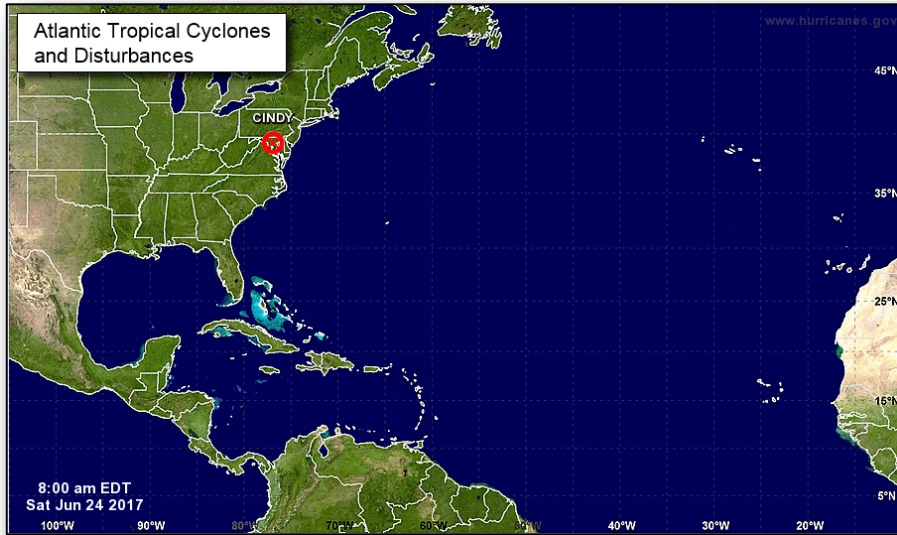

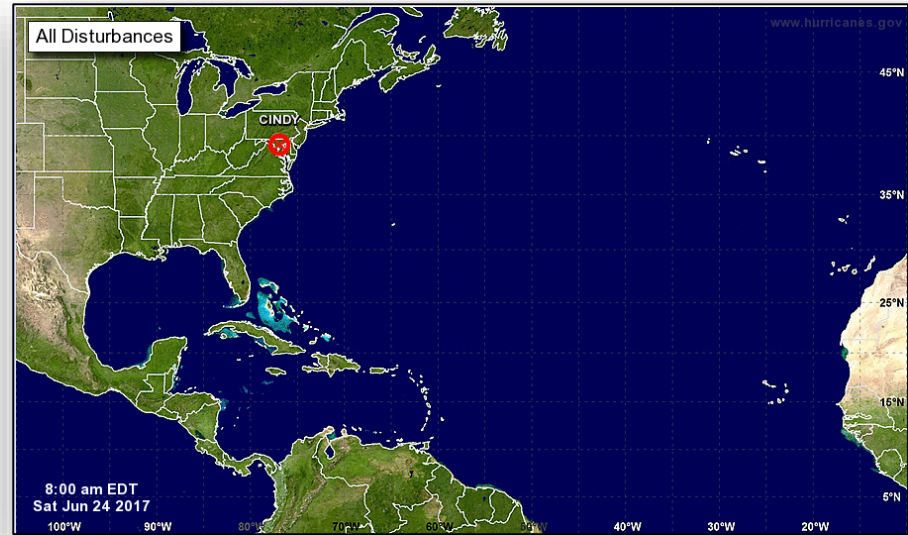

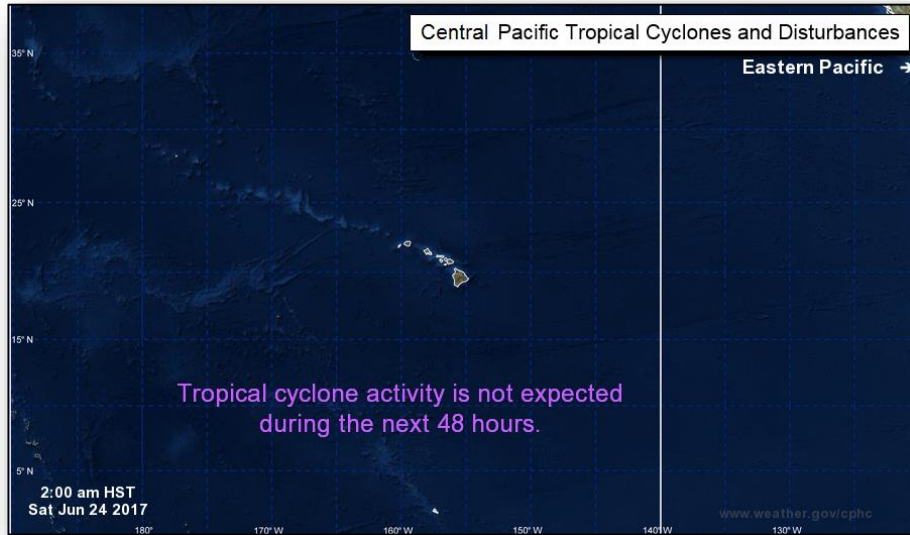


## **Disturbance 1** (as of 8:00 a.m. EDT)

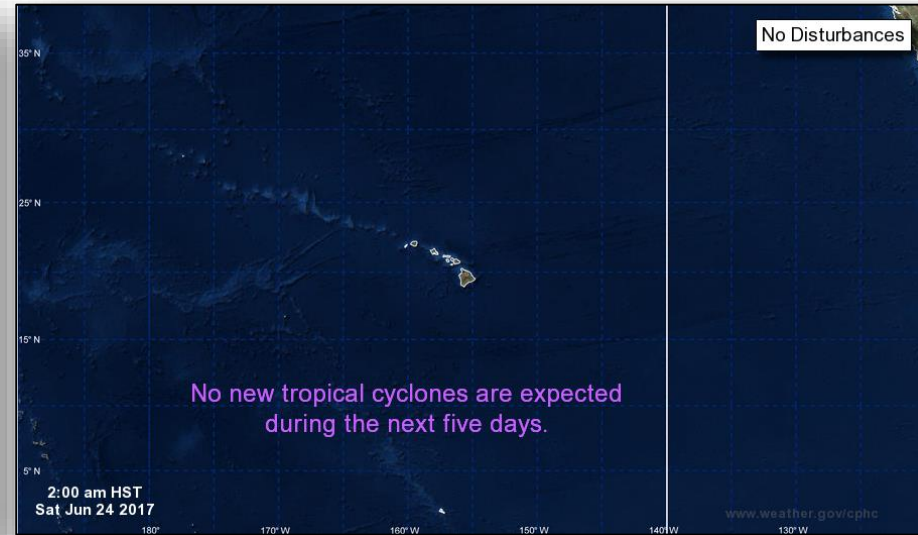
- Located a few hundred miles SE of Acapulco, Mexico
- Moving WNW at 10 mph, parallel to coast of Mexico
- Tropical depression likely to form later today or Sunday
- Formation chance through 48 hours: High (80%)
- Formation chance through 5 days: High (90%)

# Declaration Approved



## **FEMA-4320-DR-TN**

- Major Disaster Declaration approved June 23, 2017 for State of Tennessee
- For severe storms, straight-line winds, and flooding that occurred May 27-28, 2017
- Provides:
  - Public Assistance for 12 counties
  - Hazard Mitigation statewide
- FCO is Warren J. Riley

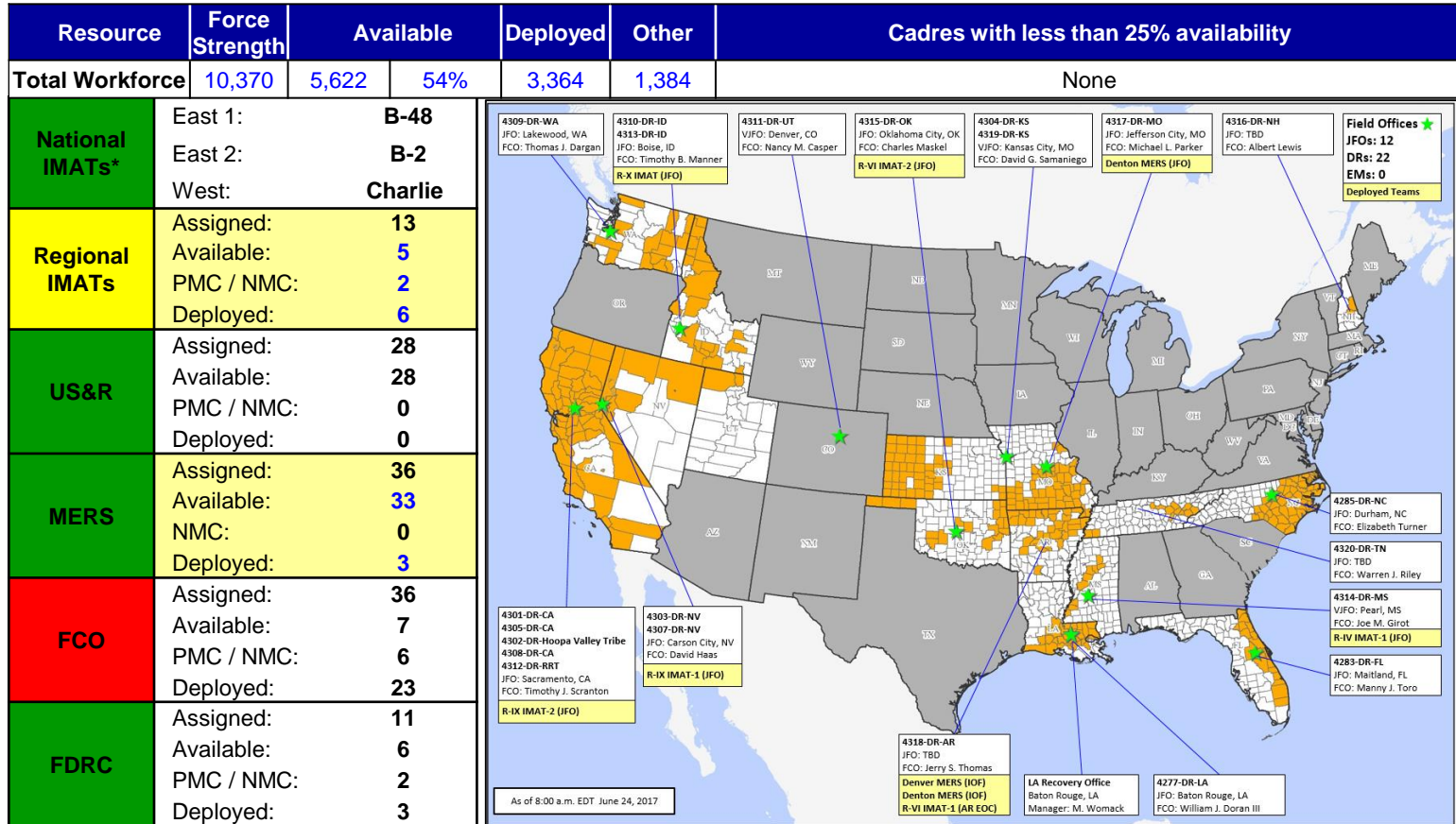
