Significant Activity – July 14 - 15



#### Significant Events: None

#### **Tropical Activity:**

- Atlantic No tropical cyclones expected next 48 hours
- Eastern Pacific Hurricane Fernanda (CAT 4); Disturbance 1 Medium (40%); Disturbance 2 Low (10%)
- Central Pacific No tropical cyclones expected next 48 hours
- Western Pacific No activity affecting U.S. interests

#### **Significant Weather:**

- Severe thunderstorms possible Upper Mississippi Valley and Great Lakes
- Flash flooding possible Southern/Central Plains, Lower Mississippi/Tennessee valleys, and the Mid-Atlantic
- Elevated to Critical Fire Weather conditions Northern Plains, Northern Intermountain, and California
- Isolated to Scattered Dry Thunderstorms Central Great Basin, Northern Intermountain, Northern Rockies and Northern Plains
- Space Weather Past 24 hours: Minor, solar radiation storms reaching S1 level occurred; next 24 hours: minor, solar radiation storms reaching S1 level expected

Earthquake Activity: No significant activity

Hurricane Fernanda (CAT 4) (Advisory #14 as of 5:00 a.m. EDT)


- Located 1,145 miles SW of southern tip of Baja California, Mexico
- Maximum sustained winds 145 mph
- Based on current advisory, there are no threats to U.S. interests

#### Disturbance 1 (as of 8:00 a.m. EDT)

- Located a few hundred miles SW of Gulf of Tehuantepec
- Tropical depression could form by early next week
- Formation chance through 48 hours: Medium (40%)
- Formation chance through 5 days: Medium (60%)


#### Disturbance 2 (as of 8:00 a.m. EDT)

- Located several hundred miles SW of Manzanillo, Mexico
- Development, if any, will be slow to occur
- Formation chance through 48 hours: Low (10%)
- Formation chance through 5 days: Low (20%)










#### National Weather Forecast






### Precipitation Forecast / Flash Flood Risk







### Regional River Forecast – Fox & Des Plaines






- Fire began July 14, 2017 and is burning in and around the community of Red Rock and Stead (combined pop. 10,000); approximately 19 miles NW of Reno
- Voluntary evacuations in effect for 200 people
- No injuries or fatalities


