Significant Activity – August 23-24



Significant Events: Tropical Weather Threat – Gulf Coast

Tropical Activity:

- Atlantic – Tropical Storm Harvey; Disturbance 1 – Low (30%)
- Eastern Pacific – No tropical cyclones expected next 48 hours
- Central Pacific – No tropical cyclones expected next 48 hours
- Western Pacific – No activity affecting U.S. interests

Significant Weather:

- Flash Flooding possible – Southwest, Southern Plains, Southeast & Mid-Atlantic
- Elevated Fire Weather conditions for portions of WA, OR, ID, & MT
- Isolated to Scattered Dry Thunderstorms increasing fire weather threat for portions of WA, OR, ID, WY and MT
- Space weather:
 - Past 24 hours: Minor-G1
 - Next 24 hours: None

Earthquake Activity: No significant activity

Declaration Activity: None

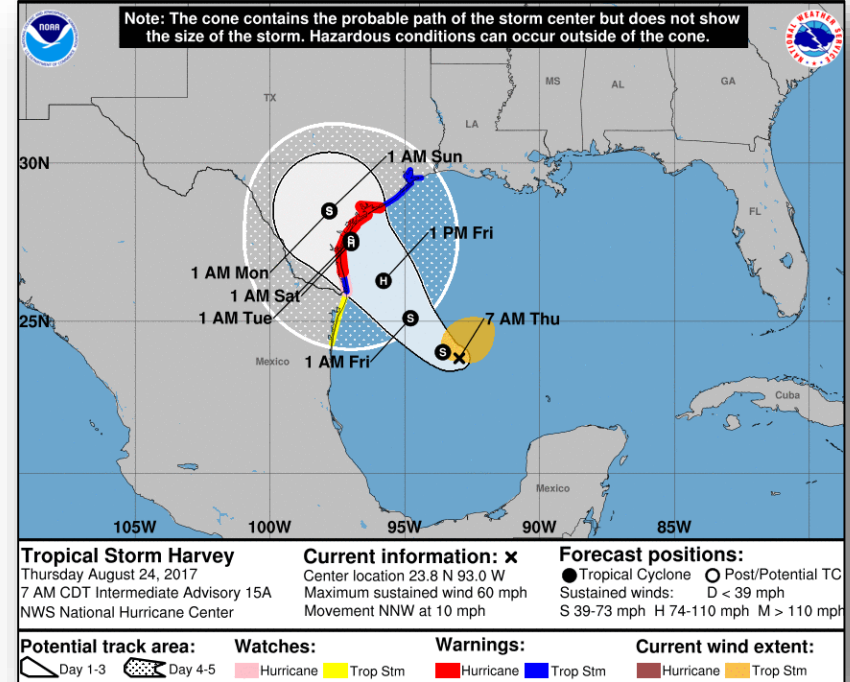
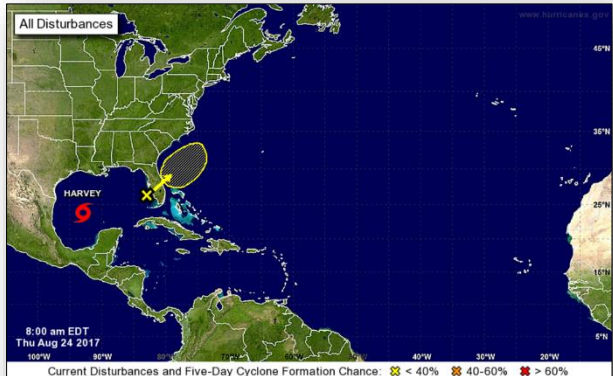


Tropical Storm Harvey (Advisory #15a, as of 8:00 a.m. EDT)

- Located 380 miles SE of Port O'Connor, TX
- Moving NNW at 10 mph
- Expected to become a hurricane on Friday
- Maximum sustained winds 60 mph
- Watches and Warnings in effect for coastal TX

Disturbance 1 (as of 8:00 a.m. EDT)

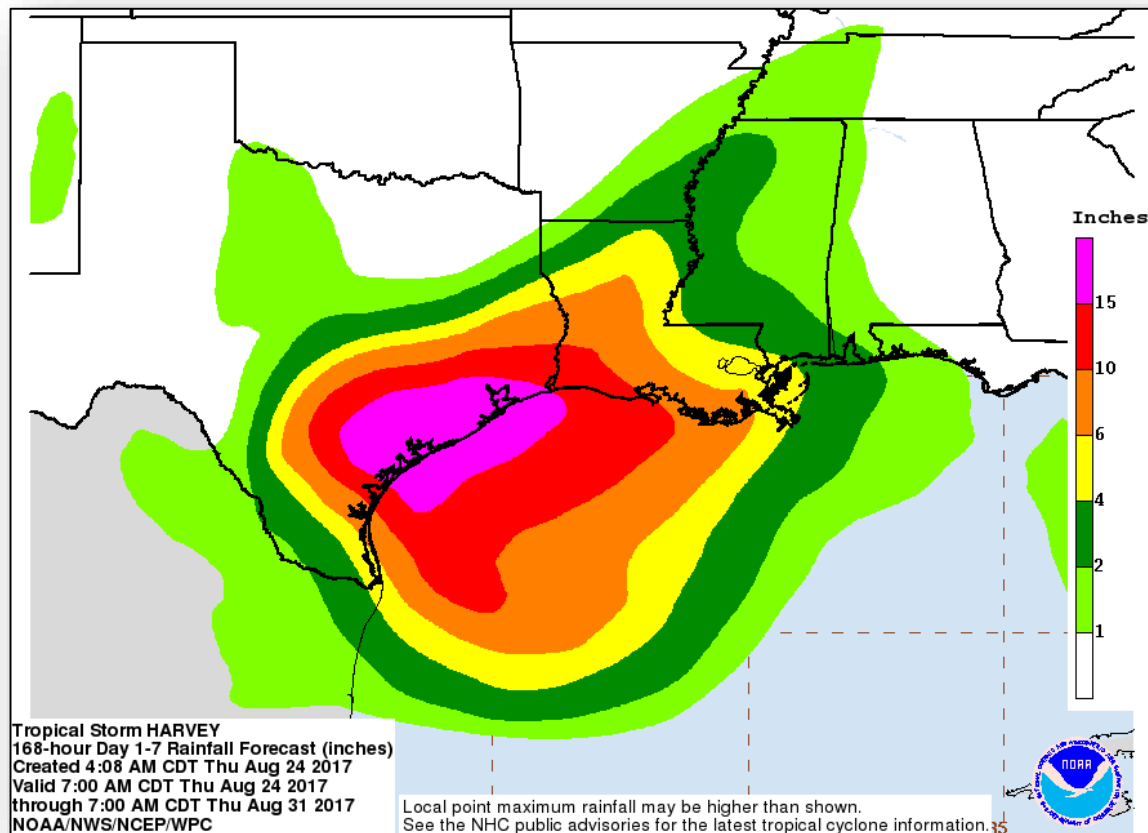
- Located near FL peninsula
- Drifting N over FL
- Expect heavy rain and flooding over FL
- Formation chance through 48 hours: Low (10%)
- Formation chance through next 5 days: Low (30%)



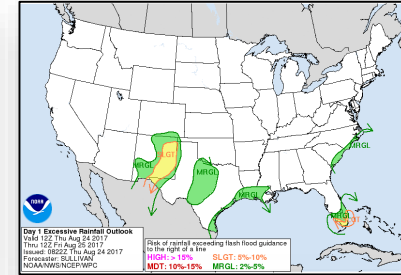
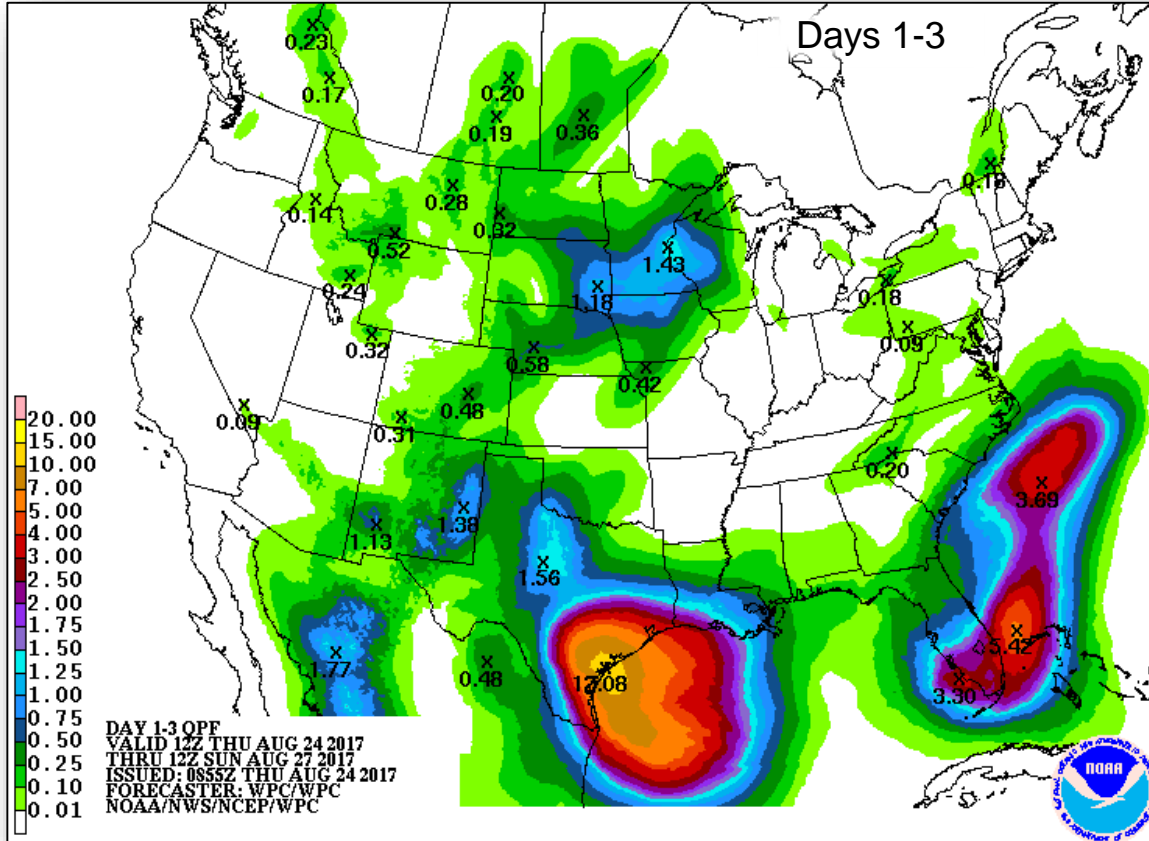
TS Harvey Rainfall Forecast – Days 1-7



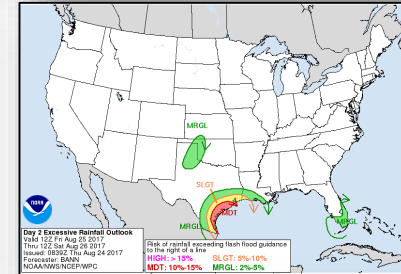

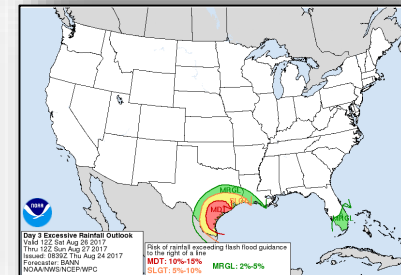
Precipitation Forecast

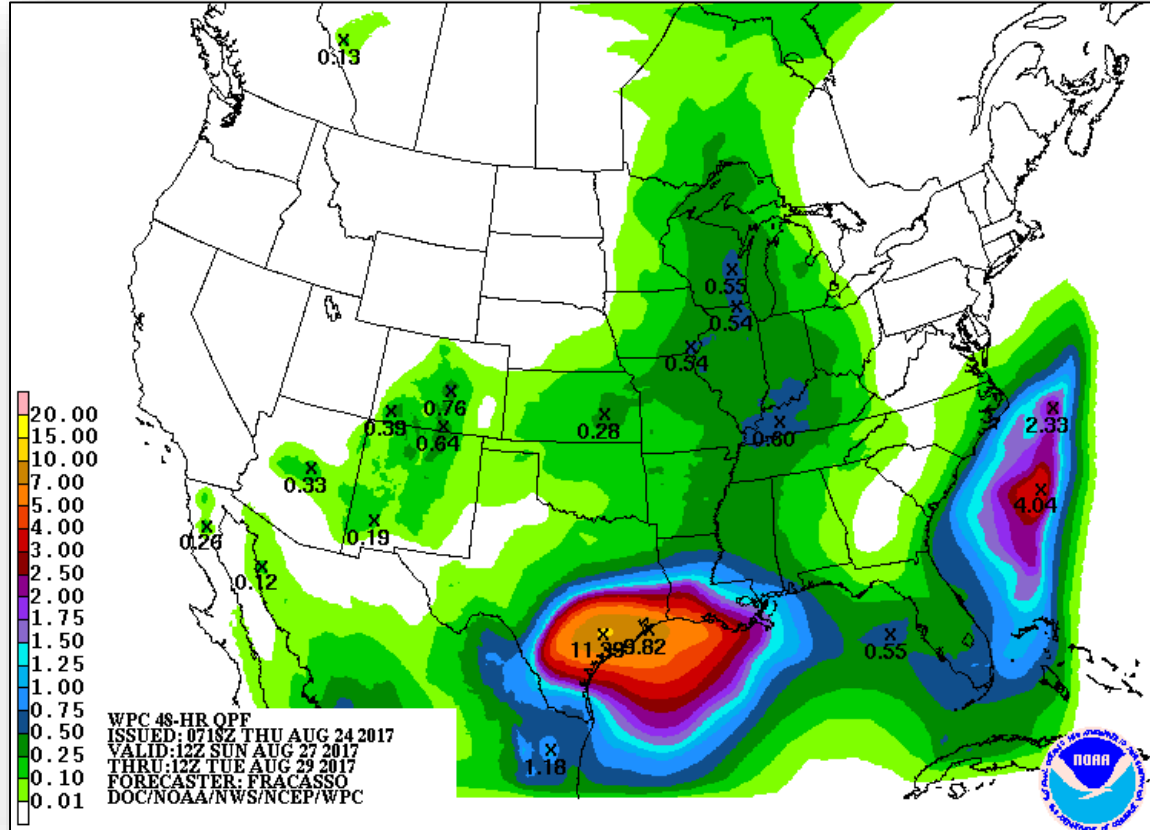

FEMA Region VI – Tropical Weather Threat



Situation

Tropical Storm Harvey continues to drift NW towards Texas; potential for prolonged heavy rains, flooding and storm surge along the coast remains.

Analysis/Potential Impacts

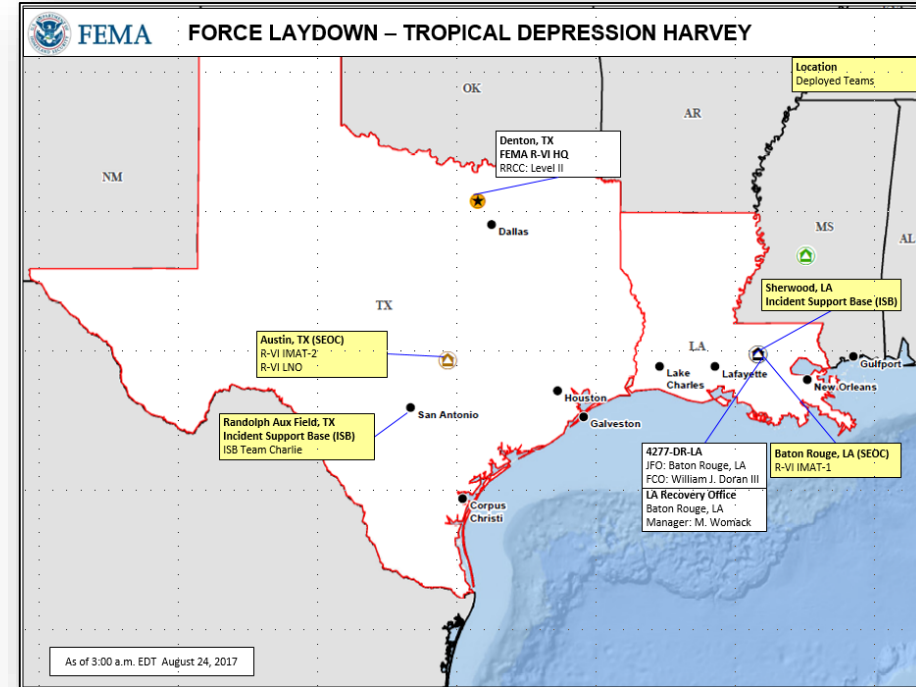
- Port Arthur, TX seawall vulnerable to storm surge due to previous damage (USACE)
- New Orleans flooding threat increased due to degradation of city pumping system; **overall pumping capacity availability at 90%** (Various sources)
- Prolonged periods of heavy rainfall/flooding across portions of TX & SW LA (NHC)
- Storm surge & tropical storm or hurricane force winds along portions of the TX coast (NHC)
- **Oil companies limiting production/evacuating personnel from Gulf platforms**

States Preparation/Response

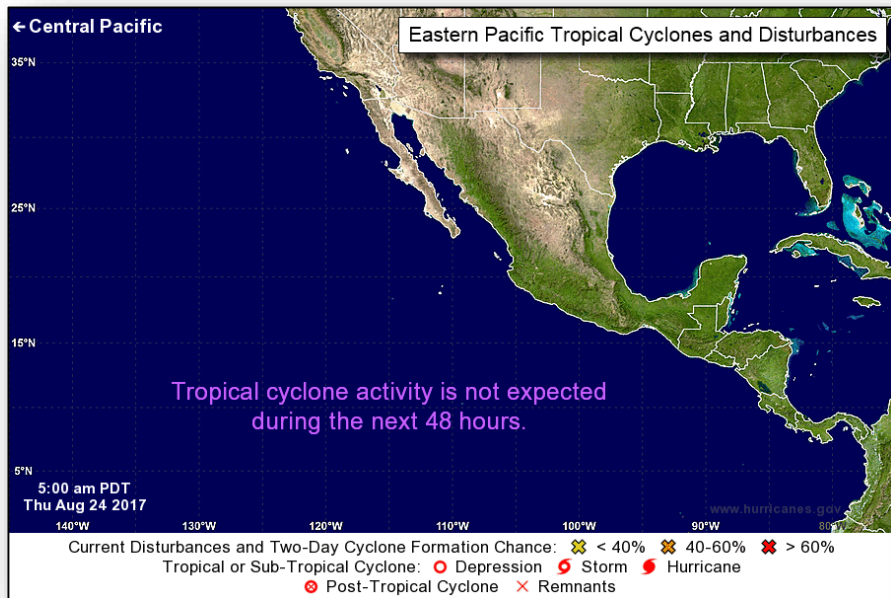
- **LA SEOC at Monitoring**
- **TX Governor declared State of Disaster for 30 counties**; SEOC at Partial Activation

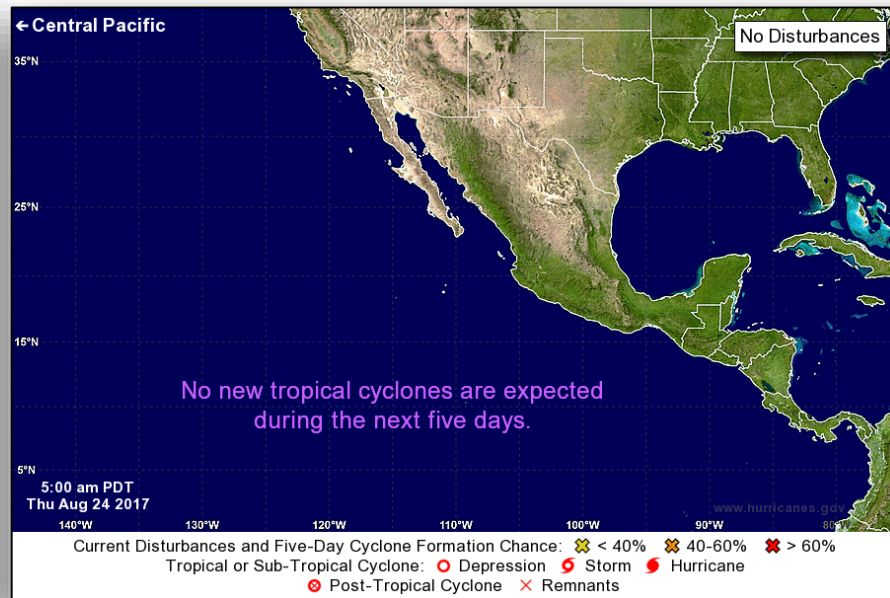
- NWC at Enhanced Watch, 24/7 ops

Tropical Outlook – Eastern Pacific

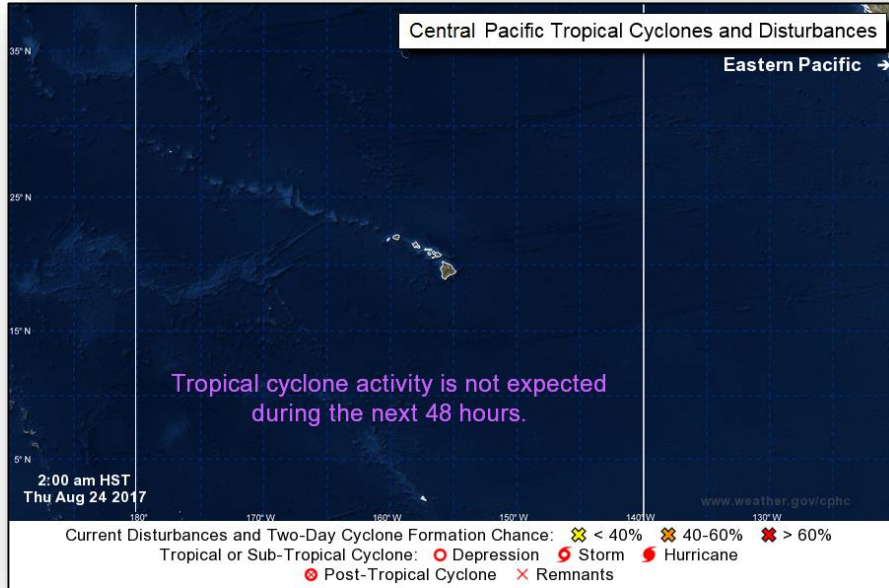

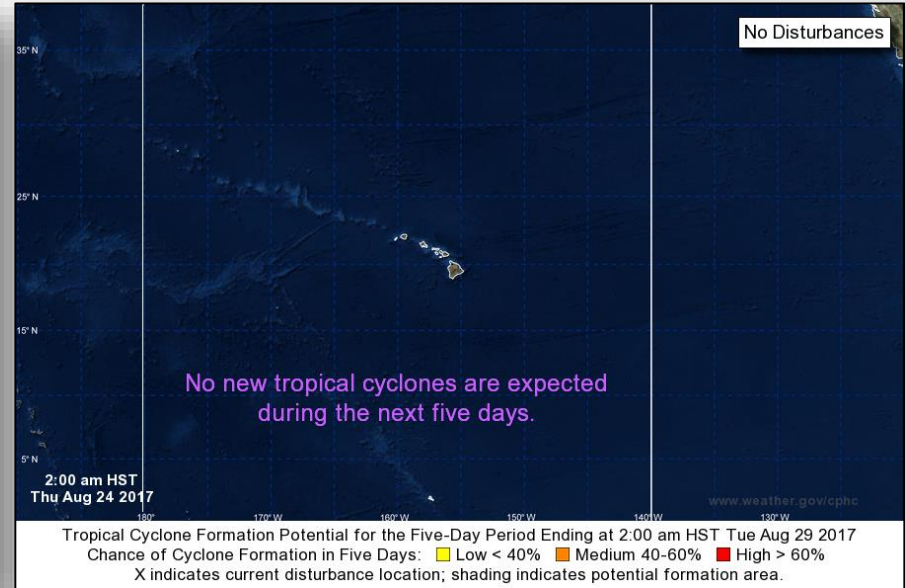


5 Day Outlook

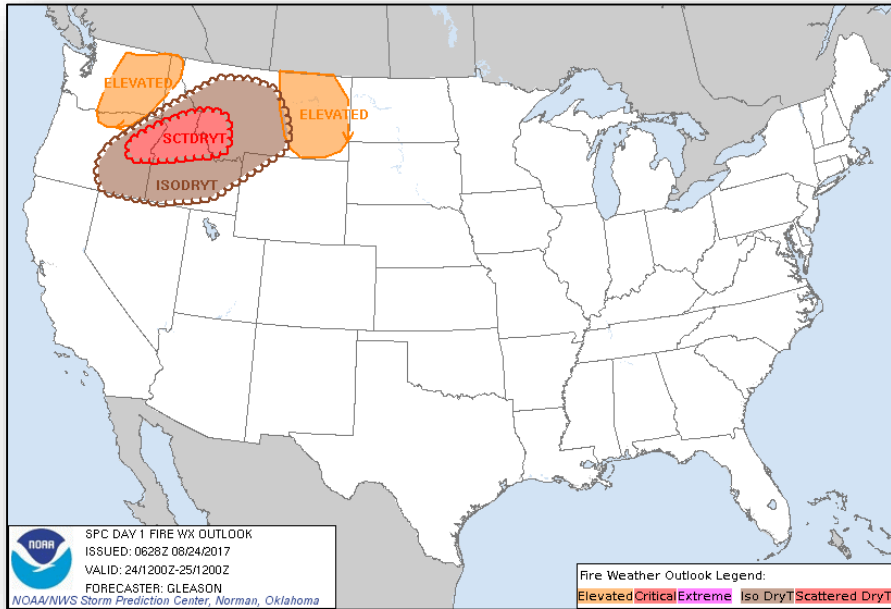
National River Flood Outlook



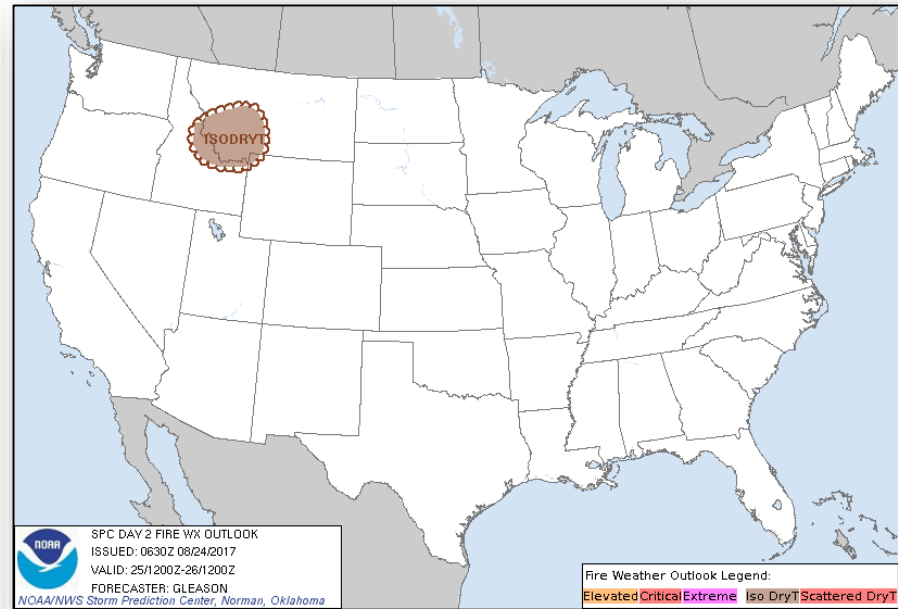
