Tropical Activity:

- Atlantic Hurricane Nate, Disturbance 1 High (70%)
- Eastern Pacific No tropical cyclones expected next 5 days
- Central Pacific No tropical cyclones expected next 5 days
- Western Pacific No activity affecting U.S. interests

Significant Weather:

- Flash Flooding possible NE, KS, IA, MO, & MN
- Severe thunderstorms possible TX, OK, & KS
- Elevated/Critical Fire weather conditions CA
- Red Flag Warnings CA, SD, & WY
- Space Weather: Past 24 hours: None observed; Next 24 hours: None predicted

Hurricane Nate


Hurricane Nate (Advisory #12 as of 8:00 a.m. EDT)

- Located 320 miles SSE of New Orleans, LA
- · Moving NNW at 22 mph
- · Maximum sustained winds of 85 mph
- Hurricane force winds extend 35 miles; Tropical storm force winds extend 125 miles
- Some strengthening possible before making landfall tonight
- Hurricane, Tropical Storm & Storm Surge Warnings issued for LA, MS & AL
 - o Watches issued for LA & FL

Potential Impacts (dependent on track and intensity)


- Tropical storm force winds starting today; hurricane force winds are possible across coastal AL & inland southeast MS
- Maximum surge is likely late tonight through early Sunday
 - 4-6 feet of inundation possible along coast from Morgan City, LA to the Mississippi River
 - o 5-8 feet (up to 9 feet) from the Mississippi River to the AL/FL border
 - o 4-6 feet (up to 7 feet) possible for the northwest Florida panhandle.
 - o 3-5 feet along the Lake Pontchartrain
- Expect 3-6 inches of rain with locally higher amounts up to 8 inches possible
- Tornado threat exists across much of the area today through midday on Sunday
- Increasing surf heights are possible through the weekend







Precipitation Forecast & Flash Flood Risk

Preparations

FEMA Headquarters

- NRCC: Level I (24/7) continuing from Maria/Irma/Harvey
- US&R: White IST staged in Atlanta, GA; TN-TF1 on alert
- FEMA Region V IMAT redeployed from TX to MS EOC

FEMA Region IV

- RRCC will activate to Level II (Partial Activation) at 12:00 pm EDT with select ESF(Day shift only)
- RWC will go to Enhanced Watch Night shift only
- IMAT-1 in FL (Irma)
- IMAT-2 in GA (Irma)
- LNOs deployed to MS, AL, GA and Seminole Tribe of FL
- MS EOCs at Partial Activation (Governor declared State of Emergency)
- AL & FL EOC at Full Activation (Governors declared State of Emergency)

FEMA Region VI:

- RRCC: Level II, day shift only
- IMAT-1 redeployed from TX to LA (Nate)
- LNO deployed to New Orleans & State EOC; Deployed to NHC
- LA EOC at Full Activation
- Evacuations ordered for 5 parishes in LA



Current Situation

Life safety and life sustainment efforts in PR and the USVI are ongoing.

Population Impacts

- PR: Shelters: 116; Population: 7,462 (-759); Disaster Assistance Registrations: 29,765;
- USVI: Shelters: five; Population: 344 (-27); Disaster Assistance Registrations: 7,610

Communications

- PR: 15.4% cell service restored, covering 49% of the population (1 carrier)
- USVI: 43% cell service restored; St. Thomas: 53% cell service restored; St.John: No cell sites operational; St. Croix: 37% cell service restored

Power Outages / Restoration

- PR: 10.7% with electricity; Generators: Completed 179 of 290 requested generator pre-installation inspections;
 35 installed; 242 are on hand; 343 en route; additional 249th Engineering Battalion personnel scheduled to arrive October 12
- USVI: Customers on the power grid: St. Thomas 19%,
 St. John 0%; St. Croix 1%; Generators: 41 installed; 6
 de-installed; 46 available on island; 41 en route

Health & Medical


- PR: 66 of 67 hospitals open, four of seven regional pediatric centers open; All dialysis centers operational, One Federal Medical Station (FMS) operational and four FMS in staging; PR Department Of Health completed nursing home assessments on October 6; compiling results; site survey for DoD Combat Support Hospital (CSH) in central PR conducted on October 6; additional CSH expected to arrive in PR by October 9 and be operational middle of next week
- USVI: 5 health care centers are operational, 2 are closed, and 3 provide limited service; 117 dialysis patients remain in St. Croix, where there are 2 dialysis providers; other patients previously evacuated; 575th Area Support Medical Company expected to fully arrive in St. Croix on October



National Weather Forecast











Severe Weather Outlook – Days 1-3











Fire Weather Outlook





Hazards Outlook – Oct 9-13







