Significant Activity – Oct 26-27



Significant Events:

- Response and Recovery – Tropical Cyclones Harvey, Irma, and Maria

Tropical Activity:

- Atlantic – Invest 93L: Medium (60%)
- Eastern Pacific – Tropical Storm Selma
- Central Pacific – No tropical cyclones expected next 48 hours
- Western Pacific – No activity affecting U.S. interests

Significant Weather:

- Elevated Fire Weather – CO, NE & KS
- Heavy Snow possible – Great Lakes
- Space Weather:
 - Past 24 hours: None observed
 - Next 24 hours: None predicted

Earthquake Activity: No significant activity

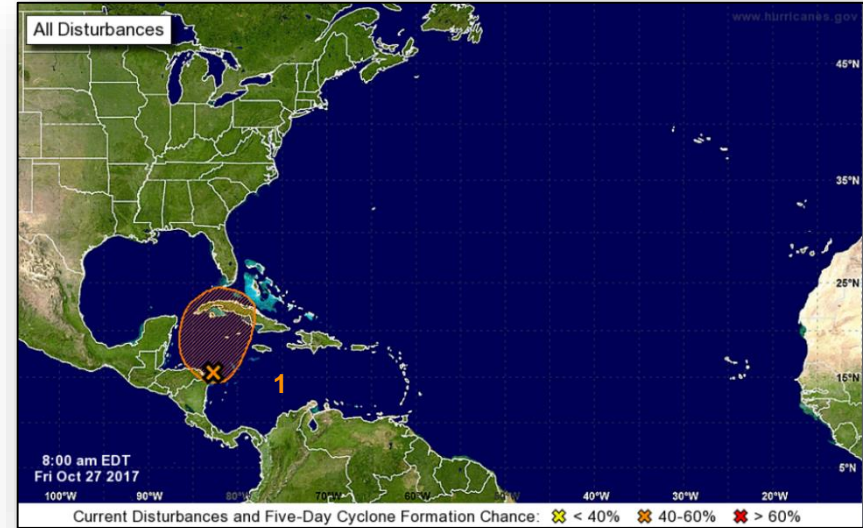
Declaration Activity:

- Amendment No. 1 to FEMA-3394-EM-AL – Closes the incident period effective October 10, 2017
- Amendment No. 7 to FEMA-4338-DR-GA – Adds additional categories of Public Assistance to 2 counties

Tropical Outlook – Atlantic

Disturbance 1 (Invest 93L) (as of 8:00 a.m. EDT)

- Located over northwestern Caribbean Sea
- Expected to be conducive for development today and Saturday
- Tropical depression could form as the system moves northward
- Formation chance through 48 hours: Medium (60%)
- Formation chance through 5 days: Medium (60%)



Tropical Outlook – Eastern Pacific

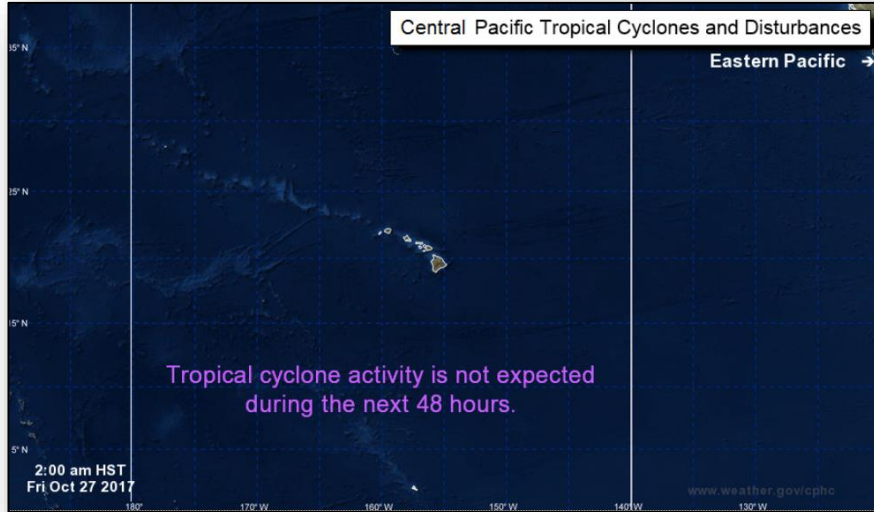


Tropical Storm Selma (Advisory 1A, as of 7:00 a.m. EDT)

- Located 210 miles south of San Salvador, El Salvador
- Moving NW at 5 mph
- Maximum sustained winds 40 mph
- Tropical Storm Warnings issued for El Salvador

PR/USVI Update



Puerto Rico

- Shelters: **82 (-1)** shelters open with **3,655 (-116)** occupants
- Disaster Assistance Registrations: **949k (+22k)**

Power Outages / Restoration

- **26.2% (+1.2)** of customers with power restored
- PREPA estimating 95% to be restored by December 15

Communications:

- **39% (+4)** of cell towers are operational
- 35 of 78 municipalities are partially energized or have energized facilities
- 87% of population lives in area where wireless coverage is available

Health & Medical

- 65 of 67 hospitals open; **45 (-2)** on power grid, **21 (+2)** on generator power, **2 with unknown status**

Water Restoration

- **75% (+0.6)** of PRASA customers have potable water; PRASA covers 96% of PR
- **8 (-4)** of 51 PRASA waste water treatment plants out of service
- **30 (-7)** of **114 (+1)** PRASA drinking water treatment plants are out of service
- Boil water advisory remains in effect island-wide

Guajataca Dam

- Dam level is **7.3** feet below spillway; additional reduction of **6.7** feet is needed before evacuation orders can be lifted; leveling to 14 feet below spillway is expected by November 1

U.S. Virgin Islands

- Shelters: **4 (-1)** shelters open with **197 (-31)** occupants
- Disaster Assistance Registrations: **17.2k (+0.3k)**

Power Outages / Restoration

- Customers receiving power from grid: St. Thomas: **30.8% (+0.6)**; St. Croix: **3% (+0.1)**; St. John: no grid power, expected to begin restoration later this week
- WAPA estimates 90% to be restored by late December

Communications:

- **50% (+2)** of cell sites are operational
- 88% of population lives in area where wireless coverage is available

Health & Medical

- St. Thomas: Schneider Medical Center sustained damage; established mobile medical facility
- St. Croix: Governor Juan Luis Hospital partially open despite damage; Charles Harwood Facility closed

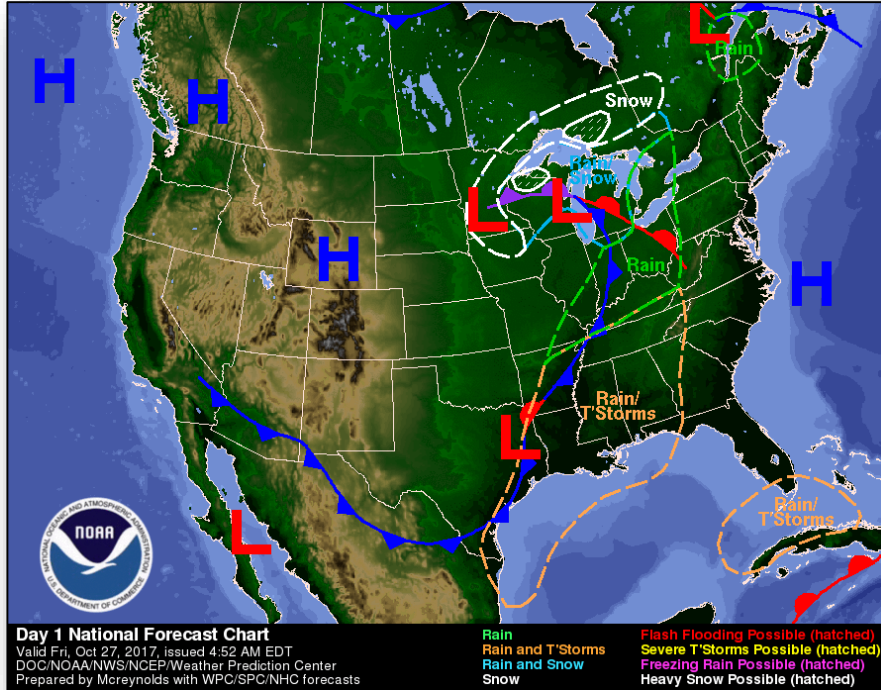
Water Restoration

- Boil Water Advisory remains in effect territory-wide

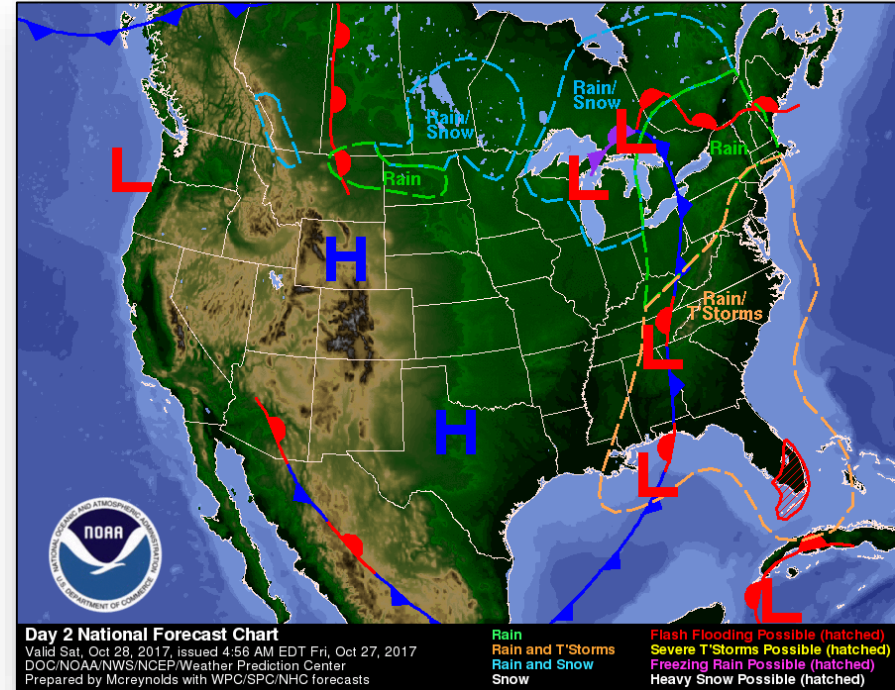

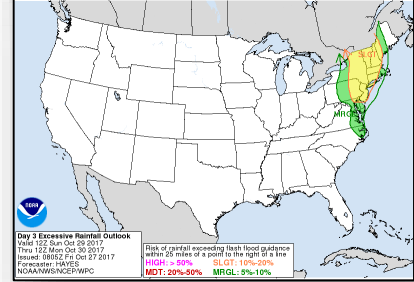
Precipitation Forecast – Excessive Rainfall

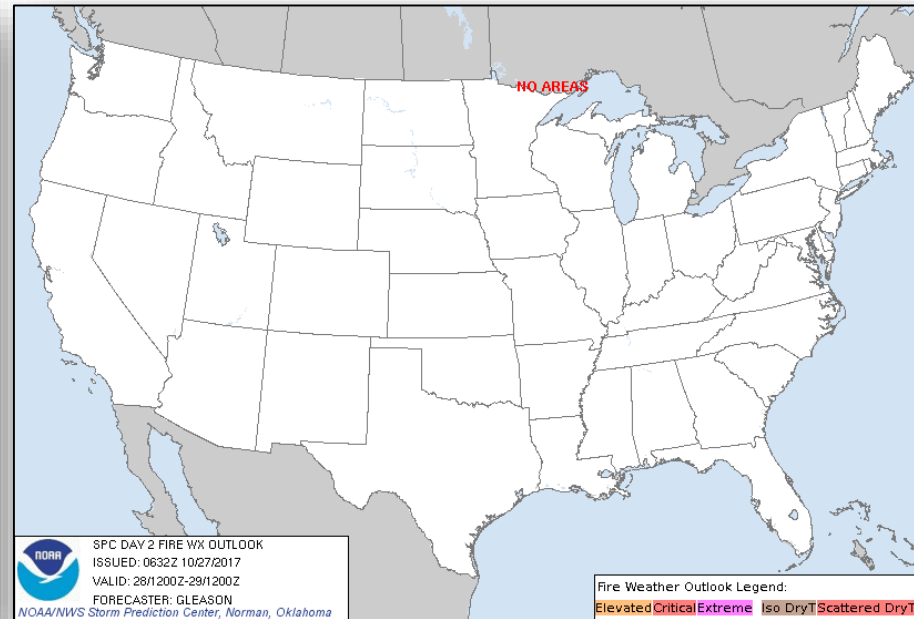
Severe Weather Outlook – Days 1-3
