Significant Events: Wildfires - southern California

Tropical Activity:

Western Pacific – No activity affecting U.S. interests

Significant Weather:

- Critical/Elevated Fire Weather conditions and Red Flag Warnings southern CA and Central Plains
- Heavy snow possible Southern Appalachians, Mid-Atlantic, Northeast, and lower Great Lakes
- Rain and thunderstorms possible FL
- Space Weather: Past 24 hours: none; next 24 hours: none

Wildfires – Southern California



Current Situation

Six active fires are burning in southern California, five of which have FMAGs. The Thomas Fire is the largest with over 143k acres burned. Critical to extreme fire weather conditions expected to persist through Sunday.

Impacts


- Shelters statewide: 12 (-1) open / 647 (+30) occupants (ARC Midnight Shelter Count as of 5:46 a.m. EST)
- Widespread mandatory evacuations remain in effect for over 200k
- One confirmed fatality reported as a result of the Thomas Fire

State/Local Response

- Governor declared a State of Emergency
- CA National Guard deployed
- CA EOC at Full Activation

FEMA Response

- Emergency Disaster Declaration approved for five counties on December 8, 2017
- Region IX RWC at Steady State; RRCC not activated
- Region IX IMAT-2 deployed to CA EOC in Sacramento, CA
- · Region IX LNO deployed to Southern Regional EOC in Los Alamitos, CA
- Defense Coordinating Element activated




Emergency Declaration Approved

- Emergency Declaration approved December 8, 2017
- For wildfires beginning on December 4, 2017, and continuing
- · Provides:
 - Emergency protective measures (Category B), limited to direct federal assistance, under the Public Assistance program at 75 percent federal funding for five counties
- FCO is Mark Armstrong










Precipitation Forecast









Forecast Snowfall










Hazards Outlook – Dec 11-15







