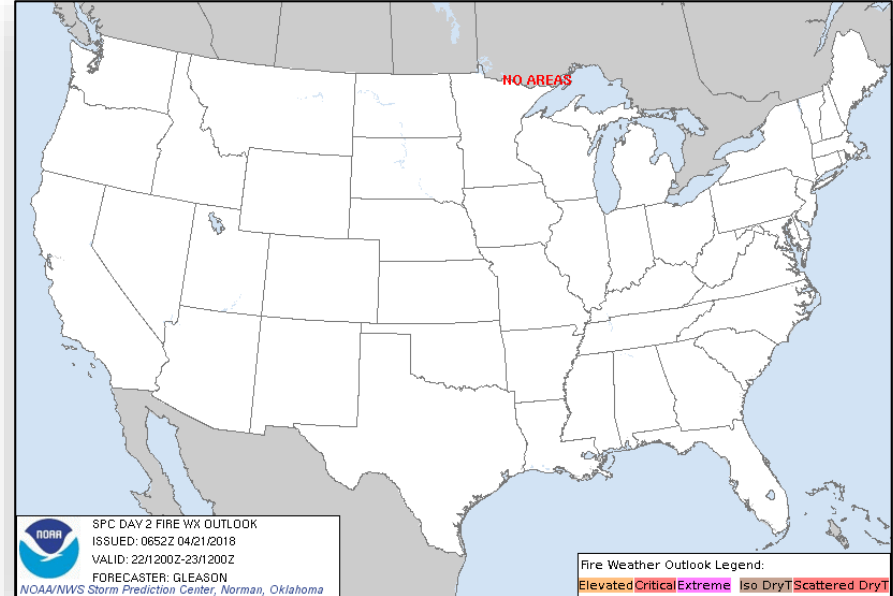
Fire Weather Outlook

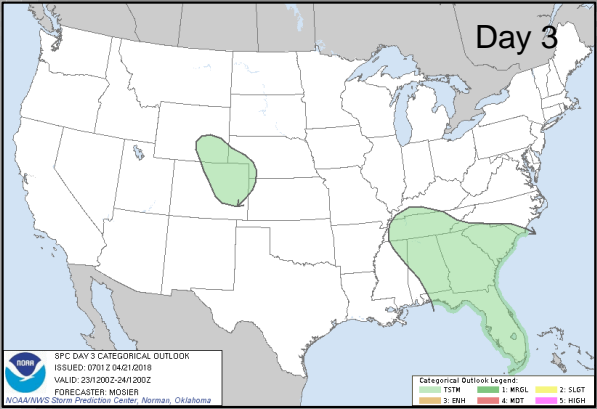
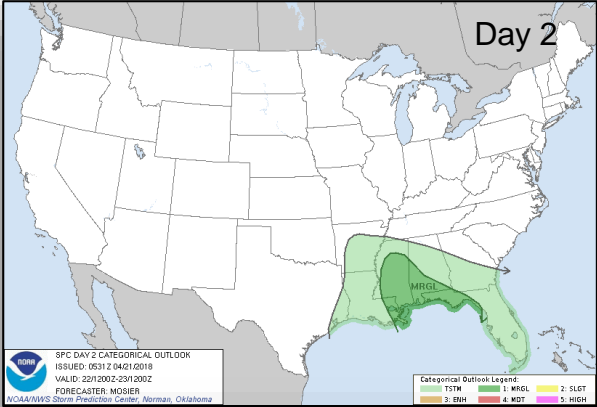
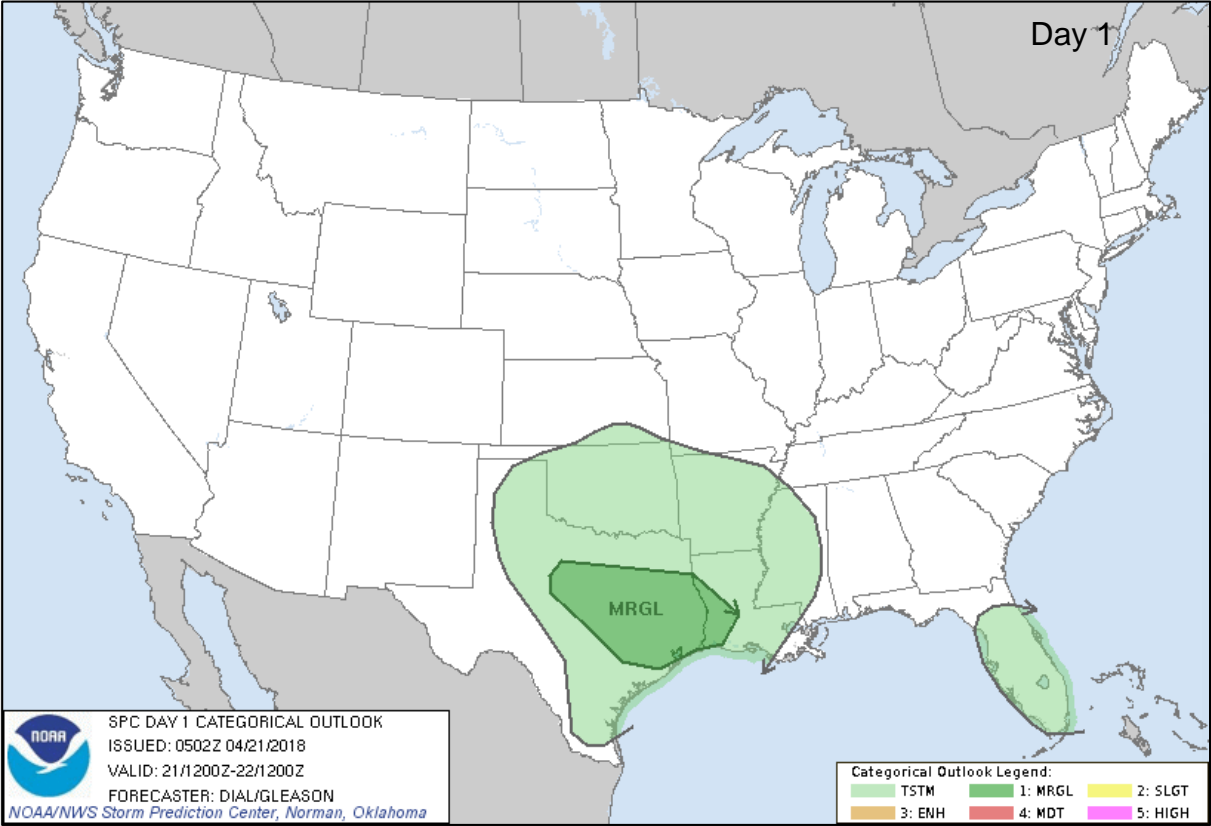

Severe Weather Outlook



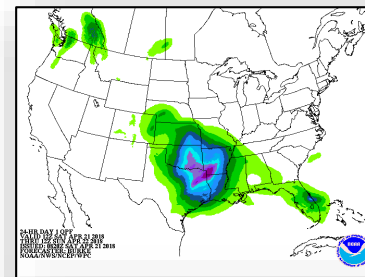
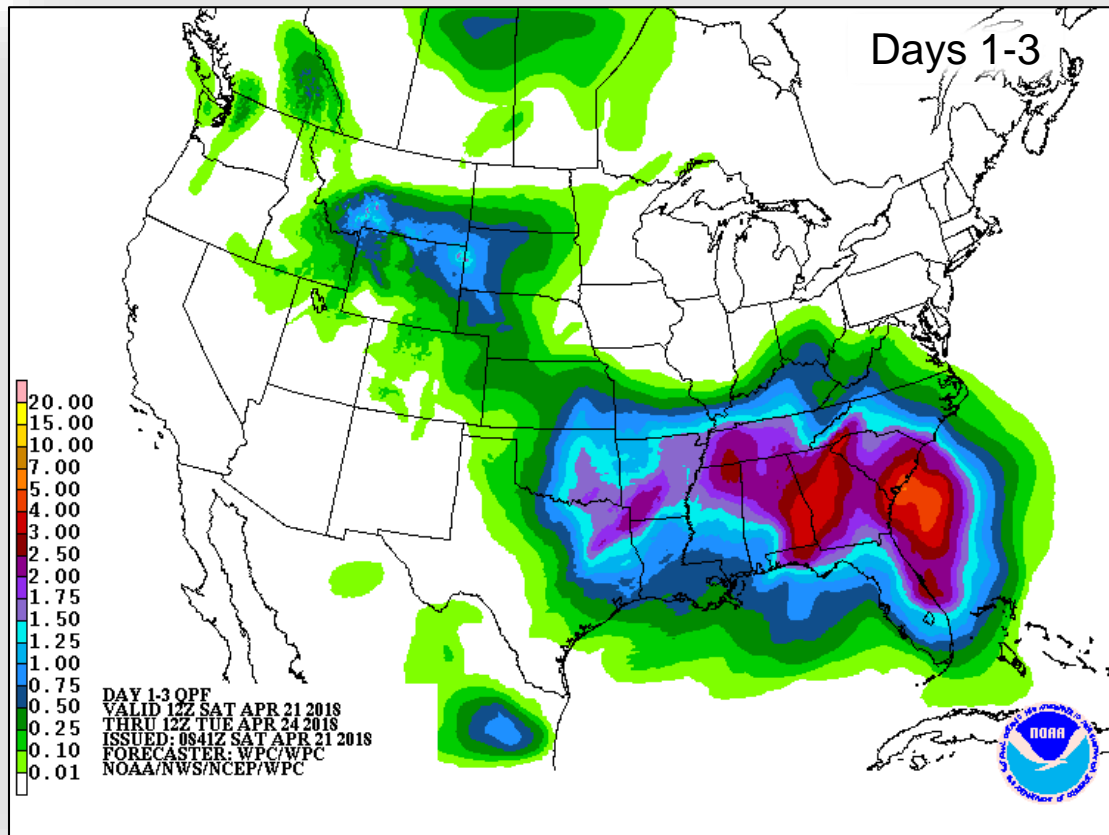

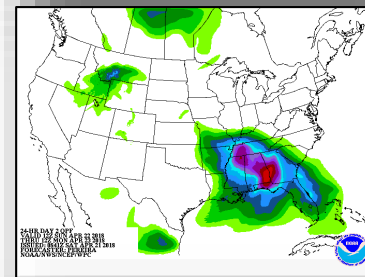
Precipitation Forecast



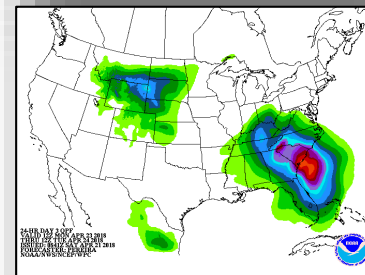
