
State Response

Current Situation


- Fire began August 11, 2018 and is threatening communities around the areas of Hot Springs, SD (pop. 3,500)





- Formation chance through 5 days: Low (20%)




Tropical Outlook – Central Pacific




Tropical Storm Hector (Advisory 52 as of 5:00 a.m. EDT)


- 245 miles SSW of Midway Island









Precipitation / Excessive Rainfall Forecast














Long Range Outlooks – August 18-22





6 - 10 Day Temperature Probability




6 - 10 Day Precipitation Probability



- FCO is David G. Samaniego






