# Significant Activity – Aug 31 – Sep 1



### Significant Events: None

#### **Tropical Activity:**

- Atlantic Tropical Storm Florence; Disturbance 1: Medium (40%)
- Eastern Pacific Hurricane Norman (CAT 2); Tropical Depression Seventeen-E; Disturbance 1: Low (20%)
- Central Pacific Hurricane Miriam (CAT 1)
- Western Pacific No activity affecting U.S. interests

#### **Significant Weather:**

Flash flooding possible – Central Plains to Great Lakes

- Major Disaster Declaration approved Havasupai Tribe
- Major Disaster Declaration request New Jersey

### Tropical Outlook – Atlantic

#### <u>Tropical Storm Florence</u> (Advisory #8A as of 8:00 a.m. EDT)


- Located 185 miles W of the southernmost Cabo Verde Islands
- Moving WNW at 14 mph
- · Maximum sustained winds 40 mph
- Gradual strengthening is forecast during the next several days
- Tropical-storm-force winds extend outward up to 35 miles
- No coastal watches or warnings in effect

#### Disturbance 1 (as of 8:00 a.m. EDT)

- Located from Hispaniola northward across Turks and Caicos Islands
- Forecast to spread WNW, enhancing rainfall across FL and northern Gulf of Mexico coast through middle of next week
- Strong upper level winds will likely prevent significant development during the next couple of days
- Conditions are expected to become a little more favorable for a low pressure area to form when it moves across the Gulf of Mexico during the early to middle part of next week
- Formation chance through 48 hours: Low (near 0%)
- Formation chance through 5 days: Medium (40%)








### Tropical Outlook – Eastern Pacific



#### Hurricane Norman (CAT 2) (Advisory #17 as of 5:00 a.m. EDT)

- Located 965 miles WSW of the southern tip of Baja California, Mexico
- Moving W at 8 mph
- On the forecast track, will approach the Central Pacific basin on Tuesday
- Maximum sustained winds 110 mph
- Gradual weakening is forecast to continue today
- Hurricane-force winds extend 30 miles
- Tropical-storm-force winds extend 105 miles
- · No coastal watches or warnings in effect



### Tropical Outlook – Eastern Pacific



#### <u>Tropical Depression Seventeen-E</u> (Advisory #2 as of 5:00 a.m. EDT)

- Located 445 miles SW of Manzanillo, Mexico
- Moving WNW at 8 mph
- Maximum sustained winds 35 mph
- Strengthening should begin by Sunday
- · Could become a tropical storm any time during the next couple of days

#### Disturbance 1 (as of 8:00 a.m. EDT)

- Area of low pressure expected to form well south of the southwestern coast of Mexico in a few days
- Some gradual development is possible through the middle of next week
- Formation chance through 48 hours: Low (near 0%)
- Formation chance through 5 days: Low (20%)






### Tropical Outlook – Central Pacific




#### Hurricane Miriam (CAT 1) (Advisory #25 as of 5:00 a.m. EDT)


- Located 905 miles E of Hilo, HI
- Moving N at 9 mph
- Maximum sustained winds 85 mph
- Rapid weakening will concur tonight through Sunday
- Forecast to become a post-tropical remnant low Monday
- Hurricane-force winds extend 25 miles
- Tropical-storm-force winds extend 110 miles
- No coastal watches or warnings in effect








### Precipitation / Excessive Rainfall Forecast







  - o Hazard Mitigation statewide








### **Declaration Approved**

- Provides:

### Disasters Happen. Prepare Now. Learn How.

#### Week 1: September 1-8 Make and Practice Your Plan

- Make an Emergency Plan today and practice it <a href="http://www.ready.gov/plan">http://www.ready.gov/plan</a>
- Make a fire escape plan and practice two ways out of every room. Have a home fire drill at least twice a year with everyone in the home.
- Download a group texting app so everyone can keep in touch before, during and after an emergency
- Learn your evacuation zone and have an evacuation plan
- Practice evacuating in the car with your animals so that they're more comfortable if you need to evacuate
- Sign up for local emergency alerts and warnings in your area by searching online
- Get the @fema app with weather alerts for up to 5 locations: https://www.fema.gov/mobile-app #NatlPrep
- Contact your water and power companies to get on a "priority reconnection service" list of power-dependent customers if you rely on electrical medical equipment
- Find out if laws in your state permit pharmacists to dispense a 30-day refill of medications in an emergency
