Current Situation:

Additional rainfall from northern Texas to southeast Kansas and Arkansas through this week will hasten ongoing major to record flooding. Major flood levels expected to continue across the Midwest and Great Lakes regions for weeks.

Lifeline Impacts:

Safety and Security

- Levee breaches reported in IA, MO, IL, LA, and AR:
 - LA: USACE has delayed the opening of the Morganza Control Structure to June 12
 - IL: 5 levees have overtopped and the Nutwood Levee has overtopped in 40 locations. No imminent life/safety issues and no impacts to critical infrastructure expected.

Food, Water & Sheltering:

- 27 (-1) shelters open with 467 (+69) occupants (ARC Shelter report June 5)
 - OK: 6 (-1) / 97 (-11); MO: 8 (+1) / 111 (+30); OH: 3 / 109 (+14); AR: 10 / 150 (+36); IL: All shelters closed
 - Mandatory and voluntary evacuations remain in effect in IL, OK, KS, MO, AR, and OH

Health & Medical

- OH: 1 fatality and 7 injuries
- OK: 6 fatalities and numerous injuries
- KS: 3 fatalities; 44 injuries
- MO: 9 fatalities; 20 injuries
- AR: 1 fatality

Transportation

- Roads:
 - Numerous roads remain closed; alternate routes available
- Waterways:
 - USCG closed portions of the Mississippi, Arkansas and Illinois Rivers
- Rail:
 - Amtrak, Union Pacific and BNSF services suspended in some impacted areas. Freight cargo is being rerouted.

Hazardous Materials

- AR: wastewater treatment plants remain an issue in flooded areas. EPA, DEQ, and National Guard are monitoring and sampling; hazardous materials relocation and sandbagging operations are ongoing.

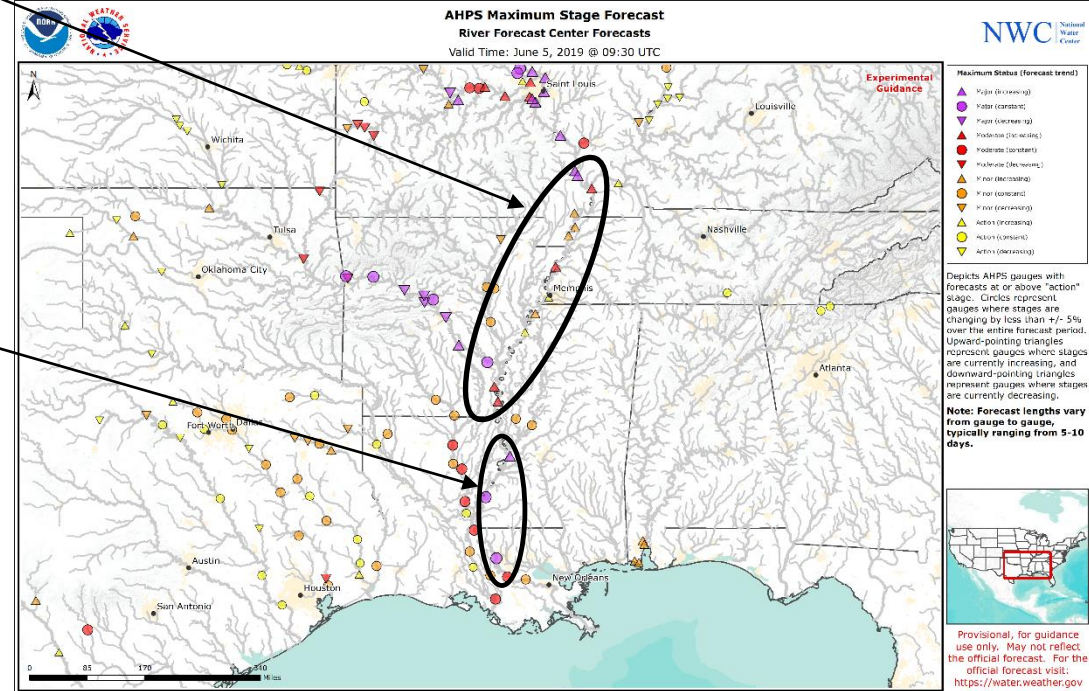

Lower Mississippi River Flooding

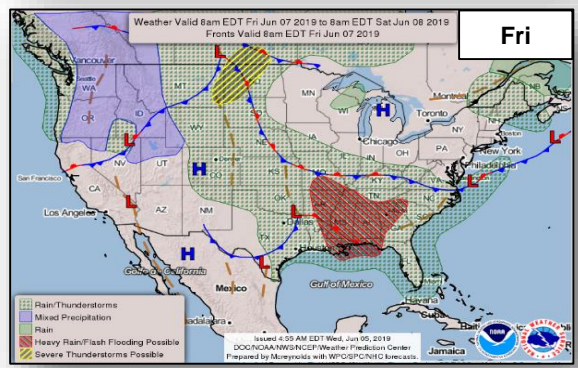
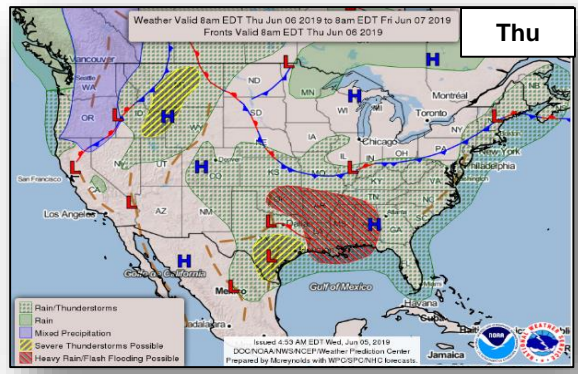
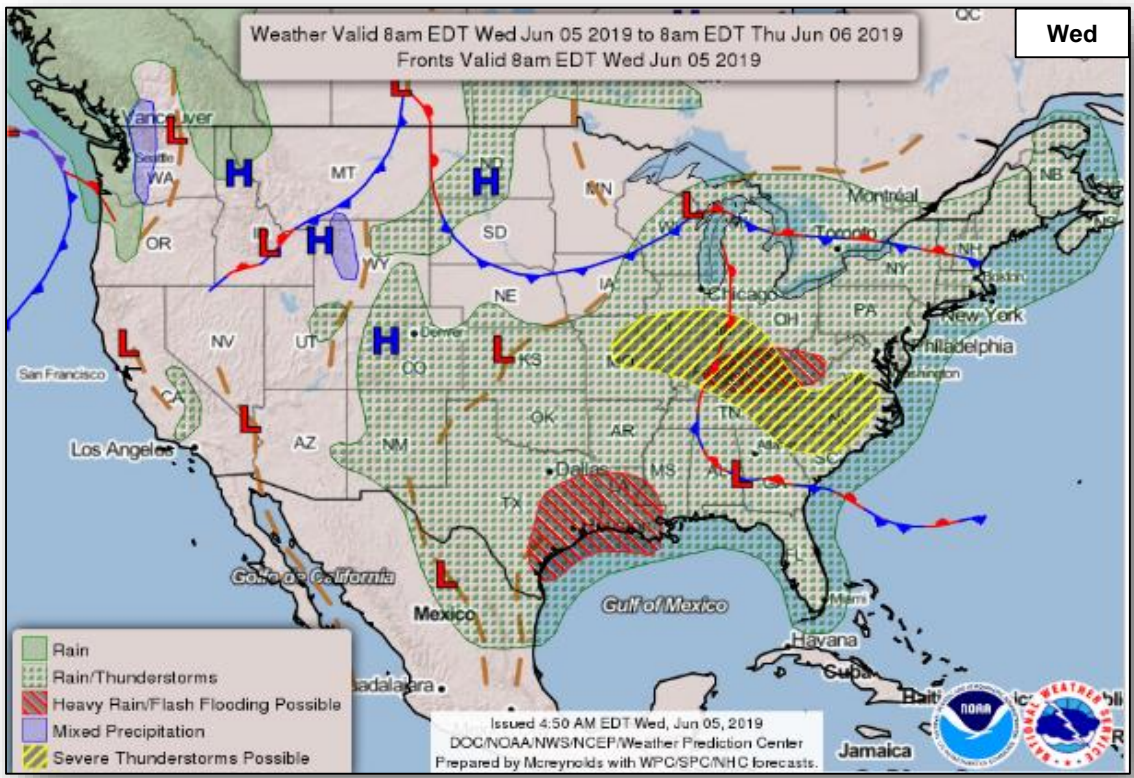

- The Lower Mississippi River continues to rise from Cape Girardeau, MO downstream to Greenville, MS. Additional rises of 1-2 feet are currently forecast.
- Major to Record** flooding continues along the **Arkansas River** and the peak is expected to reach Mississippi River within a week.
- Major** flooding is occurring at Natchez, MS and Vicksburg, MS. Impacts are primarily to agriculture. Navigation impacts continue at Baton Rouge, LA.
- Heavy rain forecast into next week may cause additional rises on area tributaries and keep main stem river elevated and even allow for additional rises.
- Elevated levels will continue through June and well into July.



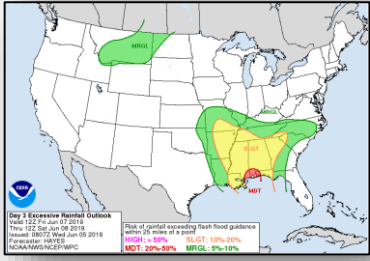
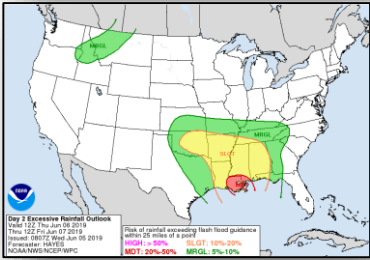
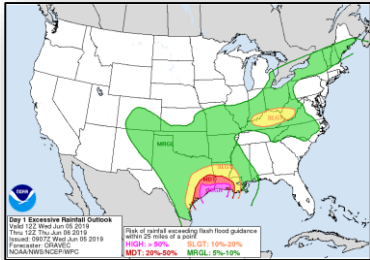
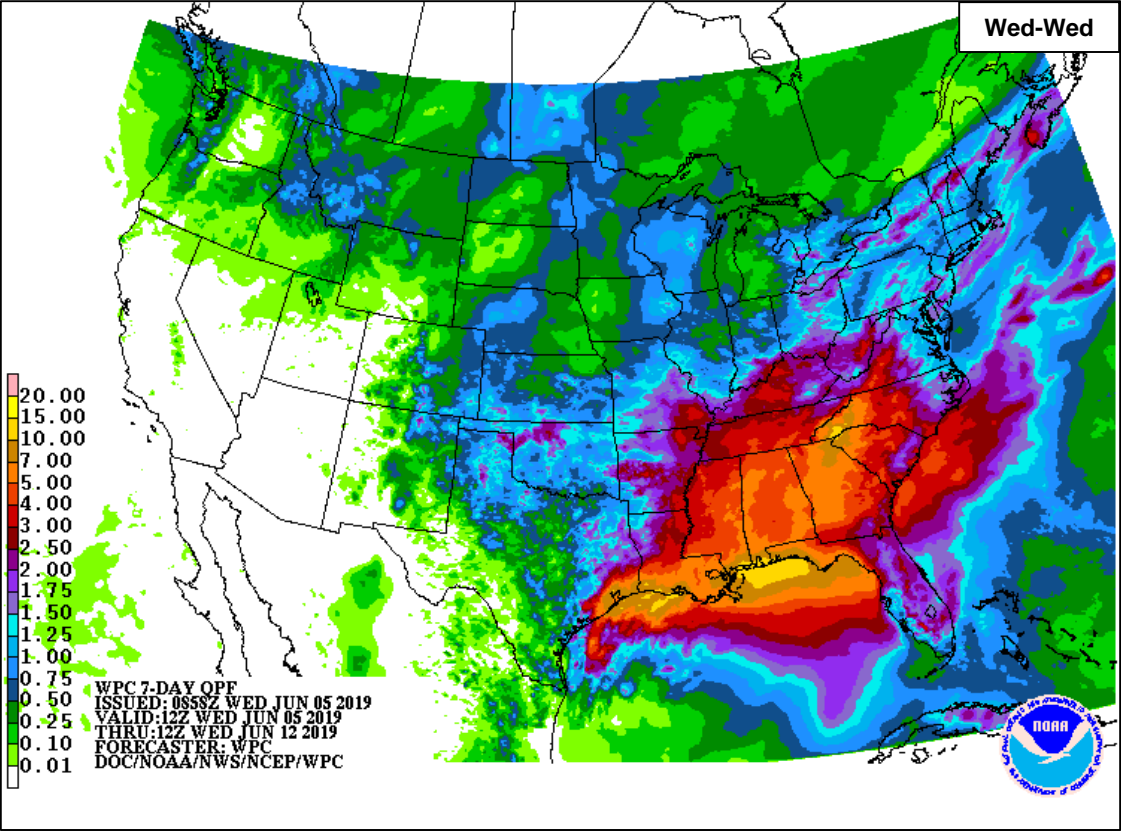
National Weather Forecast



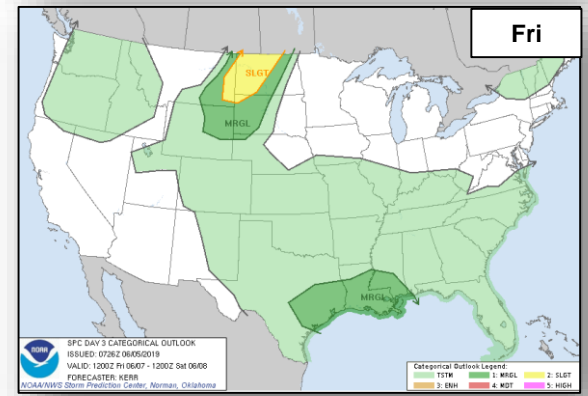
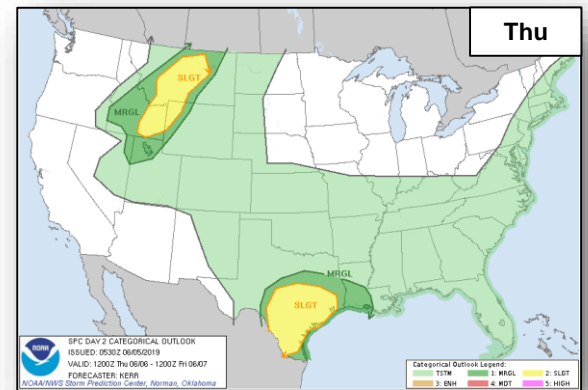
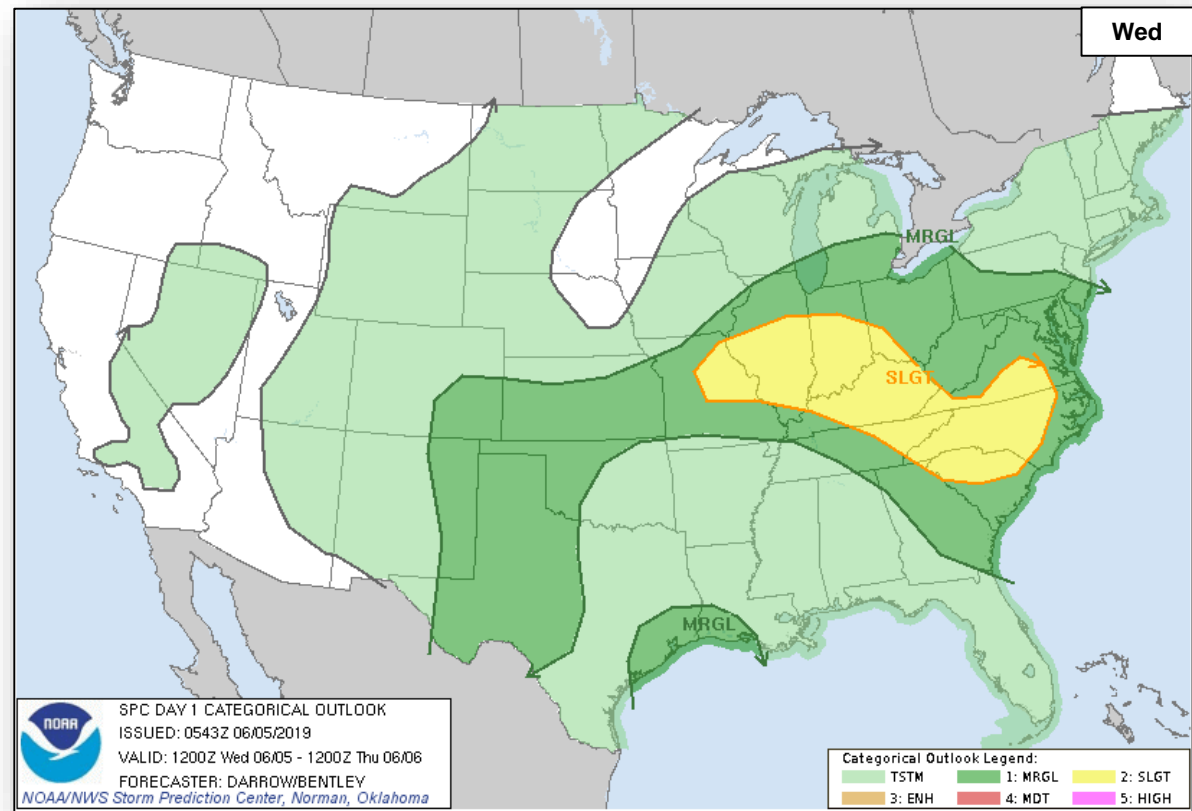
Precipitation Forecast

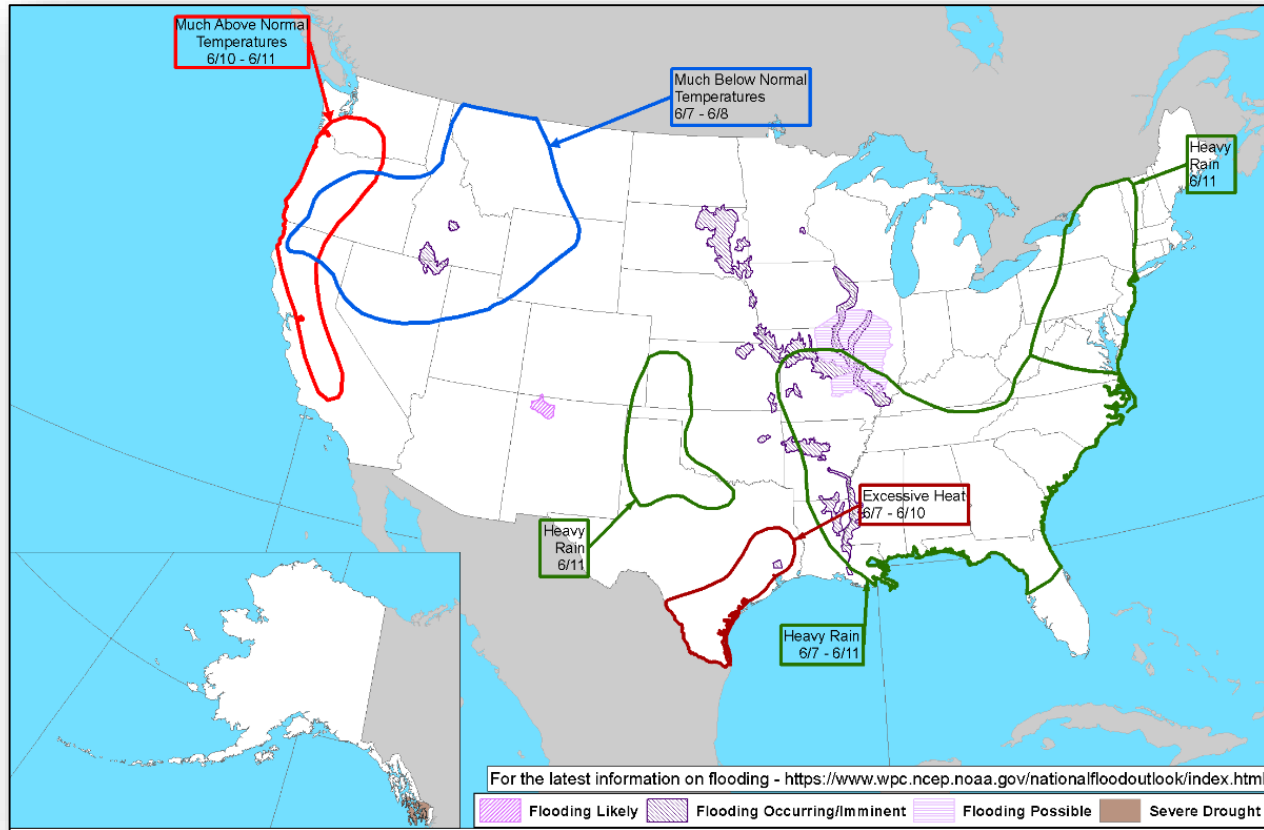
Severe Weather Outlook
