


## FORECAST 3-Day Rainfall Forecast Through Early Thursday, July 18, 2019

# Tropical Depression Barry – Gulf Coast

**Situation:** Barry is expected to produce additional rain accumulations of 3-6 inches across portions of the Lower Mississippi Valley with isolated maximum amounts of 10 inches across eastern AR, western TN, southeast MO, and northwest MS. Additional rainfall amounts of 3-5 inches with isolated storm totals of 10-15 inches are expected across south-central LA. This additional rainfall will lead to dangerous, life-threatening flooding.

## Lifeline Impacts:

### Safety and Security:

- LA: Several southern LA evacuation orders lifted, including Lafourche and Terrebonne parishes
- LA: USCG conducted search and rescues of 13 people; Jefferson Parish sended 10 high water vehicles to Lafayette Parish
- No overtopping of federal levees in New Orleans, Mississippi River or tributaries; USACE providing assistance for locally managed levees south of New Orleans

### Food, Water, and Sheltering:

- LA: 3 (-18) shelters open / 112 (-128) occupants; MS: 2 (-1) shelter open with 16 (-19) occupants; (*ESF-6 Shelter Count as of 6:20 am EDT*)
- ARC and Southern Baptists to provide 35k meals/day from July 18-26
- Airbnb activated Open Homes Program for displaced residents and relief workers

### Health and Medical:

- Minimal hospitals reporting disrupted operations
- 4 HHS Region 6 Regional Incident Support Teams (RIST) members deployed to FEMA Region VI
- TX: 2 DMATs (CA-9 and PA-1), with 2 DMAT Caches, deployed to Dallas Ft. Worth Staging Area

## Energy\*:

- LA: 51.2k (peak 181k) customers without power
- MS: 1k (peak 8k) customers without power statewide
- TX: 1.6k (peak 16k) customers without power statewide
- Pre-staged utilities crews, equipment, and materials in impacted areas. Some utilities releasing crews to support other areas
- Minimal outages of retail gas stations in LA and MS; no disruption to supply chain
- Oil and gas production temporarily capped; no further production until evacuation orders are lifted

## Transportation:

- Air: New Orleans airport open; no flight delays (*Flight Aware, FAA*)
- Sea: Some LA ports have re-opened, including New Orleans
- LA: Greyhound bus services in and out of New Orleans have resumed
- Rail: New Orleans Flood Protection Authority will re-open flood gates on July 15 which will allow limited rail traffic
- Mississippi River reopened with some flood control measures in place (*GOHSEP*)

(\*As of 5:45 p.m. EDT). Customer outage data is provided by the Department of Energy's EAGLE-I system. Comprehensive National coverage of all electrical service providers is not available.)

# Tropical Depression Barry – Response

## State / Local:

- LA EOC: Full Activation
  - Governor declared a State of Emergency
  - 3k National Guard activated including 88 high water vehicles with 2 person crews; approx. 1,900 vehicles available with full crews available
- TX EOC: Monitoring
  - Governor declared a State of Emergency
- MS EOC: Partial Activation
  - Governor declared a State of Emergency
- TN EOC: Monitoring




## FEMA / Federal:

- President approved Emergency Declaration FEMA-3416-EM-LA for 35 parishes (Category B)
- [FEMA Region IV: RWC returned to Steady State](#)
  - LNOs deployed to MS EOC and to Harrison County (MS) EOC
- FEMA Region VI: RWC is monitoring
  - RRCC: Level II (24/7)
  - LNOs deployed to New Orleans EOC and LA EOC; LNO [demobilized from TX EOC](#)
  - IMAT-1 deployed to LA EOC
  - [IMAT-2 demobilized from TX EOC](#)
- FEMA HQ: NWC is monitoring
  - Response Operations Cell (ROC) activated (day shift)
  - ISB personnel deployed to Roseland & Sherwood Forest, LA
  - MERS deployed to Baton Rouge, LA; [demobilization plan pending](#)
- US&R Blue IST, 1 Type 3 Task Force, and one Mission Ready Package/water rescue (TX TF-1) to Denham Springs, LA
- HHS IMT to Baton Rouge, LA; 2 DMATs to Dallas-Ft Worth, TX








# Severe Weather Outlook


# Tropical Outlook – Five Day



### Disturbance 1 (as of 5:00 a.m. EDT)

- Several hundred miles south of Mexico
- Formation chance through 48 hours: Low (near 0%)
- Formation chance through 5 days: Low (30%)
- No threat to the U.S.



## Atlantic

### Tropical Depression Barry (Advisory #20 as of 5:00 a.m. EDT)

- 80 miles WSW of Little Rock, AR
- Center will move across the northwestern portions of LA today, and over AR tonight and Monday
- Maximum sustained winds 25 mph; moving N at 9 mph


