There is a chance for thunderstorms across much of the area, mainly during the afternoon and evening.</p> <p>.DAYS TWO THROUGH SEVEN...Wednesday through Monday.</p> <p>There is a slight chance for thunderstorms across parts of the area early Wednesday. There is also a slight chance for thunderstorms late Sunday night into early Monday.</p> <p>An Excessive Heat Watch is in effect for northeast and central Missouri and west central and southwest Illinois from Wednesday afternoon through early Saturday. Afternoon and evening heat index values of 105 to around 110 are possible due to hot and humid conditions.</p>

<p>Missouri summers can bring a combination of high temperatures and high humidity, which can prove to be not only uncomfortable, but dangerous.</p> <p>Preparedness tips before severe heat</p> <ul style="list-style-type: none"> • Stay indoors as much as possible and limit exposure to the sun. • Stay on the lowest floor out of the sunshine if air conditioning is not available. • Consider spending the warmest part of the day in public buildings such as libraries, schools, movie theaters, shopping malls, and other community facilities. Circulating air can cool the body by increasing the evaporation rate of perspiration. Call 211 for the nearest location of a cooling center. • Use exhaust fans and dehumidifiers when needed. • Drink plenty of water. Individuals who have epilepsy or heart, kidney, or liver disease, are on fluid-restricted diets, or who have problems with fluid retention should consult a doctor before increasing liquid intake. • Dress in loose-fitting, lightweight, and light-colored clothes that cover as much skin as possible. • Protect your face and head by wearing a wide-brimmed hat. Wear sunscreen. • Check on family, friends, and neighbors who do not have air conditioning and who spend much of their time alone. • Never leave children or pets alone in closed vehicles. • Avoid strenuous work during the warmest part of the day; use the buddy system when working in extreme heat; and take frequent breaks.




