- Mile Post 97 Fire – OR
- North Hills Fire – MT

Tropical Activity:

- Atlantic: Disturbance 1 – Low (20%)
- Eastern Pacific:
 - Tropical Storm Erick
 - Tropical Storm Flossie
- Central Pacific: TS Erick expected to enter this basin on Tuesday
- Western Pacific: No activity affecting U.S. interests

Declaration Activity:

- 2 Amendments issued
- 2 FMAGs approved

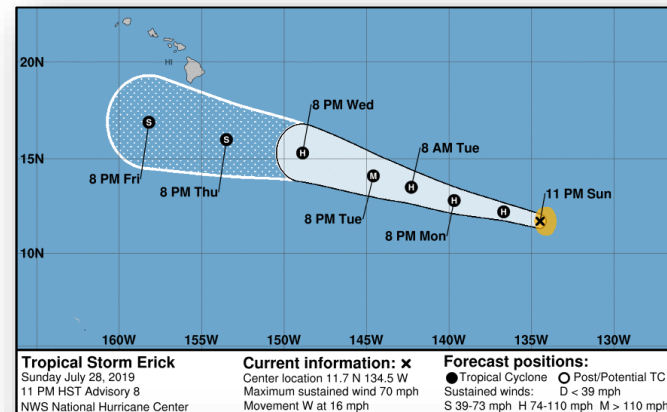

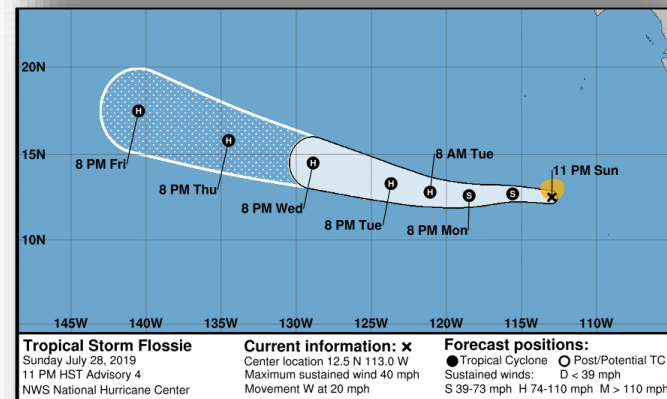
Tropical Storm Erick *(Advisory #8 as of 5:00 a.m. EDT)*

- 1,475 miles ESE of Hilo, Hawaii
- Moving W at 16 mph
- Maximum sustained winds 70 mph
- Forecast to become a hurricane very soon and a major hurricane by Tuesday
- Expected to move into the Central Pacific on Tuesday



Tropical Storm Flossie *(Advisory #4 as of 5:00 a.m. EDT)*

- 730 miles SW of Manzanillo, Mexico
- Moving WNW at 20 mph
- Maximum sustained winds 40 mph
- Expected to become a hurricane by Tuesday



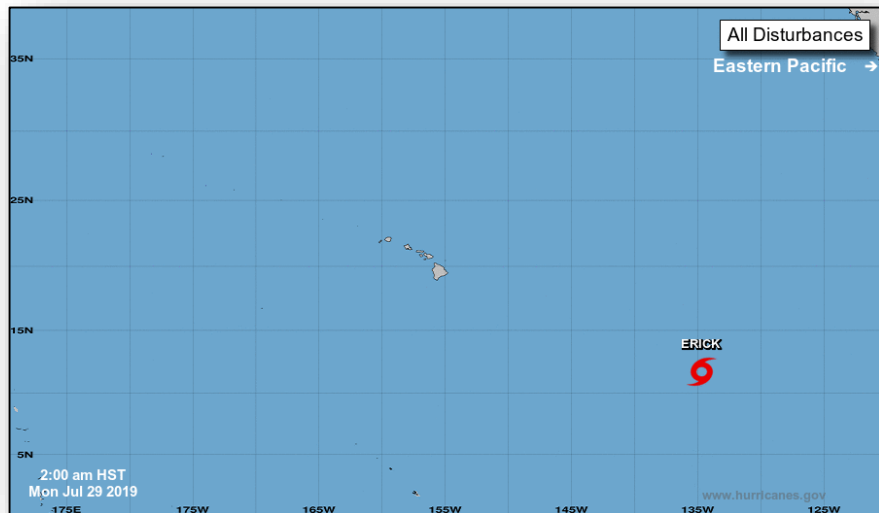

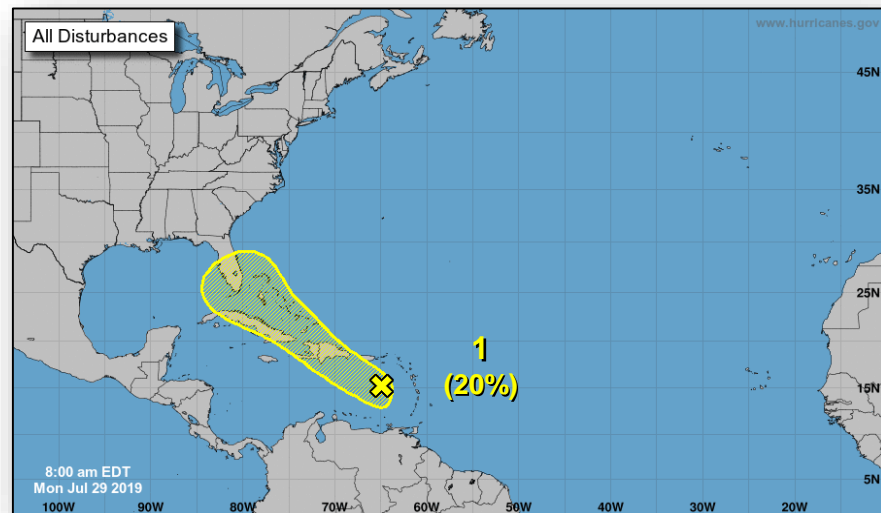

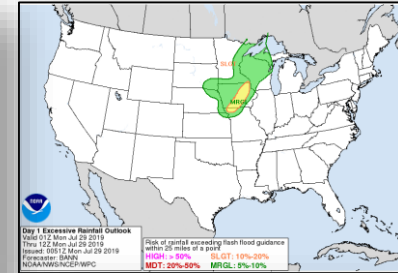

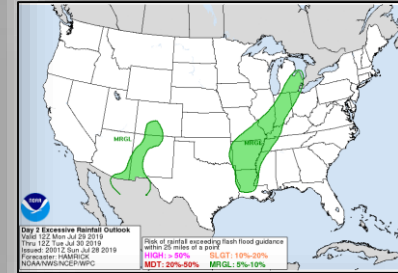
Precipitation Forecast



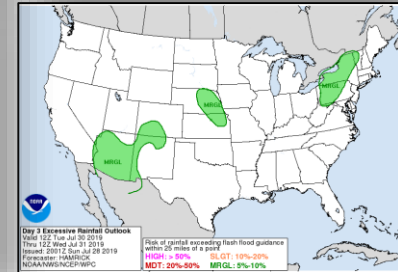

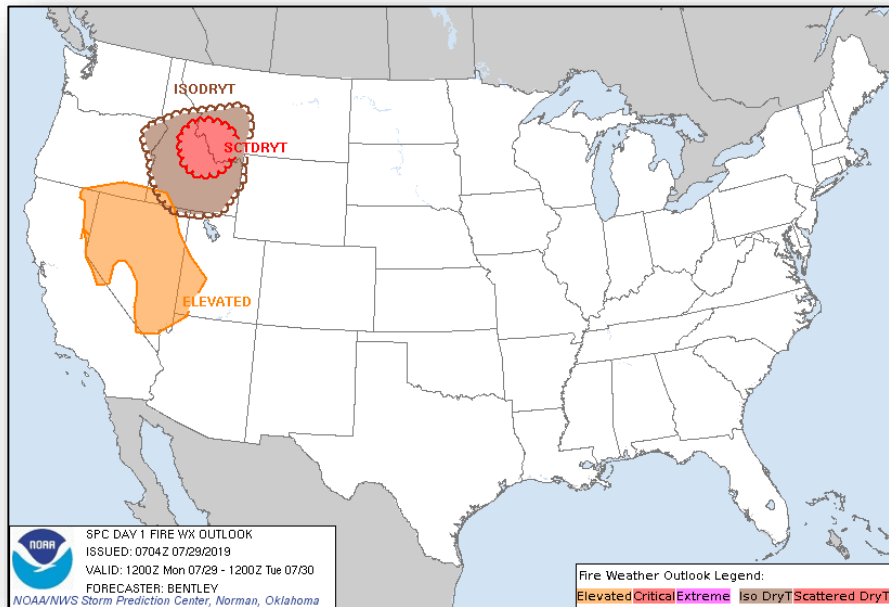

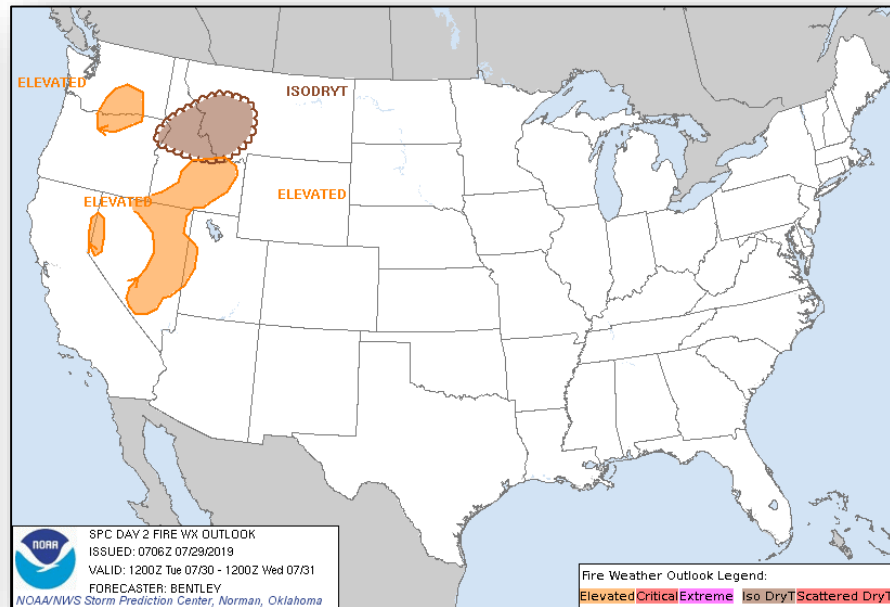

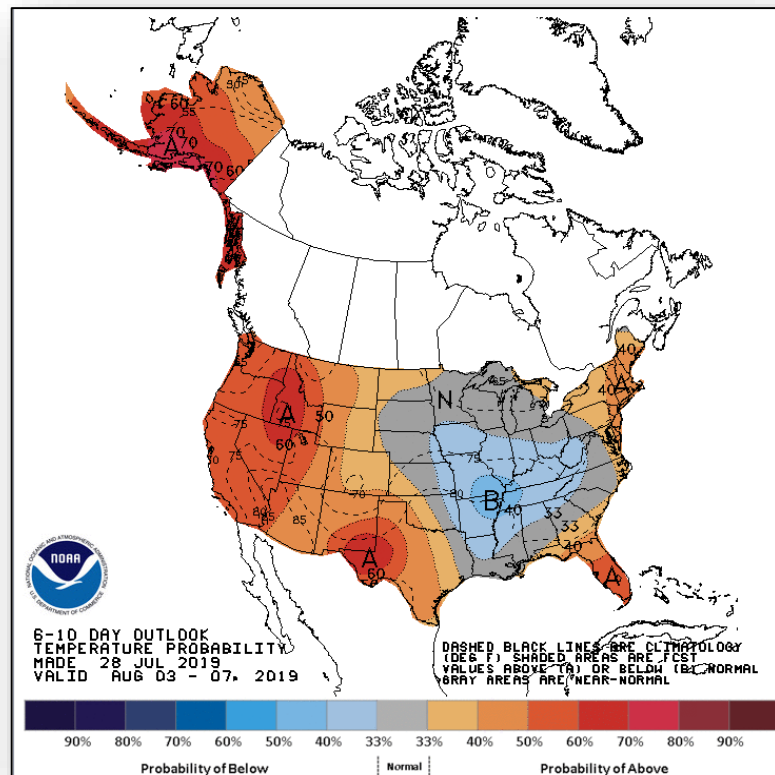

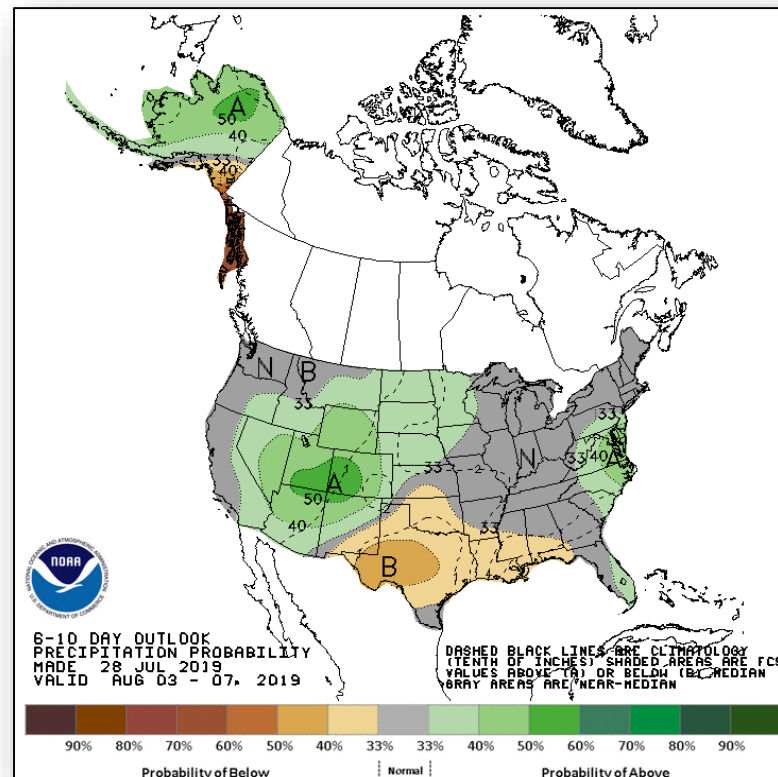
Long Range Outlooks – Aug 3-7

6-10 Day Temperature Probability



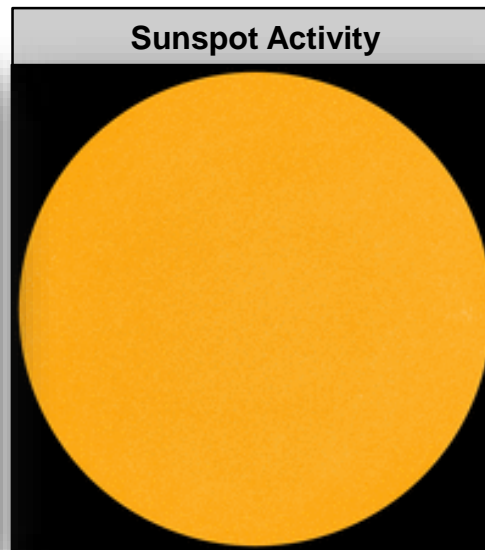
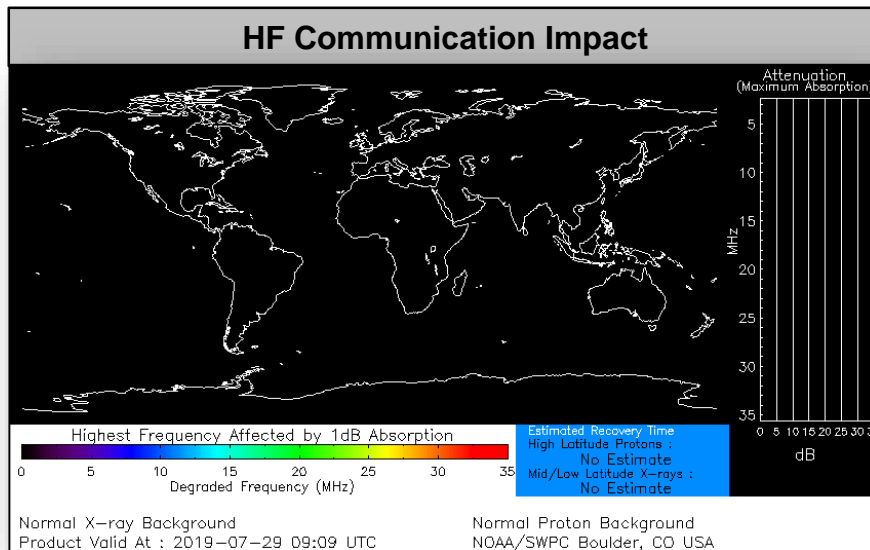
6-10 Day Precipitation Probability

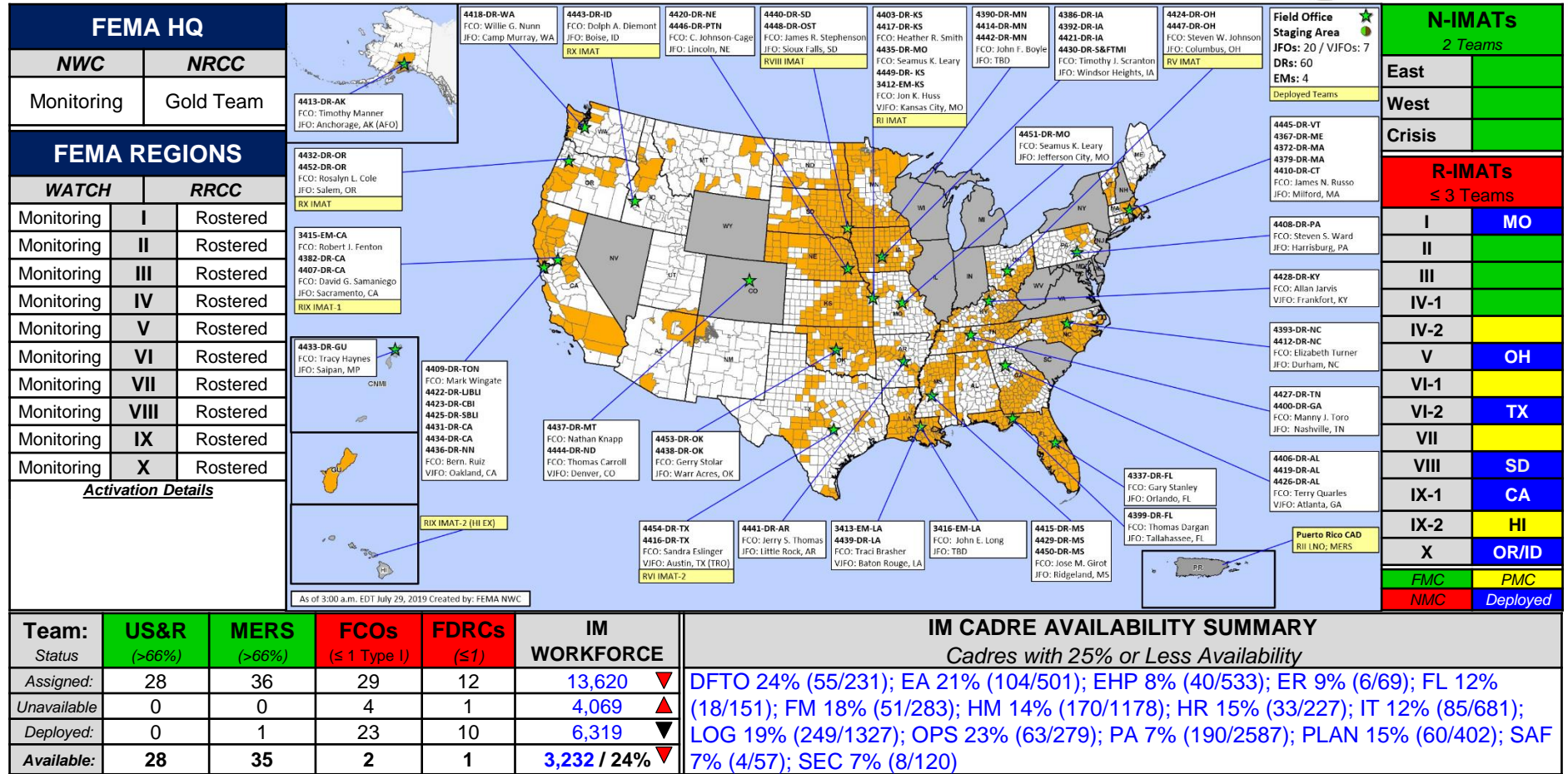
