- Mile Post 97 Fire – OR
- North Hills Fire – MT

Tropical Activity:

- Atlantic: Disturbance 1 – Low (10%); Disturbance 2 – Low (20%)
- Eastern Pacific:
 - Tropical Storm Flossie
 - Disturbance 1 – Low (20%)
- Central Pacific: Hurricane Erick (Cat 1)
- Western Pacific: No activity affecting U.S. interests


Tropical Outlook – Atlantic

- Located a few hundred miles S of the Cabo Verde Islands
- Formation chance through 48 hours: Low (near 0%)
- Formation chance through 5 days: Low (20%)




Tropical Outlook – Eastern Pacific


Tropical Storm Flossie (Advisory #8 as of 8:00 a.m. EDT)

- 965 miles SW of southern tip of Baja California, Mexico
- Moving W at 16 mph
- Maximum sustained winds 65 mph
- Expected to become a hurricane later today and a major hurricane Wednesday night

- Located a few hundred miles S of Acapulco
- Formation chance through 48 hours: Low (near 0%)
- Formation chance through 5 days: Low (20%)





Hurricane Erick (Cat 1) (Advisory #12 as of 5:00 a.m. EDT)




- 1,015 miles ESE of Hilo, Hawaii

National Weather Forecast



















