



## Tropical Outlook – Central Pacific




#### Tropical Storm Flossie (Advisory #24 as of 5:00 a.m. EDT)

- 840 miles E of Hilo, HI
- Moving WNW at 17 mph
- Maximum sustained winds 60 mph
- Tropical storm force winds extend 140 miles
- Expected to weaken through the weekend

### Tropical Storm Erick - FINAL (Advisory #28 as of 5:00 a.m. EDT)

- 300 miles SW of Honolulu, Hawaii
- Moving W at 14 mph
- Maximum sustained winds 40 mph
- Forecast to weaken to a post-tropical low today









## **Excessive Rainfall Outlook**








## Severe Weather Outlook




