National Current Operations & Monitoring



Significant Incidents or Threats:

- Extremely Critical Fire Weather CA
- Red Flag Warning CA, NV, AZ, UT, & CO
- Winter Storm Central and Northern Plains
- Severe Thunderstorms possible Southern Plains to the Middle Mississippi Valley

Tropical Activity:

- Atlantic: Disturbance 1: Low (20%); Disturbance 2: Low (near 0%)
- Eastern Pacific: Disturbance 1: High (80%)
- Central Pacific: No new tropical cyclones expected during the next five days
- Western Pacific: No activity affecting U.S. interests

Tropical Outlook – Atlantic




Disturbance 1 (as of 8:00 a.m. EDT)

- Located off northeast coast of U.S.
- Formation chance through 48 hours: Low (10%)
- Formation chance through 5 days: Low (20%)

Disturbance 2 (as of 8:00 a.m. EDT)

- Located off the Mid-Atlantic coast of the U.S.
- Formation chance through 48 hours: Low (near 0%)
- Formation chance through 5 days: Low (near 0%)




Tropical Outlook – Eastern Pacific



Disturbance 1 (as of 8:00 a.m. EDT)

- Several hundred miles SW of the coast of Mexico
- Moving WNW at 5-10 mph
- Formation chance through 48 hours: Medium (40%)
- Formation chance through 5 days: High (80%)









Severe Weather Outlook











Precipitation Forecast








