Significant Incidents or Threats:

- COVID-19
- Tornadoes and Severe weather – Southeast to Mid Atlantic
- Severe thunderstorms and Flash Flooding possible – Lower Mississippi and Tennessee Valley
- Severe thunderstorms – Florida Panhandle to Eastern Seaboard

COVID-19 Update



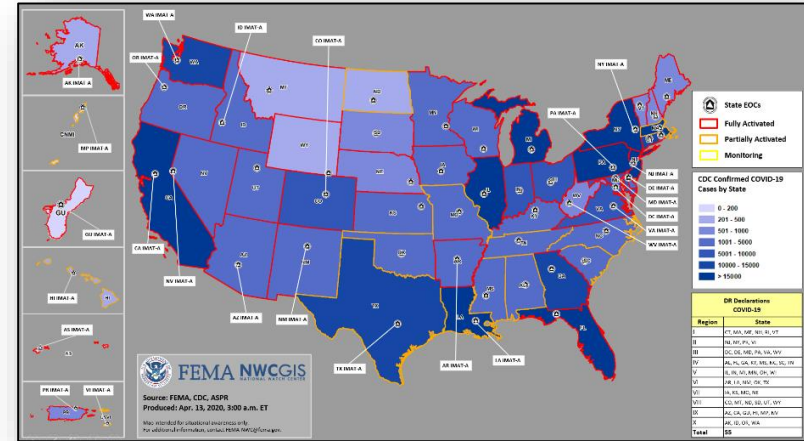
Situation: FEMA, HHS, and federal partners are working with state, local, tribe, and territorial governments to execute a whole-of-America response to the COVID-19 pandemic. The federal government is coordinating the deployment of PPE and ventilators from multiple sources including SNS, donations, and vendor procurements. These shipments are being sent nationwide with prioritization given to areas in greatest need.

State / Local Response:

- All State / Territory EOCs activated
- 42 states, D.C., 4 territories and 37 tribes issued shelter-in-place orders

FEMA / Federal Response: *(COVID-19 SLB, 5:00 p.m. ET, Apr 12)*

- NRCC: Level I in unified effort with HHS SOC; all RRCCs activated
- IMAT-A teams deployed to 26 states; LNOs deployed to 37 states, territories, & tribes
- 55 Major Disaster Declarations approved
- 325 Individual Medical Area personnel deployed; 251 currently supporting 7 of 11 NYC hospitals; 18 en route to Philadelphia hospitals; 20 onboarding at Javits; 35 en route to NYC hospitals; 1 restriction of movement (non-COVID)
- NYC: 4 Urban Augmentation Medical Task Forces / 340 personnel ISO JNYMS
- NJ: 1 UAMTF / 137 personnel deployed to ACS Edison, 1 deployed to Atlantic City
- MI: ACS TCF Convention Center in Detroit began initial operations; **25 patients seen**; 1 UAMTF with **75 personnel arrived Detroit**; **1 patient seen**
- NYC: 3,519 NG activated; 169 confirmed positive for COVID-19; 400 quarantined
- OH: Blood Center to work with hospitals in collecting plasma donations; anticipated testing of plasma transfusions for patients by end of April
- **95 public health labs using CDC assay (50 states plus DC, Guam PR, and USVI)**

Tornadoes and Severe Weather – Southeast



Situation: Severe thunderstorms moved from northeastern Texas to the Carolinas overnight. Significant, long-track tornadoes were confirmed through yesterday afternoon and evening. The Storm Prediction Center issued a Mesoscale Discussion indicating that a EF4-EF5 tornado likely occurred. Tornado Watches remain in effect from Florida to southern Virginia.

Lifeline Impacts:

Safety & Security

- Search and rescue teams are en route to impacted areas

Food, Water & Sheltering

- 2 shelters open; 10 occupants (MS)
- Preliminary reports indicate approximately 57 homes (MS) impacted
- Downed trees and power lines (extent unknown)

Health & Medical

- MS EOC reports 11 confirmed fatalities, with numerous injuries (*FEMA Region IV*)

Energy

- Power Outages (*EAGLE-I, as of 7:15 a.m. ET*)
 - Total of 1.1 million customers without power throughout the impacted area: 60K; LA: 29K; AR: 133K; MS: 72K; AL: 126K; GA: 147K; TN: 27K; KY: 71K; NC: 214K; WV: 55K

Communication

- Noxubee County, MS 911 system has been disabled

Transportation

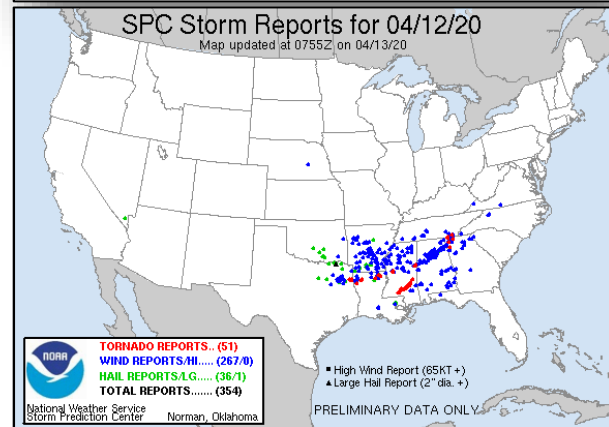
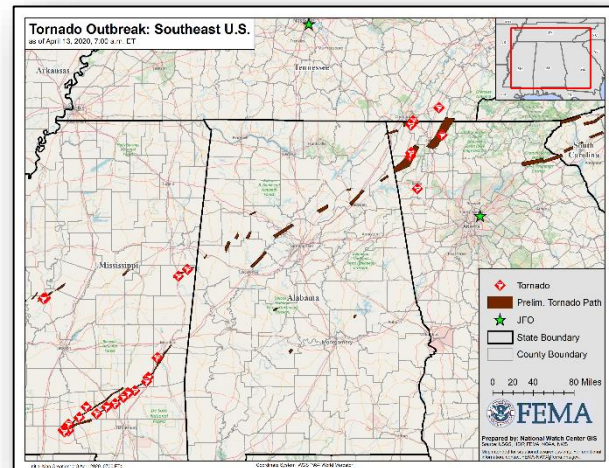
- Numerous road closures due to downed trees and debris; awaiting damage assessments

State/Local Response:

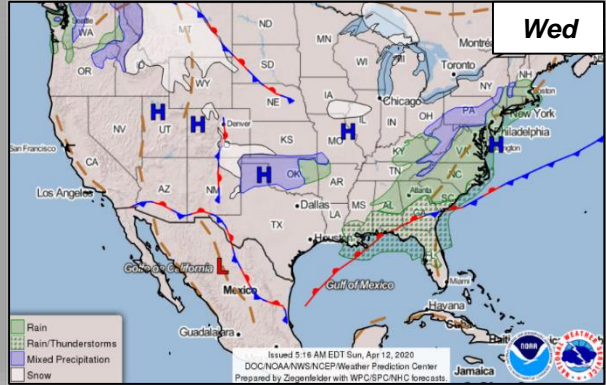
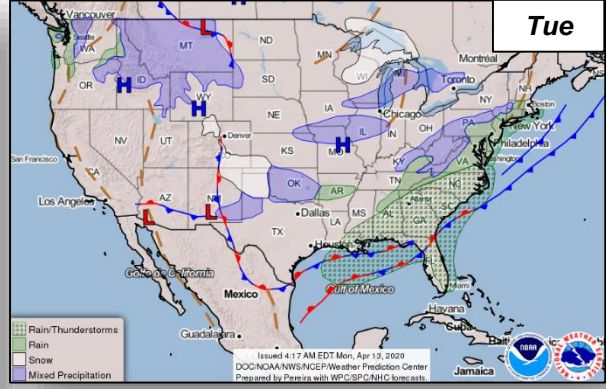
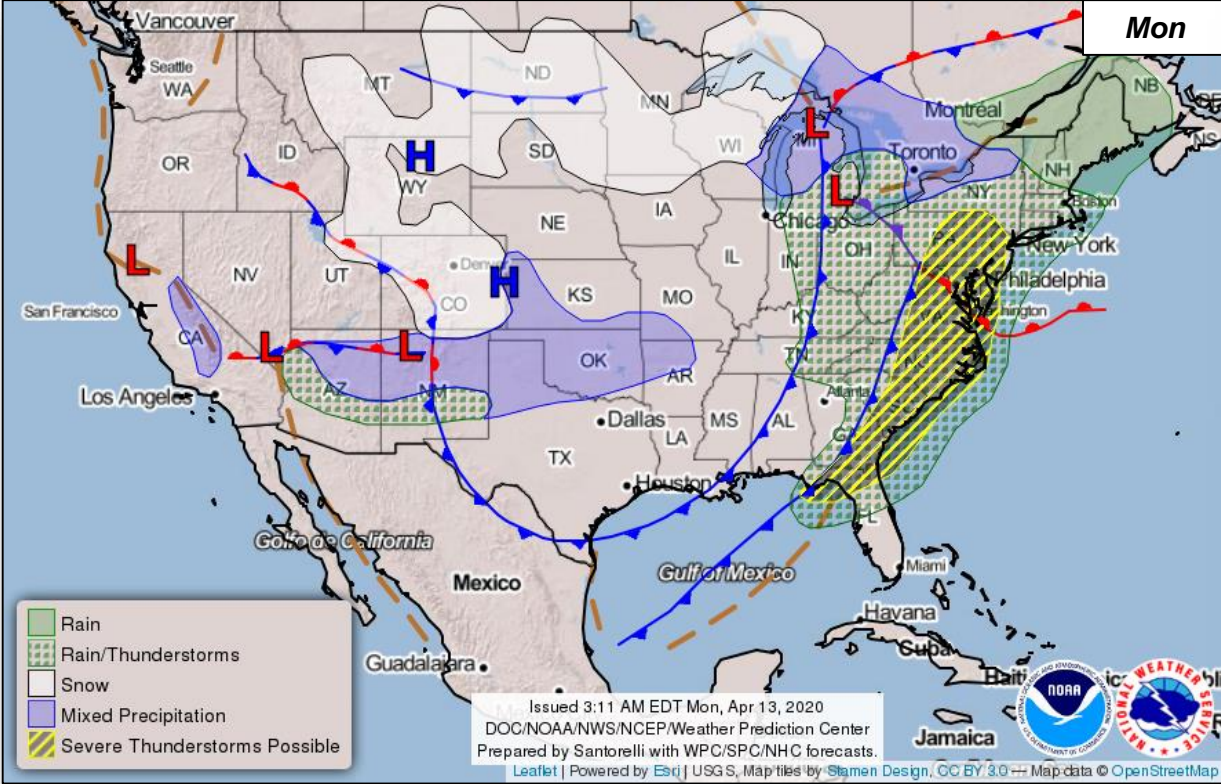
- Damage assessments continue throughout the impacted region

- NWC and Region's IV and VI RWC's continue to monitor



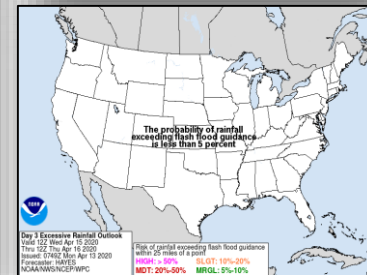
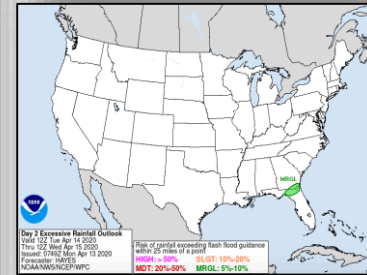
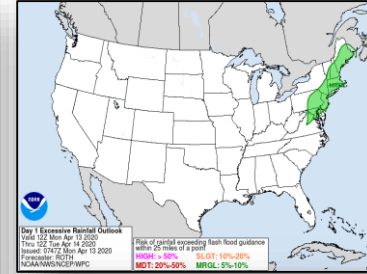
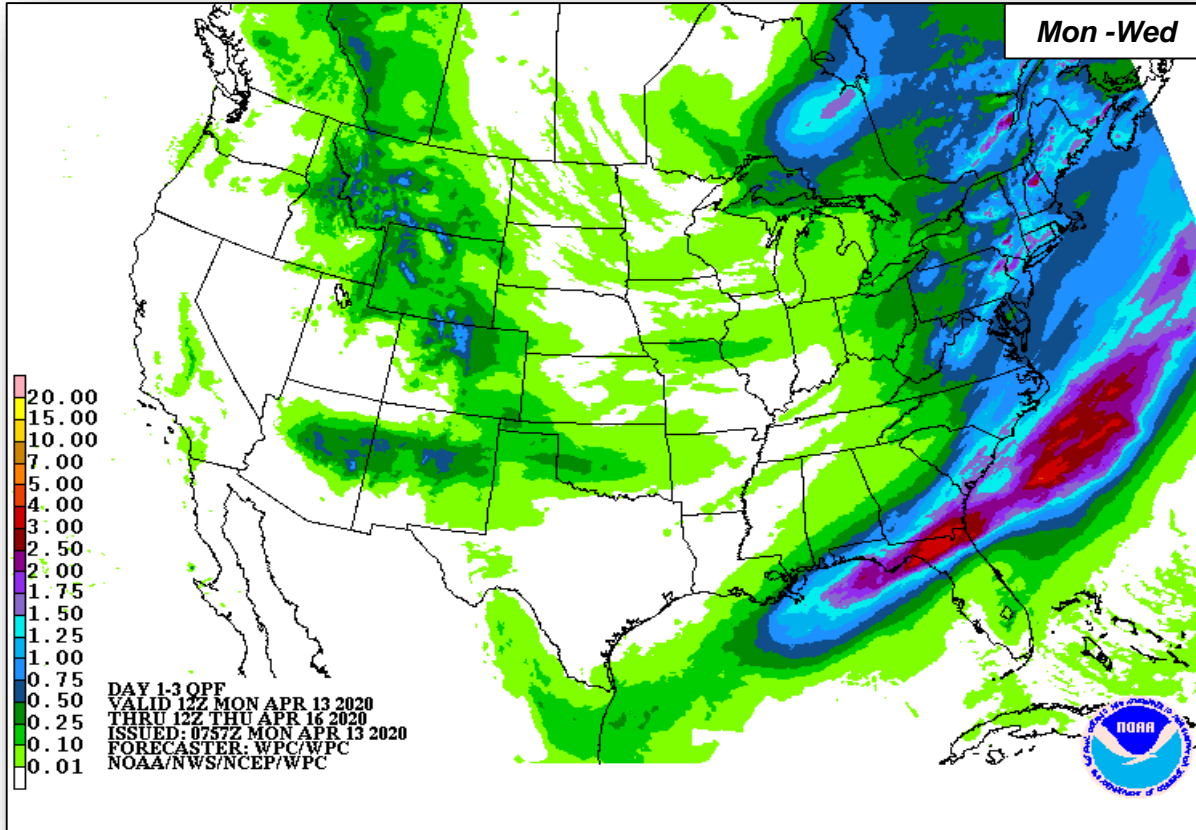
National Weather Forecast



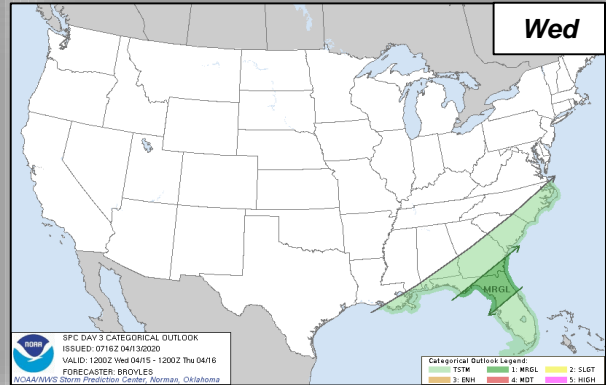
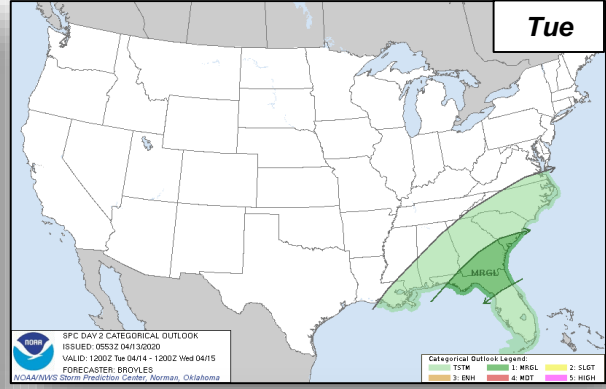
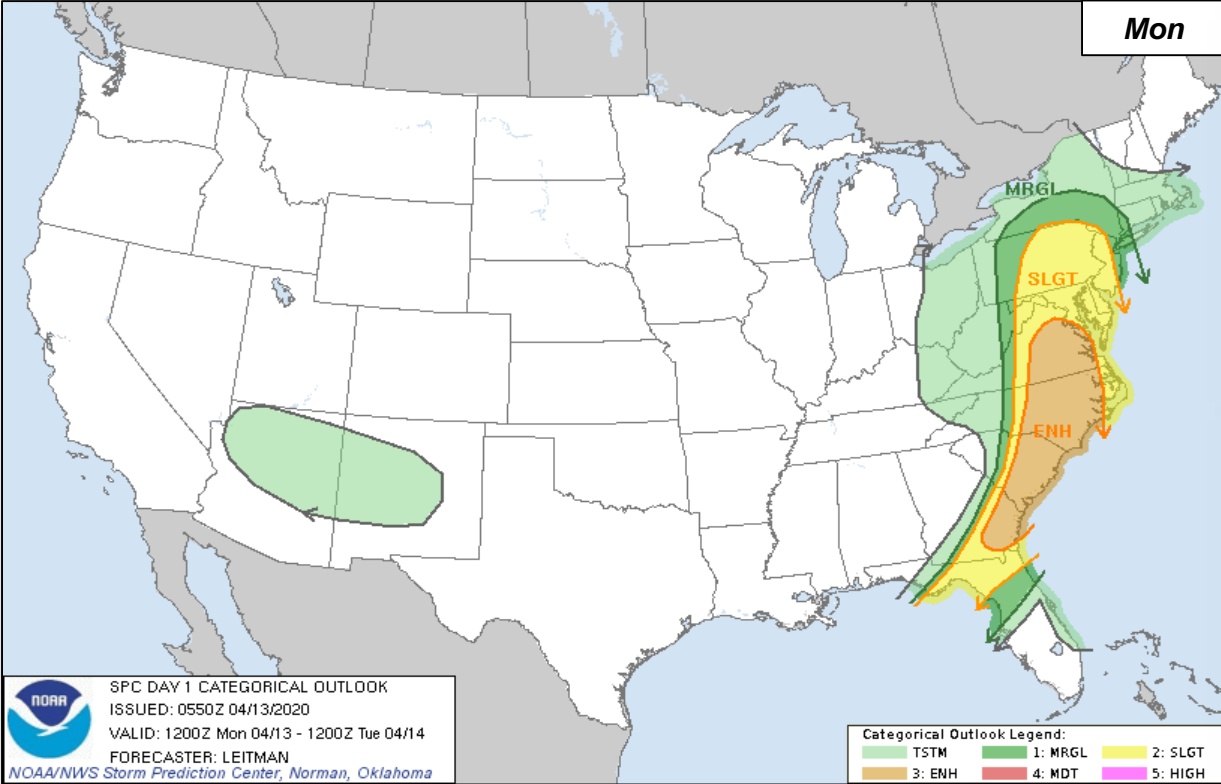
Precipitation & Excessive Rainfall

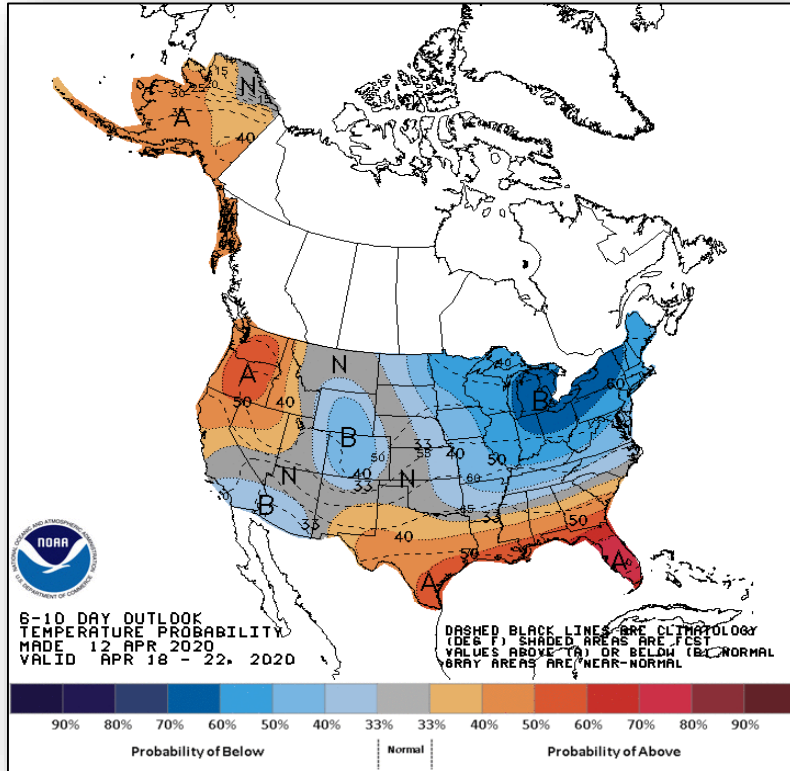
Severe Weather Outlook



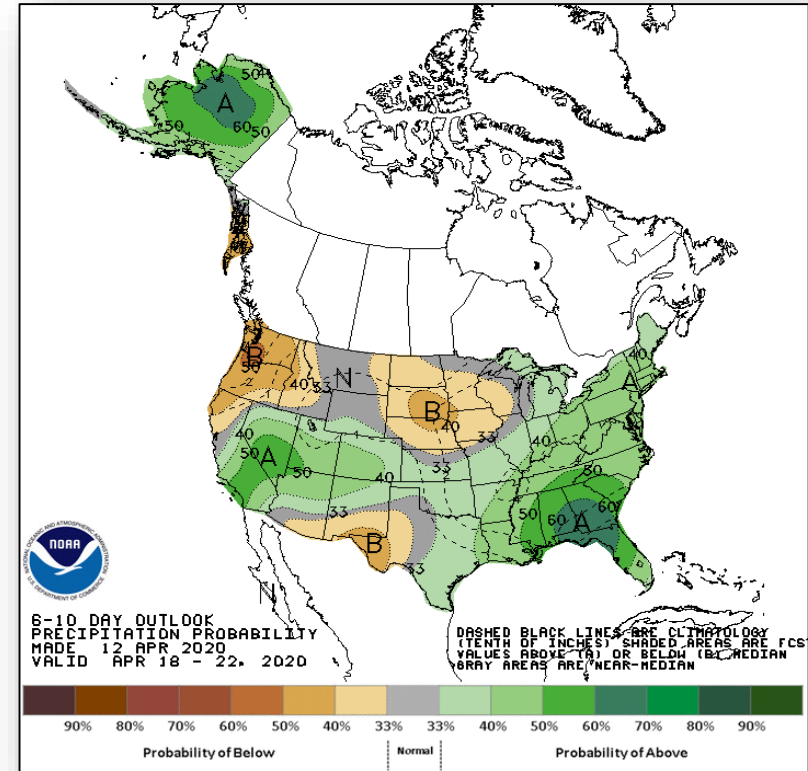
Long Range Outlooks – Apr 18-22

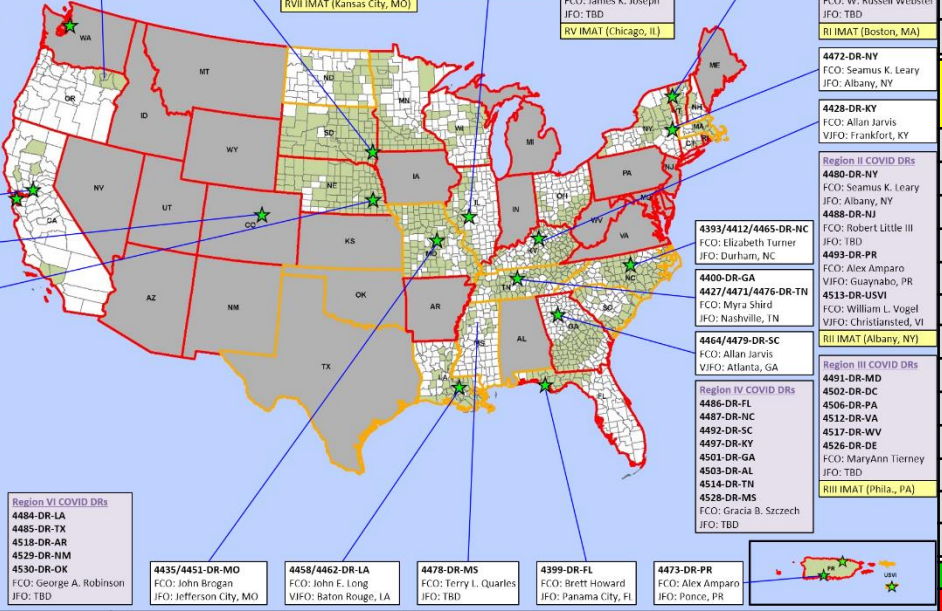
