National Current Operations and Monitoring **FEMA**

Significant Incidents or Threats:

- Earthquake (M7.5) AK
- Wildfires Western U.S.
- Freezing Rain possible MN & WI
- COVID-19

Tropical Activity:

- Atlantic:
 - Tropical Storm Epsilon
 - Disturbance 1: Low (10%)
- Eastern Pacific: No new tropical cyclones expected during the next five days
- Central Pacific: No new tropical cyclones expected during the next five days
- Western Pacific: No activity affecting U.S. interests

Declaration Activity:

Request: Major Disaster – Washington

Earthquake – Sand Point, AK (Final)



<u>Situation:</u> At 4:54 p.m. ET, Oct 19, a magnitude 7.5 earthquake with an MMI of VII occurred 55 miles SE of Sand Point, AK (pop. 1,064) at a depth of 25 miles. A Tsunami Warning was issued for South Alaska and the Alaska Peninsula; later downgraded to an Advisory, with additional advisories issued for the state of Hawaii


- Green PAGER Alert issued indicating a low likelihood of fatalities and damage
- 57 aftershocks ranging from M1.9 to M5.9
- Tsunami waves of 2.5ft were observed at Chignik Bay, Alaska. Additional tsunami waves reported near Hilo and Kahulu, HI
- Tsunami Advisories for Alaska and Hawaii were cancelled as of 1:04 a.m. ET, Oct 20
- There are no reported impacts for either state.

State/Local Preparations and Response:

- AK EOC is at Monitoring (COVID-19)
- HI EOC at Partial Activation (COVID-19)

FEMA/Federal Preparations and Response:

- Region X RRCC is activated to Level III (COVID-19)
- Bothell MOC, FEMA Region IX, and FEMA NWC continue to monitor
- No request for FEMA assistance



Tropical Storm Epsilon (Advisory #5 as of 5:00 a.m. ET)


- 765 miles SE of Bermuda

- Conditions not conducive for development
- Formation chance through 48 hours: Low (10%)
- Formation chance through 5 days: Low (10%)


National Weather Forecast




