Federal Funding for Additional COVID-19 Support

- As of Feb. 22, FEMA has obligated \$63.2 billion for the COVID-19 response with a balance remaining in the Disaster Relief Fund of more than \$12.5 billion. These funds will support continued response to the pandemic including expanded vaccination efforts as well as personal protective equipment, alternative care sites and durable medical equipment.
- Over \$3.8 billion has been obligated for expenses to support community vaccination centers at 100% federal cost share to states, tribes, territories, and Washington, D.C
 - As of Feb. 11, obligations for COVID-19 support include:
 - Funeral Expenses: \$1.9 billion has been set aside
 - Lost Wages: \$41.6 billion for those who were unemployed due to COVID-19 through Dec. 27, 2020.
 - National Guard: \$3.5 billion
 - PPE including medical supplies and pharmaceuticals: \$5.7 billion
 - Public Assistance Emergency Protective Measures (Non-PPE): \$6.8 billion
 - Temporary Medical Facilities including medical personnel, mortuary and ambulance services: over \$2.2 billion
- All 50 states, five territories, the Seminole Tribe of Florida, the Navajo Nation and Washington D.C., have been approved for major disaster declaration assistance due to COVID-19.
- FEMA is working directly with **91 tribes** as a result of COVID declarations. Tribal governments may choose to be a subrecipient or recipient under a state receiving FEMA assistance, or seek their own Presidential declaration through FEMA. Of the 91 tribal recipients, two tribes, the Seminole Tribe of Florida and the Navajo Nation, received their own major disaster declaration.

Personal Protective Equipment and Ventilators

- As of Feb. 19, FEMA, HHS and the private sector coordinated delivery of or are currently shipping: over 518.7 million N95 masks, over 2.1 billion surgical and procedural masks, over 117 million eye and face shields, over 936.8 million gowns and coveralls and over 46.5 billion gloves.
- As of Feb. 19, the federal government has approximately 151.492 total ventilators available in the Strategic National Stockpile.

Testing

- As of **Feb. 21,** CDC, state, local public health labs and other laboratories have tested more than **332.3** million samples.
 - As of Feb. 19, the FDA issued 331 individual emergency use authorizations for test kit manufacturers and laboratories, including 70 antibody tests and 14 antigen tests.

- As of **Aug. 4**, **398,300** samples were collected at federally supported <u>Community-Based</u> <u>Testing Sites.</u>
- HHS has established a public-private partnership with pharmacy and retail companies to accelerate testing.
 - As of **Feb. 22,** Under the CBTS public-private partnership, there are currently **5,618** live sites in all 50 states and Washington, D.C. and Puerto Rico are conducting testing.
 - Over **9 million** samples were processed at public-private partnership testing sites.

Federal Personnel

- As of Feb. 21, 752 interagency vaccinators have deployed to several states and more about 1,000 have been identified and are awaiting assignment.
- To date, the president has approved National Guard requests for federal support for the use of National Guard personnel in a Title 32 duty status through **March 31, 2021.**
 - As of Feb 19, 27,805 National Guard troops have activated in T-32 duty status and 324 troops have activated in State Active Duty status to help with testing, vaccinations and other response efforts.
- As of Feb. 21, FEMA has 1,298 employees supporting the COVID-19 response and (+69) FEMA Incident Management staff and 319 Incident Support staff deployed for COVID-19 vaccination support.
- As of Feb 16, 8,442 CDC personnel are supporting the outbreak response.
- As of **Feb. 16**, HHS has **269** personnel supporting the COVID-19 response.

Emergency Alerts

As of Feb. 22, 131 agencies across 31 states, the District of Columbia, three tribes and one U.S. territory have used FEMA's Integrated Public Alert and Warning System (IPAWS) to send a total of 564 alerts containing information on COVID-19 to cell phones and other wireless devices via the Wireless Emergency Alert system, and 103 alerts to radios/televisions via Emergency Alert System.
