Severe Weather and Tornadoes - Central U.S.

<u>Current Situation:</u> Severe weather impacted the central U.S. overnight; preliminary reports of 26 tornadoes, 118 wind, and 20 hail reports across 7 states (AR, MO, IL, TN, KY, IN and TX). Tornado touchdowns in Defiance MO; Monette and Truman, AR; city of Edwardsville and Coles and Moultrie counties, IL; Samburg, TN, and Mayfield, KY. At least 17 counties in KY were impacted by tornadic activity and debris fields.

Lifeline Impacts:

Safety and Security:

- Damage to nursing homes and some emergency response facilities have been reported in AR and TN
- Factory and distribution center workers have been reported trapped in KY and IL
- Debris blocking local fire departments and police stations is hampering search and rescue operations locally across KY


Health & Medical:

 Unconfirmed fluctuating numbers of fatalities and injuries reported across multiple states (KY, MO, AR, TN) and suspected entrapments at some facilities

Energy:

- Power outages: AR 24.7k (-1.8k) customers (1.7%) without power statewide; KY 92.7k (+29.7k) (4.4%); TN 133.7k (+80k) (5.4%); IN 56k (2%); minimal power outages in IL and MO (DOE Eagle-I as of 8:30 a.m. ET) Transportation:
- Debris on some transportation routes hindering response efforts across impacted areas (Governor's Request)
 Communications:
- No reports of widespread communications outages, although there are some local outages. Verizon is reporting some impacts. No reported loss of 911 services in the impacted area. CISA continues to monitor and will provide updates to the NWC as available.





State / Local Response:


- AR EOC at Full Activation (Severe weather and COVID-19)
- MO, II & TN EOC at Partial Activation (COVID-19)
- KY EOC at Partial Activation (severe weather); Governor declared a state of emergency; activated the National Guard and requested an Emergency Declaration and IMAT support



Severe Weather Outlook






Tornado Outlook



Situation

- The fire began on Dec 10 and is burning on private land in and around the city of Electra, TX (population 2,750)
- Threatening 150 homes, 300 buildings, infrastructure, utilities, and equipment in the area
- 500 acres burned; 0% contained
- Voluntary evacuations in effect for 300 people

- TX EOC at Partial Activation (COVID-19)
- Region VI RWC and NWC continue to monitor
- FMAG approved Dec 10


