FEMA Hosts Webinars on its Updated Public Assistance Program and Policy Guide

FEMA is hosting four webinars to inform partners on updates to Version 5 of the Public Assistance Program and Policy Guide (PAPPG) and encourage participation in the 60-day public comment period that is now open through Aug. 19, 2024. The updated guide, which is based on feedback from states, Tribal Nations, territories and nonprofits, simplifies eligibility, streamlines processes, increases accessibility and supports resilience.

The public can view and submit comments during the 60-day public comment period through Aug. 19, 2024, via the <u>Federal Register</u> and on <u>FEMA.gov</u>. Each webinar is targeted to include Tribal Nations, state, local and territorial partners and private nonprofits, with options for those who prefer to receive information in Spanish.
