### Flooding - Ohio Valley

<u>Situation:</u> Minor to moderate winter weather impacts are expected across Kentucky and west Tennessee where the risk of moderate to isolated major river flooding is ongoing and forecast through the week. Dangerous wind chills continue extending into western Tennessee and Kentucky. Coordination of early recovery actions continues as response assets demobilize and lifelines continue to stabilize.

#### Lifelines:

Safety & Security: US&R IN-TF1 to demobilize on 2/20. (Region IV SLB, as of 5:30 p.m. ET, Feb 19)


- KY: Swiftwater rescue operations concluded (Region IV RWC Update, as of 1:25 p.m. ET, Feb 18)
- VA: Swiftwater rescue operations concluded. 150 rescues conducted (FEMA Region III SPOTREP, as of 5:00 a.m. ET. Feb 18)

Food, Hydration & Shelter: (ARC Shelter Report, as of 6:53 a.m. ET)

- KY: 16 (+1) shelters open / 416 (-8) occupants
- TN: 2 shelters open / 3 occupants
- WV: 5 shelters open / 42 (-38) occupants
- VA: no ARC shelters remain open

Health & Medical: (Region IV SLB, as of 6:00 p.m. ET, Feb 19)

- KY: 14 fatalities reported
- Evacuated facilities have reopened, and all patients formerly transported to alternate locations are now back in their home facilities (Region IV SLB, as of 5:46 p.m. ET, Feb 18)
- GA: 1 fatality reported (Region IV, as of 9:44 p.m. ET, Feb 17)
- WV: 3 fatalities reported (Region III, RWC as of 8:17 a.m. ET, Feb 19)



#### Water Systems:

KY: (Region IV SLB, as of 6:00 p.m. ET, Feb 19)

- 1 water treatment facility non-operational; 20 (-7) operating at reduced capacity
- 45.1k (9.2k) customers under a Boil Water Advisory (BWA) and 8.7k (-9.3k) are without water service
- 3 (+1) wastewater treatment facilities nonoperational; 32 operating at a limited capacity
- VA: Boil Water Advisories continue in 5 counties (Region III SPOTREP, as of 6:07 a.m. ET)

#### Transportation:

- KY: 217 (-78) road closures, particularly in eastern and southern Kentucky. No major thoroughfares are impassible. (Region IV SLB, as of 6:00 p.m. ET, Feb 19)
- WV: Several major and auxiliary roads impacted and impassible (wv 511, as of 6:45 a.m. ET)











## **Wind Chill Forecast**


