SIGNIFICANT INCIDENTS			
DATE	INCIDENT TYPE	SUMMARY	
12/5/2022	Public Intoxication	At about 2030 hours, rangers received a report of an intoxicated male at Yavapai Lodge. Rangers contacted a 48-year-old male resident of Grand Canyon, confirmed he was nonviolent and not in danger of self-harm, and gave him a courtesy transport to his residence.	
12/5/2022	Pet Violation	Around 2245 hours, rangers were requested for a report of a dog off leash in front of a neighbor's house. The dog was secured and a 39-year-old female resident of Grand Canyon was issued a verbal warning for Dog Off Leash.	
12/6/2022	Arrest – DUI, Child Endangerment	At approximately 1515 hours, rangers responded to a report of an erratic driver on South Entrance Road. The driver, a 36-year-old female from Peach Springs, AZ, made spontaneous statements that she was intoxicated. The vehicle contained five concerned occupants, including an infant. The subject was arrested with charges of Driving Under the Influence of Alcohol and Unsafe Operation. An investigation into child endangerment is ongoing.	
12/7/2022	Emotionally Disturbed Person	Coconino County Sheriff's Office (CCSO) contacted a 61-year-old male resident of Valle, AZ who threatened the use of firearms at a Grand Canyon hotel. Rangers provided overnight security at the hotel until CCSO transported the subject to Flagstaff for mental health assistance.	
12/8/2022	Agency Assist – Welfare Check	Around 1400 hours, Arizona Department of Public Safety (DPS) requested a ranger check on a distressed individual on Highway 64 east of Desert View. Rangers located the male, who denied medical attention and stated he was hitchhiking.	
12/10/2022	Arrest – DUI, Open Container, Traffic Violations	At approximately 2245 hours, rangers stopped a vehicle for traffic violations. A 27-year-old male resident of Grand Canyon was found to be impaired and arrested for Driving Under the Influence of Alcohol and Open Container.	
12/14/2022	Disorderly Conduct – Fighting	Around 0045 hours, rangers responded to a physical altercation near the Coconino Apartments. A 26-year-old male and a 31-year-old male, both residents of Grand Canyon, admitted to physically fighting and destroying property. The subjects were given citations for Disorderly Conduct – Fighting.	
12/14/2022	Disorderly Conduct – Offensive Condition	At about 0945 hours, rangers received a report of a male concessions employee looking at a female in the restroom at Mather Campground. In an interview with rangers, the male subject admitted to looking at the female under the shower door. The subject was issued a citation for Disorderly Conduct — Creating an Offensive Condition. The female was provided with victim witness resources.	
12/15/2022	Arrest – DUI, Unsafe Operation	At approximately 2315 hours, rangers stopped a vehicle for multiple lane violations. Following investigation, the driver, a 33-year-old male resident of Grand Canyon, was arrested for Driving Under the Influence of Alcohol and Unsafe Operation.
