SIGNIFICANT INCIDENTS		
DATE	INCIDENT TYPE	SUMMARY
12/18/2022	Motor Vehicle Collision – PDO	Around 0045 hours, rangers responded to vehicle versus elk collision on Highway 64 near Desert View. No injuries occurred, but the vehicle was inoperable.
12/19/2022	Motor Vehicle Collision – PDO	At about 0200 hours, rangers responded to a single-vehicle accident on Center Road. The driver, a female resident of Valle, AZ went through a stop sign and off the road.
12/22/2022	Motor Vehicle Collision – PDO	At approximately 1645 hours, rangers responded to a vehicle versus deer on Highway 64 near Pipe Creek Vista. The vehicle sustained minor damage.
12/22/2022	Arrest – DUI	At around 2245 hours, rangers observed a vehicle fail to maintain lane multiple times. The driver, 22-year-old male resident of Grand Canyon, was found to be intoxicated and was arrested for Driving Under the Influence of Alcohol.
12/23/2022	Motor Vehicle Collision – PDO	At approximately 1415 hours, rangers were dispatched to Highway 64 near Moran Point for a motor vehicle rollover. The occupants denied medical attention and the driver, a 34-year-old male from Fremont, CA was given a warning for Unsafe Operation.
12/24/2022	Arrest – DUI, Drug Violations, Weapons Violations	Around 1530 hours, rangers responded to the report of an intoxicated male Grand Canyon Visitor Center parking lot. On scene, rangers discovered spray-painted plastic bags and litter around a vehicle. Following investigation, rangers confiscated two firearms, fentanyl pills, and several ounces of suspected meth and heroin. The three occupants, a 38-year-old female resident of Clovis, CA, a 38-year-old male resident of Fresno, CA, and a 35-year-old male resident of Clovis, CA, were arrested for Drug Violations and the male driver was charged with Driving Under the Influence of Alcohol.
12/24/2022	Arrest – Public Intoxication	At about 2130 hours, rangers responded to the Coconino Apartments area for a report of a domestic dispute. A 31-year-old male and a 27-year-old male, both residents of Grand Canyon, had been in an altercation and were found to be intoxicated. The subjects were treated for their injuries and arrested for Public Intoxication.
12/26/2022	Disorderly Conduct	Around 1200 hours, rangers received a report of a male brandishing a firearm following a road range incident at the South Entrance Station. Rangers contacted a 43-year-old male resident of Chesterfield, MO and a 39-year-old male resident of Denton, TX, who had engaged in a verbal altercation. Both subjects were given verbal warnings for Disorderly Conduct.
12/26/2022	Emotionally Disturbed Person	At approximately 1200 hours, rangers responded to the Maswik Cabins for a welfare check on a female who made suicidal comments earlier that day. The female stated she was being dramatic when she made the comment to a friend and denied any current suicidal ideations. Rangers provided her with mental health resources.

12/29/2022	Motor Vehicle Collision – PDO	At approximately 1300 hours, rangers responded to a motor vehicle collision on Highway 64 near Desert View. A 22-year-old male resident of New York, NY sideswiped a motorhome while attempting to pass and was issued a citation for Unsafe Operation.
12/29/2022	Agency Assist – Disorderly Conduct	At about 1615 hours, Coconino County Sheriff's Office (CCSO) requested rangers' assistance in Tusayan for a domestic dispute. A female passenger had a protection order against the driver, a 56-year-old male resident of Flagstaff, AZ. The male subject, who was also intoxicated, was arrested by CCSO for Disorderly Conduct and Violating a Court Order.
12/29/2022	Emotionally Disturbed Person	At approximately 1745 hours, rangers responded to El Tovar hotel for a welfare check on a male employee. After talking to staff, rangers discovered no suicidal comments were made, although the male was acting manic. Rangers located the male near his residence, who was not requesting assistance at that time and found to be fine.
12/31/2022	Arrest – Warrant	Around 1645 hours, rangers conducted a vehicle stop for speed. Following investigation, the driver, 47-year-old male from Polacca, AZ, was arrested for an outstanding warrant.
12/31/2022	Arrest – DUI, Wood Cutting	At around 1630 hours, rangers noticed fresh vehicle tracks exiting the pavement on Highway 64 near Desert View. Rangers followed the tracks and discovered significant wood cutting damage in the forest. After locating the two vehicles, rangers contacted five residents of Tuba City, AZ who admitted to the wood cutting. Following investigation, rangers arrested the driver of one vehicle, a 35-year-old male, for Driving Under the Influence of Alcohol and Open Container. The additional four occupants received citations for Wood Cutting.
