SIGNIFICANT INCIDENTS			
DATE	INCIDENT TYPE	SUMMARY	
1/1/2023	Agency Assist – Disorderly Conduct	At approximately 0045 hours, Coconino County Sheriff's Office (CCSO) requested rangers' respond to Tusayan for a possible domestic dispute. Rangers helped CCSO locate the female suspect, who was arrested for Disorderly Conduct.	
1/1/2023	Motor Vehicle Accident – PDO	At around 1230 hours, rangers responded to the South Kaibab Trailhead for a motor vehicle accident. A bus collided with an unoccupied parked truck's rear bumper.	
1/1/2023	Motor Vehicle Accident – PDO	Around 1530, rangers responded to the South Entrance Station for a report of suspiciously few cars coming into the park. On arrival, rangers found an AZDOT snowplow in the ditch and blocking traffic. Roads crew staff assisted in recovering the plow and restoring traffic flow.	
1/1/2023	Disorderly Conduct	At approximately 2330 hours, rangers responded to Supai Camp Loop for a report of a domestic assault. A 51-year-old male and 49-year-old female, both residents of Grand Canyon, engaged in a verbal altercation. The male subject was issued a warning for Disorderly Conduct and the female was relocated for the night.	
1/2/2023	Motor Vehicle Accident – PDO	At about 1015 hours, rangers responded to a single vehicle motor vehicle accident near the kennels. A van slid on the snow and impacted a tree, breaking several windows. The driver was attempting to reverse downhill and lost control of the vehicle. No injuries were reported.	
1/5/2023	Motor Vehicle Accident – PDO	Around 0930 hours, rangers responded to a motor vehicle accident on Village Loop. A vehicle slid on ice and collided with a parked delivery van. No injuries were reported.	
1/6/2023	Resource Violations (Wildlife)	At approximately 1200 hours, a resident of Pinon Park reported that her neighbors were feeding wildlife. The female resident had not seen the behavior occur but reported that wildlife was becoming a nuisance. The resident was advised to call rangers if the neighbors' behavior continued.	
1/12/2023	Commercial/Permit Violations	At about 1445 hours, rangers located a woman selling jewelry at Mather Point. The woman, a 28-year-old female resident of Tuba City, AZ, initially provided false information and stated she did so because she was banned from the park as a result of an earlier incident. The female was issued a citation for Business Operations Without a Permit.
