INDICTMENT

The Grand Jury in and for the District of New Jersey, sitting at Newark, charges as follows:

On a date on or after September 24, 2024, and on or before December 7, 2024, in Somerset County, in the District of New Jersey, and elsewhere, the defendant,

AEDO CRUZ GONZALEZ,
a/k/a "Edo Gonzalez-Luna,"
a/k/a "Rosendo Camarillo-Lopez,"
a/k/a "Aedo Cruz-Gonzalez,"
a/k/a "Acedo Cruz-Gonzalez,"

being an alien who was deported and removed from the United States while an order of deportation and removal was outstanding, and whose removal was subsequent to a conviction for the commission of a felony, and thereafter, without the express consent of the Attorney General or the Secretary of Homeland Security to reapply for admission prior to his reembarkation at a place outside the United States, did knowingly and voluntarily enter, and on or about December 7, 2024, was found in, the United States.

In violation of Title 8, United States Code, Sections 1326(a) and (b)(1).
