**Apply for an internship, earn a paycheck and learn the skills you need for an exciting career in intelligence.**

### WHAT WE NEED

The Office of Intelligence and Analysis (I&A) leads DHS in the business of intelligence. We offer undergraduate and graduate students the opportunity to hone their skills to prepare for careers as intelligence professionals. We need students in the following areas.

- **Intelligence Analysis:** Includes analysis of issues related to terrorism, cybersecurity, border security, transnational crimes and counterintelligence.
- **Intelligence Operations:** Includes open source collection, document and media exploitation, counterintelligence operations and coordination of information sharing activities.
- **Mission Readiness:** Includes budget and finance, human resources, program management, security, strategic planning and policy development.
- **Information Technology and Data Science:** Includes information assurance/IT security, IT engineering, data science and visualization, and programming and development.



### BASIC QUALIFICATIONS

All applicants must meet the following criteria:

- Be a U.S. citizen and able to obtain and maintain a Top Secret security clearance.
- Be a current degree-seeking undergraduate or graduate student in a Department of Education accredited university. Must have at least one academic year of study. Rising seniors are eligible to apply if they will be going directly on to graduate school.
- Maintain a cumulative GPA of 3.0 or higher.
- Be 16 years old or older.

## FAQs



### Where are the internships located?

Internships are in the Washington, DC, area.



### Are internships for the summer or year-long?

All interns start in the summer and work full time. Interns attending Metropolitan Washington, D.C. universities may continue to work during the academic year.



### When do I apply?

### How can I prepare for the security clearance?

- If you travel abroad, keep a list of dates, locations and foreign contacts.
- If you have foreign contacts on social media, include them on your list.
- Do not use illegal drugs, including marijuana. While legal in several states, marijuana is still illegal under federal law. Do not misuse legal/prescription drugs.
- Do not illegally download material.
- Be careful with alcohol consumption.



### Does DHS provide housing for interns?

### Can summer interns return each year?

Yes! In fact, we encourage our high-performing interns to return for an additional summer internship.



### Will I be offered a job when I graduate?
