Issue: Changes to Bankruptcy Court Miscellaneous Fee Schedule

At its March 2020 session, the Judicial Conference approved inflationary adjustments to the Bankruptcy Court Miscellaneous Fee Schedule (28 U.S.C. § 1930) to take effect on December 1, 2020. (**See Table 1**)

The adjustment to the Administrative Fee (Item #8) will increase the fee to file a petition under all chapters and to file a motion to divide a joint case under chapter 7, 11, 12, and 13. (**See Table 2**)
