Oratory Contest: Five Students Share Their Views on "Crisis in Black Education"

Each February, GAO celebrates African American History Month with a large variety of events. The 27th GAO Student Essay Oratory Contest, which concluded GAO's celebration of African American History Month, is typically a highlight of the month. On February 28, five students presented their essays based on this year's African American History Month theme, "Crisis in Black Education." The purpose of the competition, now in its 27th year, is to encourage the development, writing and presentation skills essential to academic and professional success. Since 1989, 128 students have participated as finalists in the program, which is open to Washington, D.C. high schoolers.

Pamela Hall of FAIS was the emcee and it is her first year serving as the Oratory Contest Coordinator. Contestants were asked to research and write a 700 to 1,000 word essay. The entrants were judged on the quality of their written essays as well as their oral presentation. After a preliminary round of judging, the five finalists, one from Woodrow Wilson High School, one from Thurgood Marshall Academy PCHS, and three from H.D. Benjamin Banneker Academic High School presented their essays before a live audience of GAO employees, family members, school faculty and friends.

First place winner, Aaron King was from Woodrow Wilson High School. King began with a quote from Carter G. Woodson, who wrote "The Mis-Education of the Negro" which was first published in 1933. "If you can control a man's thinking, you do not have to worry about his action." King said modern problems with black education include that most black students are placed in lower quality early child care and he discussed the school to prison pipeline. He said he finds that "We suffer from lack of finding connection with teachers." King is interested in a career in film and journalism.

Second place went to Destiny Jackson from Benjamin Banneker High School. Jackson, who is interested in a future in finance, said she felt oppression by her own peers and their acceptance of mediocrity.

Kelsi Gross from Benjamin Banneker High School took third place. She said she witnessed "mis-education" in the 5th grade when she shifted to a predominantly white school from a predominately black school. "I have to separate myself from my community to get an education," she said. Gross is interested in robotics and chess and said she is unsure about her future career.

Honorable Mention went to Talia Ford, Thurgood Marshall Academy PCHS and Jose Castellon, Benjamin Banneker High School. Ford seeks a future as a lawyer or judge, or senator. Ford said she felt that she's been blind to the problems of black students in public high schools, citing that 69% of African American students graduate, compared to her school where 100% of the students graduate. Castellon, an immigrant from El Salvador, said he felt that the crisis was his, too. "It's our crisis. Yes, our crisis. Not his, not yours, not the black man's crisis, but our crisis," he said. Castellon is interested in a career in Constitutional law.

The finalist round was judged by Comptroller General Gene Dodaro; Clifton Douglas, SI, Chief Judge; Chief Human Capital Officer Bill White; James Christian-Blockwood, SPEL; Lois Hanshaw, OGC; Phyllis Anderson, FMA; and Latesha Love, FAIS.

After the event, Hall stated, "I am pleased with the outcome of my first year as the Oratory Contest Coordinator. Congratulations to the overall winner, Aaron King and the other winners, Destiny, Kelsi, Talia and Jose. All of the participants did a great job. Keep up the good work."


In addition, the office organized a "music lounge" in its break room featuring music of African-American musicians; an interactive board where staff

Award



Senior Social Science Analyst Valerie Caracelli, ARM, was awarded the Robert Ingle Service Award by the American Evaluation Association (AEA). AEA newsletter profiled Caracelli:

"Valerie Caracelli has been a professional evaluator for over 30 years. Much of her career has been at the U.S. Government Accountability Office (GAO), where she works in the Applied Research and Methods Team, in the Center for Evaluation Methods and Issues. In addition to conducting congressionally requested studies with Stephanie Shipman, she consults with other GAO Teams on evaluation design issues and assists in examining the quality of evaluation studies.

She has been a member of the American Evaluation Association since its founding. With Jennifer Greene, her scholarly interests in mixed methods resulted in several articles that framed mixed methods evaluation designs (see for example, their co-edited volume, Advances in Mixed-Method Evaluation (NDE, no. 74). She has served as chair of the Evaluation Use TIG, now known as the Use and Influence of Evaluation TIG, and maintains active engagement. In 2000, she and Hallie Preskill conducted a survey of evaluators about evaluation use. This led to a New Directions for Evaluation volume (NDE-no. 88), "The Expanding Scope of Evaluation Use."

According to Nancy Kingsbury, ARM, this award was named after the late Robert Ingle who was a founding member of AEA and was its long time conference chair. "The award was created to recognize service to the organization as well as the field of evaluation. Val has been a long-time stalwart in the AEA local affiliate, "Washington Evaluators," said Kingsbury.

This is not the first Robert Ingle award to come to a GAOer. Kingsbury was presented with the first Ingle award from AEA in 1987 for her service as its Secretary Treasurer (and Secretary Treasurer for the predecessor organization, the Evaluation Research Society.) AEA was created in 1986 in a merger of ERS with an organization called Evaluation Network.
