

# Knowledge Brokers

Communities of Practice (CoP) & Federal and Industry Summits



**FY24 saw a total of 50 community meetings with 4,247 attendees!**

#### Key Metrics by Community:

- » **Cloud & Infrastructure Community of Practice** held eight meetings with 1,099 attendees
- » **IT Sustainability Subcommunity of Practice** held four meetings with 149 attendees
- » **Low-Code No-Code Subcommunity of Practice** held eight meetings with 999 attendees
- » **Agile Subcommunity of Practice (New!)** held two meetings with 145 attendees
- » **Workforce Development Subcommunity of Practice** held 25 training sessions with 1,333 attendees
- » **IPv6 Subcommunity of Practice** supported three meetings with 522 attendees

#### Federal and Industry Summits:

- » **Disruptive Methods to Modernize IT Symposium** had 371 attendees
- » **IT Modernization Summit** had 400 attendees


#### Looking Ahead towards FY25:

**In FY24, the Task Force:**


- » Engaged CFO-Act agencies on their progress

# Federal Upskilling

Interagency Committee on Standards Policy (ICSP)



**The Office of Technology Policy (OTP) assumed the GSA Standards Executive Role as a member of the ICSP to provide technical expertise for the adoption of new standards.**

**The IT Modernization Division was selected to facilitate this role and participate in this committee.**

**In FY24, the IT Modernization Division has:**

- » Attended eight ICSP meetings and working group meetings.
- » Engaged GSA Standards SMEs involved in national and international standards bodies.

- » Authored a Concept of Operations for the role of GSA Standards Executive in collaboration with NIST ICSP leadership.

**In FY25, we will:**

- » Continue to engage with Standards SMEs.
- » Continue attending ICSP meetings and sharing information with the GSA community.
- » Release a Data Center Guide for leveraging artificial intelligence and high-performance computing technologies.
