On My Mind



Health Center COVID-19 Survey*- Patient Testing

- Health centers with COVID-19 testing capacity: 89.52%
- Health centers with COVID-19 drive-up/walk-up testing capacity: 66.52%
- Average turnaround time for COVID-19 test results: 65.41% at 2-3 days

Number of patients tested:

Metrics	Value
Patients tested for COVID-19	127,816
Racial and/or ethnic minority patients tested for COVID-19	57.33%
Patients tested positive for COVID-19	36,155
Racial and/or ethnic minority patients tested positive for COVID-19	56.10%

Health Center COVID-19 Survey - Operations & Staff

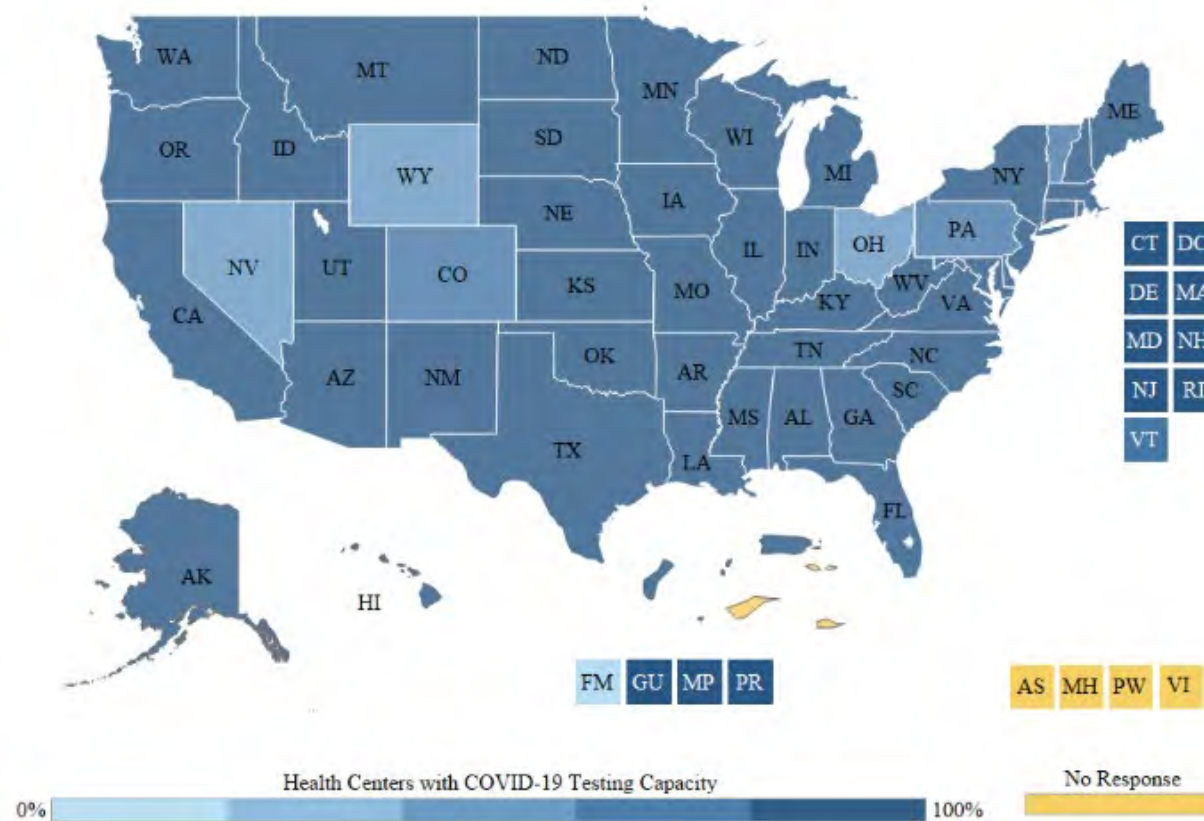
Metrics	Value
Health center weekly visits compared to pre-COVID-19 weekly visits	57.19%
Health center sites temporarily closed	1,954
Staff tested positive for COVID-19	419
Health center staff unable to work*	11%
Average percent of health center visits conducted virtually	50.97%

- **Health centers with an adequate supply of Personally Protective Equipment (PPE) for the next week:**
 - Surgical masks: 92.68%
 - N95/PPR masks: 89.91%
 - Gowns: 87.64%
 - Gloves: 96.04%
 - Face masks/goggles: 92.98%



*Due to site/service closure, exposure, family/home obligations, lack of PPE, etc.

These data represent the percent of health centers with testing capacity for COVID-19, by state, for the week of May 8, 2020.

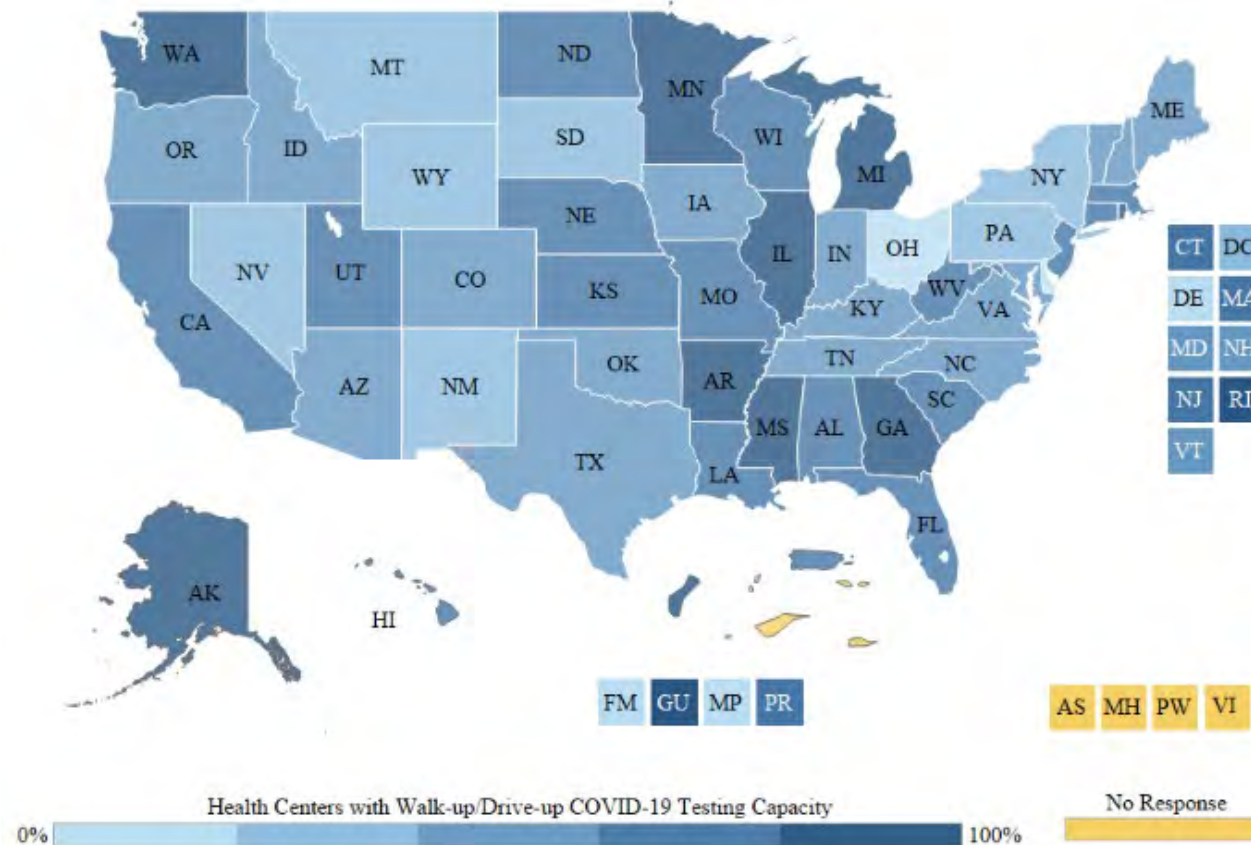

Health Centers with Walk-up/Drive-up COVID-19 Testing Capacity



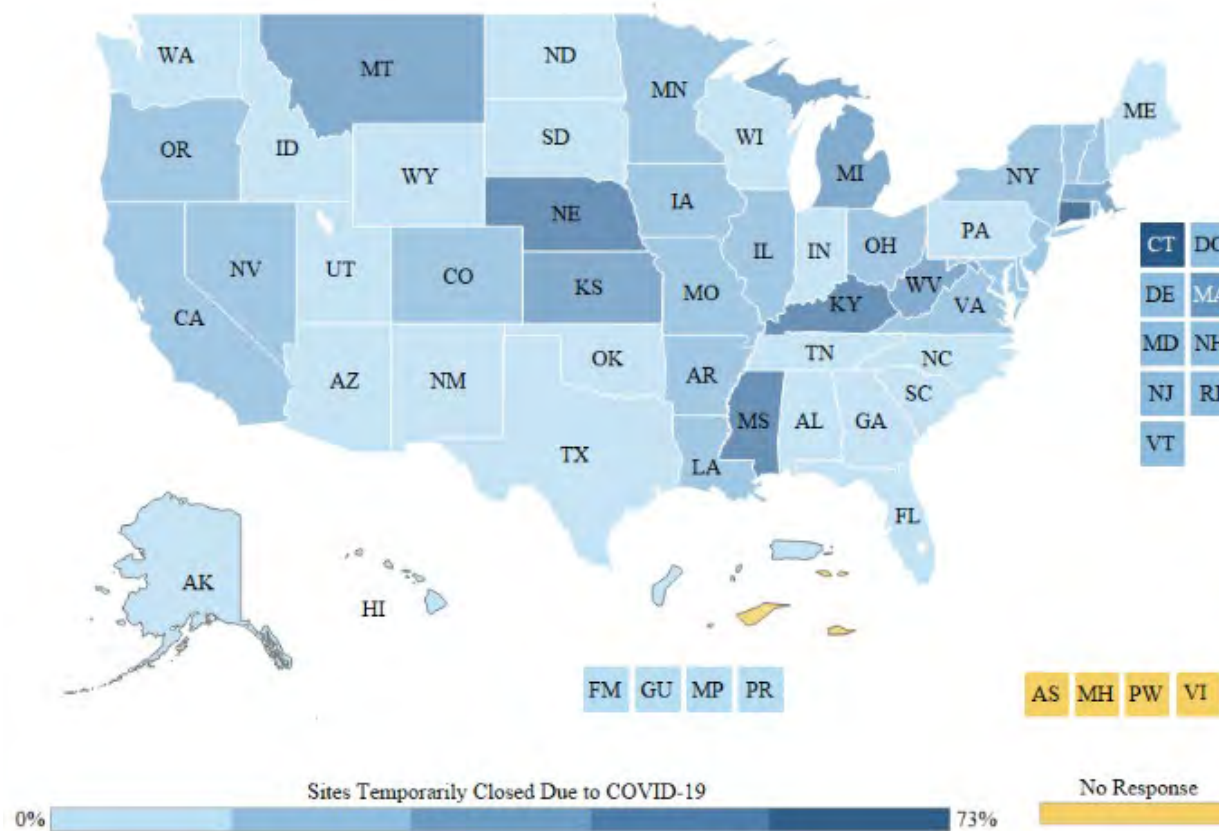

Sites Temporarily Closed Due to COVID-19



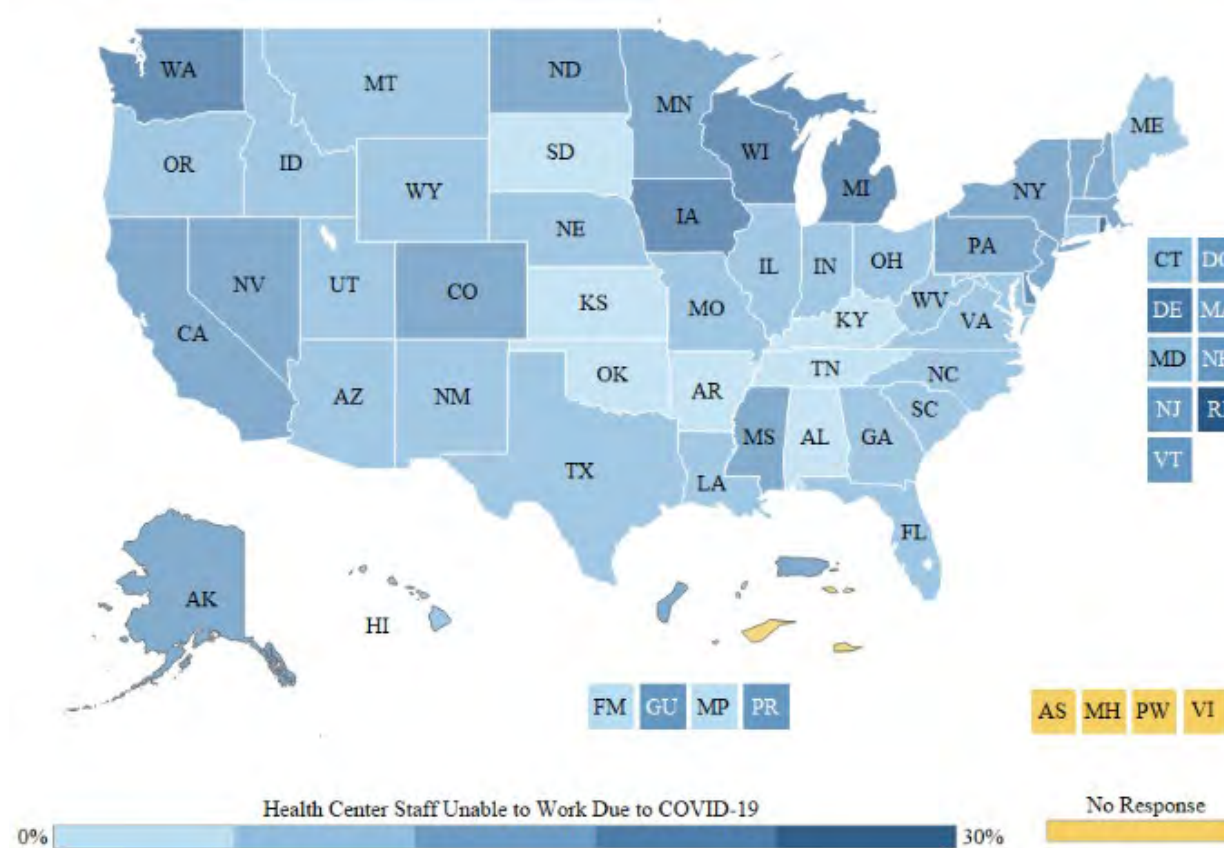

These data represent the percent of health center staff unable to work due to COVID-19, by state, for the week of May 8, 2020.

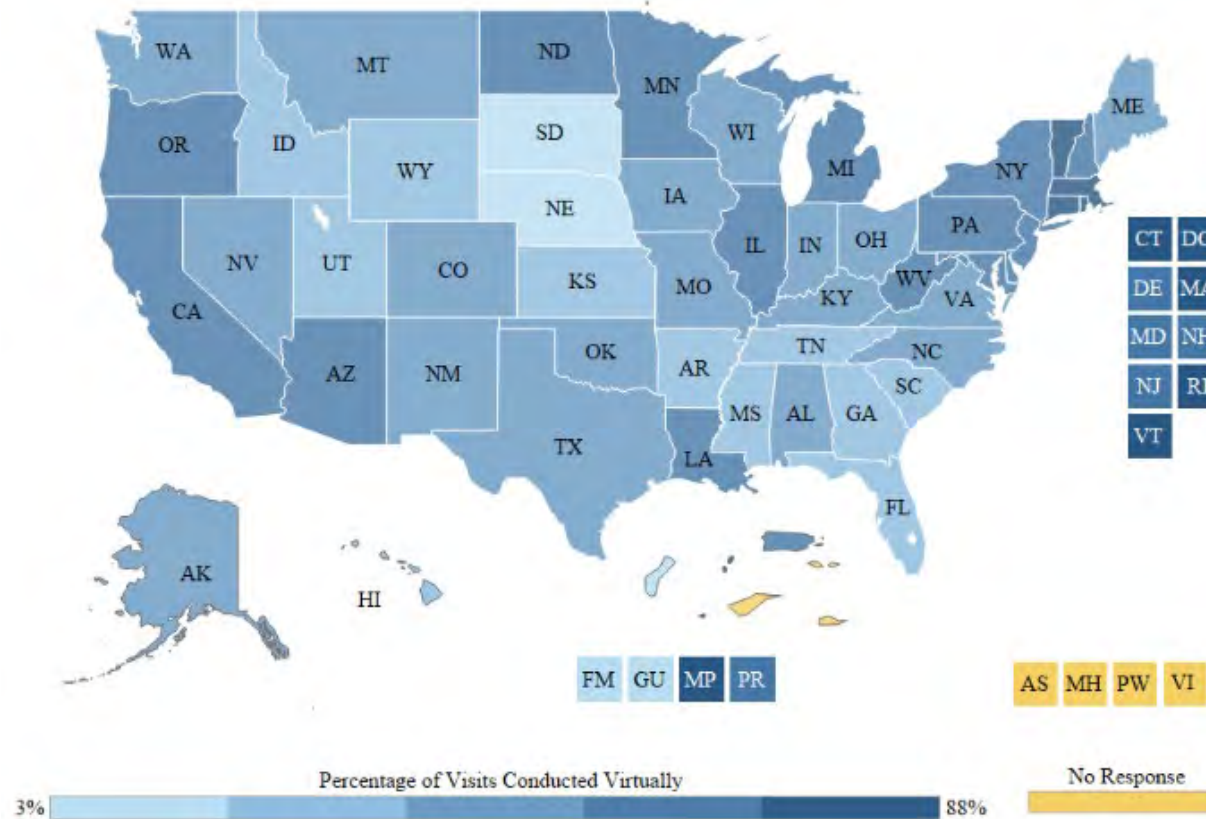
