SECTION 1 - OVERVIEW

1.1 FBP A2A CHANNEL

The Forms Based Processing system A2A channel allows registered API consumers to interact with FBP in programmatic way on be-half of an IVES participant. FBP is organized around two main entities.

1. **Documents** – Documents represent IRS forms that are/have been submitted to the IRS for processing. For IVES this will be the form 4506c
2. **Products** – Products represent the outcome of processing a form. For IVES products are the transcripts that were generated based on the details of the 4506c submitted.

The A2A channel provides the consumer the ability to

- **Submit Documents** – Submit new document (4506c) request to the IRS for processing
- **Search Documents** – Search for request that have already been submitted. Request submitted via any input channel will be available
- **Retrieve Document Details** – Retrieve the current details of a specific document
- **Edit Document** – Documents that were submitted via the A2A or Web-UI input channel are available for editing/updating prior to Taxpayer authorization
- **Withdraw a Document** – Documents that were submitted via the A2A or Web-UI input channel can be withdrawn prior to Taxpayer authorization. Withdrawing a document cancels the request for processing.
- **Search Products** – Search for products (transcripts) that have been generated by the IRS.
- **Retrieve a Product's Details** – Retrieve the metadata for a specific product
- **Retrieve a Product's Content** – Retrieve the content for a specific product

1.2 API AUTHENTICATION & AUTHORIZATION

The authentication and authorization capabilities utilized by the FBP A2A input channel are provided by a centralized framework that supports all of the e-Services APIs. The [**e-Services API Authorization User Guide**](#) provides information regarding the client registration process required for new consumers to gain access to the e-Services APIs as well as the technical details related to the authentication and authorization process flows utilized by the e-Services APIs. SECTION 4 - TESTING

The FBP A2A API provides a publicly available set of testing resources for API clients to test against. Each of the API resources are available on the test endpoint <https://api.alt.www4.irs.gov>. Resources on the test endpoint only return simulated responses, they do not return response with live data. To access the test resources, you must have a valid client ID and valid user credentials.

The purpose of the test resources is to allow clients to see a verity of responses, so they can handle them appropriately. The following sections outline the behavior for each of the FBP A2A API resources.

4.1 SUBMIT DOCUMENT

Clients can submit 4506c to the test endpoint(s)

- when submitting valid data (data that meets the input constraint) clients will receive a document summary response with an assigned transaction id that can be used to search, retrieve document details, etc.
- when submitting invalid data, clients will receive a 400 Error Response, with details about which field or fields are invalid
- Taxpayer approval/signatures, documents will not actually be processed. Based on taxpayer in the document they will
 1. When the tin start with 000-11- the document will stay in PENDING_AUTHORIZATION status and will never move to completion. These documents can be used to test editing and withdrawing a document
 2. When the tin does not start with 000-11- The testing env will approve them and generate simulated products/transcripts for them.

4.1.1 Notes

- Only 1 product will be generated per document, documents that request multiple types and tax periods will only get 1 product.
- **DO NOT use live taxpayer data!!!**
- Document submittals are still subject to 429 constraints

4.2 SEARCH DOCUMENTS

Clients will be able to search for any/all of the documents they submitted into the test endpoint(s).

4.3 RETRIEVE DOCUMENT DETAILS

Clients can retrieve the document details of any/all documents they have submitted into the test endpoint(s)



4.4 EDIT DOCUMENT

Clients can edit any of their documents that are in PENDING_AUTHORIZATION status in the test environment.

4.4.1 Notes

- The only documents that will stay in PENDING_AUTHORIZATION status are those that have taxpayer tin that start with 000-11-
- These documents will never move to COMPLETE they will stay in PENDING_AUTHORIZATION until they expire.

4.5 WITHDRAW DOCUMENT

Clients can withdraw any of their document that are in PENDING_AUTHORIZATION status in the test environment.

4.5.1 Notes

- The only documents that will stay in PENDING_AUTHORIZATION status are those that have taxpayer tin that start with 000-11-

4.6 PRODUCTS SEARCH

Clients can search for any/all products/transcripts that have been created for the documents they have submitted in the test environment.

4.6.1 Notes

- Only 1 product will be generated per document, documents that request multiple types and tax periods will only get 1 product.
- Only documents with a taxpayer tin that do not start with 000-11- will get a product generated for it in the test environment.
- Products are canned examples. They will not correspond to the taxpayer(s) request in the document, nor the tax form requested in the document

4.7 RETRIEVE PRODUCT DETAILS

Clients can retrieve the details of any product/transcript that have been created for the documents they have submitted in the test environment.

4.7.1 Notes

- Only 1 product will be generated per document, documents that request multiple types and tax periods will only get 1 product.
- Only documents with a taxpayer tin that do not start with 000-11- will get a product generated for it in the test environment.
- Products are canned examples. They will not correspond to the taxpayer(s) request in the document, nor the tax form requested in the document



4.8 RETRIEVE PRODUCT CONTENT

Clients can retrieve the content of any product/transcript that have been created for the documents they have submitted in the test environment.

4.8.1 Notes

- Only 1 product will be generated per document, documents that request multiple types and tax periods will only get 1 product.
- Only documents with a taxpayer tin that do not start with 000-11- will get a product generated for it in the test environment.
- Products are canned examples. They will not correspond to the taxpayer(s) request in the document, nor the tax form requested in the document
