As a follow-up to meetings held during the 2023 United Nations General Assembly (UNGA) with Turkish President Recep Tayyip Erdogan and his Cabinet, the U.S. Chamber of Commerce's U.S.-Türkiye Business Council will lead a U.S. Department of Commerce Certified Green Tech Mission to Ankara and Istanbul.

This business mission will advance bilateral partnerships to accelerate Türkiye's ongoing energy transition and climate goals. The business mission plans to meet with new government officials including Minister of Trade, Minister of Treasury and Finance, Minister of Health, Minister of Defense, Minister of Energy and Natural Resources, Minister of Environment, Minister of Industry and Technology, and Vice President of Türkiye.

The mission will feature specialized meetings focused on energy transition, adaptation technologies, and clean-green tech ahead of the COP28 Summit in Dubai. All companies

contributing to the clean-green energy transformation are encouraged to participate including sectors like energy, manufacturing, transportation, agriculture, finance, and healthcare.

The U.S. Office of the Special Presidential Envoy for Climate John Kerry will participate, in addition to various agencies across the U.S. government working to provide technical and financial assistance to facilitate U.S. companies engaging in green technology projects in Türkiye.
