Purpose Statement

Dental practitioners are often uninformed and therefore ill-equipped to make decisions pertaining to the clinical applications of Artificial Intelligence (AI), Software as a Medical Device (SaMD), and associated Clinical Decision Support Systems (CDSS). A 2022 published survey suggests that busy clinicians have neither the time, inclination, or expertise to pursue the fundamental knowledge necessary to understand the complex issues involved in developing and deploying AI, SaMD, and CDSS tools. Yet, AI is developing with breathtaking speed; it is imperative that clinicians gain a basic understanding of the fundamentals of AI technology so that it can be deployed safely and effectively into clinical practice.

The purpose of the International Virtual Symposium on Artificial Intelligence in Dentistry is to provide event participants and interprofessional health care teams with a fundamental understanding of artificial intelligence (AI) as it relates to SaMD, CDSS, and related applications. The expected outcome of this live, virtual knowledge-based training is that participants will gain a broad understanding of AI uses in dental practice. Participants will learn advantages and pitfalls of incorporating AI and Software as Medical Devices (SaMD) into the clinical environment. Most importantly, it will provide dental healthcare providers with a basis for evaluating AI modalities and Clinical Decision Support Tools before incorporating them into clinical practice. This program will include national and international speakers, industry representatives, and content experts from government, academia, and private sector.





Target Audience

The primary target audience for this activity consists of dentists, nurses, and nurse practitioners. The secondary target audience for this activity consists of clinical staff.

Outcome/Objectives

At the conclusion of this educational program, learners will be able to:

- 1. describe broad concepts of AI, its uses in health care, current applicable VA policy framework, and available resources;
- 2. explain AI software development in Dentistry, including Deep Learning and Supervised Learning, to potentially improve clinical outcomes;
- 3. explain potential applications of current FDA-approved AI software devices in diagnosis and treatment planning in Dentistry;
- 4. identify at least two AI technologies' potential uses in efficient dental charting, note documentation, and generating reports;
- 5. identify at least two potential risks and ethical considerations in use of AI augmented software devices; and
- 6. list at least two AI possible uses beyond diagnostic aids in Dentistry.
