SUBJECT: Timeline for Reporting 2023-2024 Accountability Results

The Virginia Department of Education (VDOE) has established the following preliminary timeline for the release of accountability reports that are based on data from the 2022-2023 school year. The timeline is preliminary and subject to change. As in the past, school division staff will be notified of any change to the timeline, should one be necessary. Please protect student privacy by exercising care in sharing information from any of these reports.

Week of May 8, 2023

- **Preview** accreditation data will be available within the *Accreditation* application reports found in the VDOE <u>Single Sign-On for Web Systems (SSWS)</u>. Initially, growth data will NOT be included in the preview results for the grades 3-8 mathematics and English combined rates. Divisions will be notified when the preview results include growth.
- It is important to note that **preview** results for the achievement indicators may be vastly different than final accreditation rates due to, in part, fewer test records at the beginning of the testing window, and the non-inclusion of growth. Also, other reports within the *Accreditation* application only reflect currently refreshed data. Accreditation results will be refreshed bi-weekly.

June 10, 2023

Preliminary reports are available in the *Cohort Graduation* application within SSWS, which includes:

- Graduation & Completion Index (GCI) reports;
- Federal Graduation Indicator (FGI) reports; and
- Virginia On-Time Graduation reports.

June 16, 2023

• The School Quality Profiles (SQP) *Finance* tab will be updated to include 2021-2022 school, division, and state per-pupil spending, as well as the percentage of expenditures for instruction for the division and state.

July 21, 2023

• The deadline for successful submission of the end-of-year Student Record Collection (SRC).

July 24, 2023

- Assessment data are locked.
- **Preliminary** accreditation results will be available in the *Accreditation Detail Report*, found in the *Accreditation* application of the VDOE Single Sign-On for Web Systems. Growth data will be included. EL proficiency data will be added when the data becomes available. Reports are refreshed bi-weekly.

July 31, 2023

- **Preliminary** ESSA results will be available in the *Federal Accountability Detail Report* found in the *Federal Accountability* application of the VDOE Single Sign-On for Web Systems.
- The annual pass rates will be available in the *Pass Rates Report* and the *Pass Rates by Test Report* in the *Federal Accountability* application of the VDOE Single Sign-On for Web Systems.
- Reports are refreshed bi-weekly.

August 14, 2023, 9:00 a.m. through August 15, 2023, 3:00 p.m.

- Divisions will preview the <u>School Quality Profiles</u> to review the Annual Pass Rate results, Federal Accountability (ESSA) results, and Chronic Absenteeism data.
 - The Assessment tab of the School Quality Profiles reports the Annual Pass Rates.
 These rates reflect the number of students who pass the assessments, and DO
 NOT include students who fail the assessments but demonstrate growth.
 - The Learning Climate tab of the School Quality Profiles reports, in part, the Chronic Absenteeism rates.
 - The ESSA tab of the School Quality Profiles reports the participation rates and the federal achievement rates for reading, mathematics, and science, Chronic Absenteeism rates, and English Learner Progress. The Federal Graduation Indicator will not be reported at this time.
 - The *At-A-Glance* button will NOT be updated at this time.
 - o The URL and password for a preview of the School Quality Profile website will be provided by superintendent's email at 9:00 a.m. Monday, August 14.

August 17, 2023

- VDOE issues a press release on the 2022-2023 statewide, division, and school Annual Pass Rates on state assessments (overall and by student reporting group).
- Subject-by-subject and test-by-test Annual Pass rates will be posted publicly on the School Quality Profiles under the *Assessments* tab and on the <u>SOL Test Pass Rates &</u> <u>Other Results</u> page. The <u>Build-a-Table</u> tool on the VDOE website will include the 2022-2023 annual assessment results.
- Federal accountability results (participation rates, performance rates, chronic absenteeism rates, and English Learner Progress) will be posted on the School Quality Profiles under the *ESSA* tab.

August 18, 2023

This is the deadline for a successful summer submission of the summer SRC.

August 25, 2023

• The Substitute Test application in SSWS closes for the 2022-2023 school year.

September 1, 2023

- The cohort graduation data correction tool within the *Cohort Graduation* application in SSWS closes until January 2023.
- All data is locked for a final accountability refresh.

September 2, 2023

• **Final** refresh of Graduation and Completion Index (GCI), Federal Graduation Indicator (FGI), and Virginia's On-Time Graduation rate.

September 5, 2023

• **Final** accreditation results will be available in the *Accreditation Detail Report* within the *Accreditation* application of the VDOE <u>Single Sign-On for Web Systems (SSWS)</u>. The *College, Career, & Civic Readiness Index* will be used for the first time in determining accreditation status

September 15, 2023

 Schools designated for federal support will be notified by this date by the Office of School Quality.

September 18, 2023, 9:00 a.m. through September 19, 2023, 3:00 p.m.

- Division preview of the School Quality Profiles to view the *Accreditation* tab.
- The URL and password to preview the School Quality Profile website will be provided by superintendent's email at 9:00 a.m. Monday, September 18.

September 21, 2023

- VDOE issues a news release on the 2022-2023 state accreditation ratings (including performance levels on school quality indicators).
- VDOE will update the *Accreditation* tab on the School Quality Profiles for schools to include new accreditation ratings.
- The *At-A-Glance* button on the School Quality Profiles will be updated at this time.

September 28, 2023

- VDOE issues a news release on the Virginia On-Time Graduation rate and the cohort dropout rate for the class of 2023.
- The *ESSA* tab on the School Quality Profiles will report the Federal Graduation Index and the *College & Career Readiness* tab will report the Virginia On-Time Graduation rate for the class of 2023.
- Cohort data will be posted on the VDOE website, and data for the 2023 cohort will be included in the *Cohort Graduation Build-a-Table* tool.
- Schools under federal support designations are tentatively scheduled to be posted on the VDOE website.
