Building Capacity for Involvement

Efforts will be made to ensure parents/caregivers are actively involved in the development, implementation, monitoring, and evaluation of the school's Title I program, including the following:

- Provide family members a voice in decision-making on committees, such as SIIP Committee, TPAC Committee,

Effective Communication with Parents

Efforts will be made to ensure parents/caregivers receive meaningful communication in a timely manner, including the following:

- Use multiple methods of communication to families such as Timber Lane Twitter account, FCPS News You Choose, PTA updates, school website, PTA Facebook page, PTA website, PTA Twitter, E-Notify, and paper copies of flyers. Communication will be put forth as often as possible in multiple languages.
- Encourage all caregivers to attend an annual PTA meeting on **September 15**, **2020** to share information about Title I services, explain Title I grant requirements, and inform families of their right to be involved in the school.
- Share new virtual tools that we will be using for the 2020-2021 school year and offer virtual parent technology nights prior to school starting to best help parents support students in their virtual learning.
- Provide opportunities throughout the year for families to better understand the school's goals for students and find ways to improve student learning by hosting literacy and math nights where families can be involved in authentic ways to help support their children.
- Maintain resources for caregivers to review student assignments and ongoing communication about student work, such as grade level and class newsletters and parent contact via email and phone, as well as parent teacher conferences.
- Provide ongoing feedback on student progress through quarterly progress reports that show specific areas of proficiency and areas for continued growth.
- ♦ Hold parent-teacher conferences for all students at least annually in the fall and more often, as needed.

Shared Responsibilities for High Academic Achievement

Efforts will be made to ensure parents/caregivers receive materials, training, and benefits from school partnerships with social and academic services, community-based organizations, and businesses, including the following:

- Hold workshops connecting caregivers to tools and resources, such as grade level math nights, reading to and with your child. We will host a math night on various topics and two partners in print nights on various topics related to reading.
- ♦ Offer regular opportunities for families to learn directly from school staff about the school's academic, behavioral, and social programming through PTA meetings and quarterly Tiger Talks.
- ♦ Encourage participation in family learning events where caregivers learn strategies to support their child's learning at home and have a chance to practice those strategies with their child, such as Math night, and Partners in Print.
- ♦ Provide ongoing access to resources in the school, such as Library nights, school website and PTA meetings.
- ♦ Provide mentors for students though Timber Lane mentoring program, buddy reading classrooms and staff check in/check out model.
- Provide opportunities for every child to obtain school supplies, laptops, books and other learning materials free of charge.
- ♦ Leverage partnerships with local businesses and organizations to enhance school programs and events, such as New City Church, Mclean Rotary, Food For Others, and Mclean Bible Church.
- Support parents in accessing county and community resources, such as health care resources (Medicaid, FAMIS, MCCP and County health clinics), food resources (SNAP benefits, WIC, local food pantries, holiday food drives), eyeglass and dental resources, emergency financial assistance (Fairfax County's Coordinated Services Planning), etc.
- ♦ Offer outreach and training for targeted families, such Parent Liaison led activities and classes.

Welcoming All Families

Efforts will be made to ensure that all parents/caregivers are welcomed and provided opportunities to actively engage within the school, including the following:

- ♦ Create a welcoming atmosphere at the school through frequent and open communication, accessibility to staff, PTA events, and translated documents.
- Provide interpretation services for parent-teacher conferences, workshops, and meetings.
- Translate or provide interpretation of all school documents and communication to make them accessible in the caregiver's preferred correspondence language.
- Support two-way communication between families and staff through assistance of a parent liaison for translating teacher and parent correspondence, phone calls in the native language using interpreters when needed, and fliers for school and community events.
- Expand access for family participation in informational meetings and learning sessions through providing interpreters at the meetings and parent workshops.

- ♦ Provide multiple opportunities for caregivers to ask questions and give input into the Title I programs.
- ♦ Publish or present information regarding state and local assessments administered during the school year.
- Publish or present information regarding the school's accreditation and federal accountability results.
- ♦ Provide parents with the school's Title I Family Engagement Policy and Compact Provisions.
