Fairfax Public Access

Fairfax Public Access is a non-profit TV/Radio station, which operates the production facilities for the public access channels in Fairfax County. These are channels: 10, 30, 36, and 37 on Cox Cable of Northern Virginia, Comcast Cable at Reston and Verizon FiOS TV. We offer a wide variety of workshops for those interested in learning about television and/or radio production.



Throughout the year, anyone interested in learning more about FPA and our services is encouraged to begin by attending a free orientation and tour of our station. Information regarding the monthly orientation dates and times is available online at (<http://www.fcac.org/orientation>), OR alternatively visitors to the site can now see a video presentation with the information offered in our general orientations. Participants that decide to become FPA members can then enroll in the various TV or Radio production courses designed to teach the use of our production equipment and station policies. Upon completion of our training workshops, each member is encouraged to network and begin earning hands-on production experience by volunteering as a crewmember in the various productions conducted at the station. Additionally, FPA members can also become certified as TV and/or Radio producers and submit a program proposal in order to create their very own shows.

In order to get involved FPA does have a yearly membership fee of \$26 dollars and course fees vary depending on their length. However, once certified the use of our studios and production equipment is free of charge to members working on an approved FPA program.

FPA's general courses are open for adult and students as young as 15, however, during the months of July and August FPA offers the following summer camp programs for teens (ages 12-18). These camps include hands-on training in the use of our station equipment and mirror the core equipment courses offered throughout the year. Therefore, camp choices include our television studio equipment, television field equipment and our post-production editing educational goals. Furthermore, the camps include the cost of the yearlong FPA membership and upon certification, students are encouraged to network with our independent producers to earn production experience or review with our staff the options to produce a show of their own.

CAMP DESCRIPTIONS & INFORMATION

2021 Television 101 Summer Camps (for ages 12-18)

Choose between the STUDIO Production, FIELD Production or VIDEO EDITING camps

DISCOVER the behind the scene process of what it takes to create a television program. Learn about the equipment and key production roles. There is a lot of effort involved; therefore, teamwork and preparedness will be key to make a successful show. Each program created as part of the camps will only be as good as the crew involved; therefore, we are looking for the best, most dedicated students interested to learn about this exciting media.

The goal for the TV Studio and TV Field camp is to create a 30-minute program, planned and filmed by the students and then edited with the aid of the instructor. If successful, the program will then air on Channel 10.

The TV 101 Studio camp: Our studio TV camp includes instruction in pre-production and production areas, including all the key equipment and crew roles such as scriptwriting, studio lighting, studio cameras, set design, audio, floor directing, on-air talent, graphics, and technical Directing. Learn the "how to's" of creating studio television programs and what is needed to put together a half-hour show. Successful completion of the camp allows students to receive certification approval on both the use of our studio A and B equipment and as possible future TV producers. Participants will also receive a copy of the final student project and information of when it will air on Channel 10. Students are further encouraged to take advantage of their annual FPA membership and volunteer in the various studio shows to improve their skills and gain production experience.

Positions covered in the TV 101 Studio camp include - Studio Camera operator, audio operator, Lighting, Set-Design, Graphics operation, Technical Directing, Floor Directing, Talent, and an overview of post-production work.

Cost: \$500

The TV 101 Field camp: Our field TV camp includes hands-on training using FPA's JVC professional grade HD cameras and all associated equipment. Students will learn to conceptualize a field program by completing a storyboard, plan their shoots and record footage at the station or locally in the Alliance or Mosaic Centers near the station. Furthermore, as part of the training participants will review proper care of the gear, plus the key techniques and procedures to record an on-location shoot. Classroom facilities will be booked as part of each session, however, a great deal of time will be spent outdoors gathering the footage for the show. Successful completion of the camp allows students to receive certification approval on both the use of our field production gear and as possible future TV producers. Students will receive a copy of the final student project and information of when it will air on Channel 10. As with our other training programs, at the end of the camp students are encourage to volunteer to practice and gain further experience.

Positions covered in the TV 101 Field camp include - Field Camera operator, Audio operator, Lighting, Field Director, Production Assistant, Talent, and overview of post-production work.

Cost: \$500

TV 101 Post-Production video editing Camp (Adobe Premiere): If you are you interested in learning how to tweak and edit videos and better understand the role of a professional video editor this camp is for you. Participants in this camp will learn the functions of the widely used Adobe Premiere video editing software and the essential techniques to become proficient at editing videos. The camp objectives are two fold, the first goal is to teach students the tools and workflow on how to operate the software program and the second is to teach the concepts of basic storytelling to create more compelling TV, Film or online videos. Leading to a more rounded editor.

Topics covered in the editing camp include - Program tools, importing and trimming footage, adding transitions, working with audio and music, using text/graphics, color correction and exporting.

2021 WRLD Summer Radio Camp (for ages: 12-18)

WRLD Radio Production Camp: Since its inception, radio has had a significant impact in the culture of the world. Thru the various genres such as music, news reporting, storytelling, and on-air discussions, the impact of radio continues to evolve along with the ever-changing digital technologies. In present day, the impact of radio style productions even extends to shows that are podcast and streamed online. FPA invites all students who are interested in experiencing what radio is all about to take part in our *WRLD Radio Summer Camps*.

Camp time is a mix of workshops, in class discussions, and hands-on training. During the camp students will understand the needs of each radio show genre and review the specific requirements for each. In addition, students will know how a radio studio works, learn the use of the radio board and microphones and develop scripts such as news clips, weather reports, and/or music discussion segments. Part of the camp will focus in reviewing tips on how to conduct on-air interviews with their peers and review the basics of post-production audio editing using either Adobe Audition or the Audacity audio editing software program. To cover all the content, students will rotate and share key production roles as they bring each segment together and create their very own radio Show. The goal for the radio camp is the creation of a 58 minute student lead program, structured and recorded with the collaboration of each student with the aim of airing the final version on Channel 37 (Fairfax County's community bulletin board and over the air Radio Fairfax channel).

After completion of a radio summer camp students are certified as FPA Radio producers and if interested can become certified continue to use the studios to create a radio show of their own. As FPA members, camp students will also have the option to network with our current public access radio producers to observe and shadow their productions to gain more production experience.

Positions covered in the Radio camp include - Voice over, On-Air Talent, Radio Producer, radio studio operator, and overview of post-production audio editing.

Parental Consent Requirement during future productions

After the completion of each camp students between the ages of 12-16 who submit a program proposal idea for their own show must have a parent or legal guardian approve the proposal and give consent. A parent or legal guardian must be present during any future television or radio productions conducted by a minor.

This does not apply to any camp production requirements.

How do I register and pay for a camp?

It's highly recommended to contact the Training Dept. ahead of time to check for camp availability.

Where are the camps held?

All camps and orientation sessions are held in our studio facilities at: 2929 Eskridge Rd., Suite S, Fairfax, VA 22031. As part of the TV 101 Field camp, field production exercises are conducted in locations around the station. Such as the Alliance for Community Media and the Merrifield Mosaic District centers.

Are there any camps discounts?

The FPA summer camp fee includes the yearly FPA membership cost of \$26 dollars. As part of the 2019 camp season FPA has two early registration discount options. A 10% summer camp discount for enrollments completed by May 31; or a 5% early registration discount for enrollments completed May 31st.

What are the camp's withdrawal and /or refund policy?

To withdraw and receive a full refund your request must be received no later than two business days (48 hrs) prior to the camp orientation start date. After the first session, no refunds will be made. However, if availabilities remain we can attempt to accommodate a student and transfer them to one of the next available camps. Upon confirmation please allow two weeks for refunds to be processed.
