

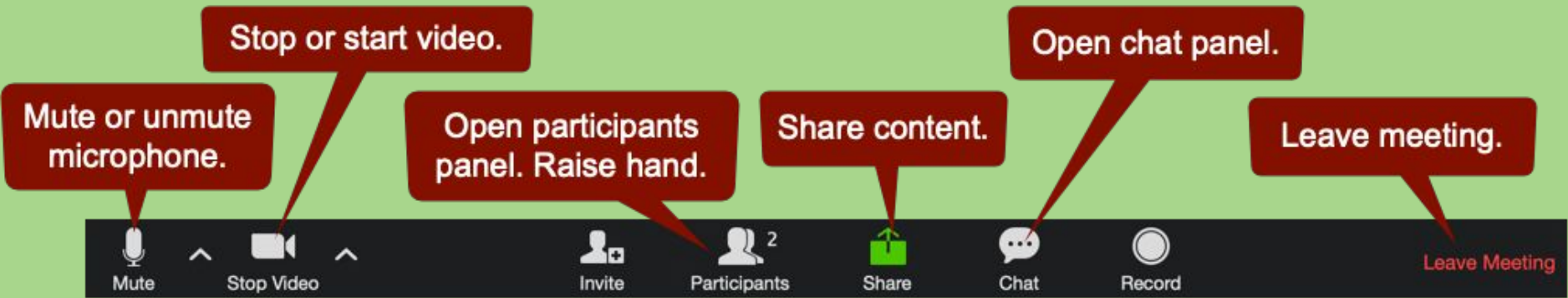

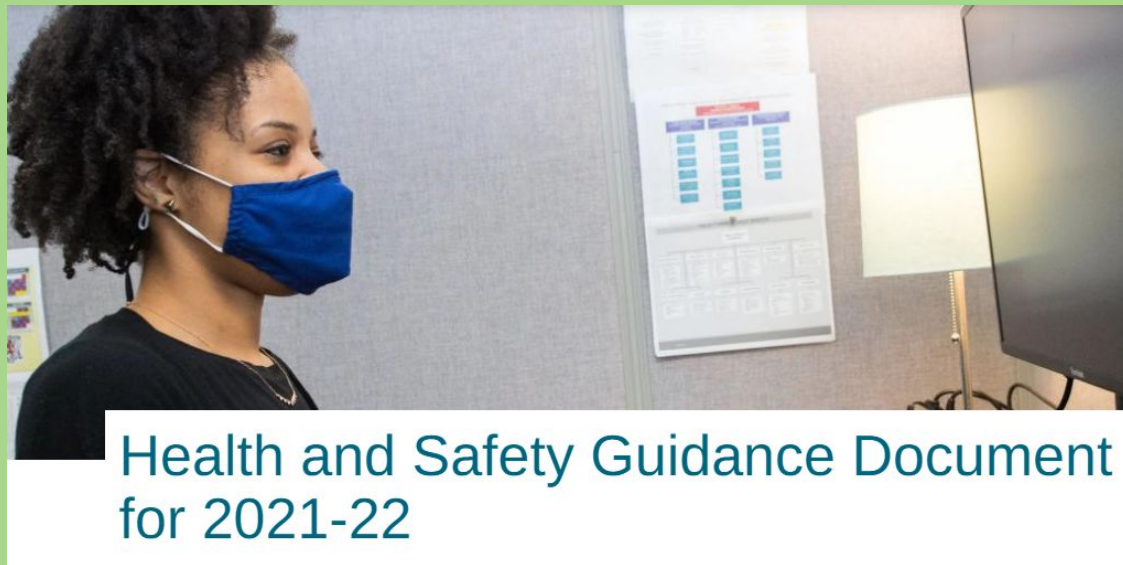

# Close Contact Definition

The CDC issued a [revised definition of close contact](#) to include an exemption for K-12 students.

A close contact is defined as someone who was within 6 feet of an infected person for a cumulative total of 15 minutes or more over a 24-hour period.

In the K-12 classroom setting, the close contact definition *excludes* students who were within 3-6 feet of an infected student where:

- Both students were engaged in consistent and correct use of well-fitting masks; *and*
- Other K-12 school prevention strategies (such as universal and correct mask use, physical distancing, increased ventilation) were in place in the school setting.

When students are wearing masks and layered prevention strategies are in place, students are not considered close contacts. Therefore, students will not miss in-person instruction or activities for quarantine after an exposure.

# Sick Children

## Attendance- Reporting Sick Children at Home

Inform staff on the attendance line of symptoms your child is experiencing if they are home sick. It helps us track and monitor classrooms for additional needs. Inform us if you receive a diagnosis from a doctor that is considered contagious.

## Sick Children at School

Sick children will be isolated in the care room and supervised until picked up by a parent. If Covid symptoms are present, a negative Covid test OR clearance by a doctor will be needed for return to school.

## Returning to School After Diagnosis

Students who have been diagnosed with COVID-19, may not return until:

- It has been at least ten (10) days since my child first had symptoms AND
- My child has had no fever off anti-fever medicines (ex: Tylenol, Ibuprofen) for 24 hours AND
- My child's symptoms are getting better

# Health and Safety

## Food and Nutrition Services (FNS)

## Indoor Dining

- Masks required when not actively eating and drinking

CDC recommends social distancing\*, to the extent possible, while masks are removed (i.e., while eating or drinking). CDC also indicates that schools shall not exclude students from in-person learning to keep a minimum distance requirement

## Recess

- Face masks are not required on the playground
- Handwashing and/or hand sanitizing will be utilized before and after play.
- Note that masks may be required during high or substantial community rates.
