OUR CHANNELS

Our channels air in Fairfax County on Cox Cable of Northern Virginia, Comcast Cable at Reston and Verizon FiOS TV (Verizon airs some of our channels in a few other local jurisdictions).

CHANNEL 10

English variety channel, which airs local programming indicative of the diverse lifestyles and interests of the Washington Metropolitan area.

CHANNEL 30 WRLD

International channel airing programming in multiple languages produced by and for the multicultural regions.

CHANNEL 36

A religious, spiritual and philosophical channel open the wide variety of beliefs in the area.

CHANNEL 37 Radio Fairfax / community corner

A cable & webcast channel, which airs a unique free-form mix of radio genres. Listen using the TuneIn radio app or on the web. Channel 37 is also our Community Corner; a free service we provide for Fairfax's non-profit community. Informational slides about organizations are played over the live audio of our radio station.

TRAINING INFO

Throughout the year, anyone interested in learning more about our station and services is encouraged to begin by attending one of our free orientation / open-house sessions.

Alternatively, our website also includes a video version of the key information covered in the orientation.

Participants that decide to become members can then enroll in the various TV or Radio production courses designed to teach the use of our equipment and station policies. These general training programs are open for adults and students as young as 15, however, during the months of July and August we offer the following summer camp programs for teens (ages 12-18). These camps include hands-on training in the use of our station equipment and mirror the core training programs offered throughout the year. Our 2024 Summer Camp programs include the choice of two separate camp topics to choose from. A two-week TV Studio Production camp or a 1-week Post-Production video editing camp (two separate starting dates for each).

MEMBERSHIP

Completing the annual membership fee of \$26 helps support our mission, entitles our members to enroll in our educational courses, and permits members who are residents of Fairfax County to vote for candidates at the annual meeting and election for FPA's Board of Directors.

In regards to our summer camps, the camp registration forms are equivalent to the membership form. Membership registrations can be completed by mail, by calling the Training Department or in person.

Furthermore, the camp fee includes the cost of the annual membership fee.

2024 summer camp options



DISCOVER the behind the scenes process of what it takes to create a television program. Learn about the equipment and key production roles. There is a lot of effort involved; therefore, teamwork and preparedness will be key to making a successful show. Each program created as part of the camps will only be as good as the crew involved; therefore, we are looking for the best, most dedicated students interested to learn about this exciting media.

The goal for the TV Studio Camp is to create a 30-minute program, planned and filmed by the students and then edited with the aid of the instructor. If successful, the program will then air on Channel 10.

The goal of the TV Post-Production camp is to delve into the editing process and teach students the use of the industry standard Adobe Premiere Pro and the role of a video editor.

TV101 Studio Production Camp



Our studio TV camp includes instruction in pre-production and production areas, including all the key equipment and crew roles such as scriptwriting, studio lighting, studio cameras, set design, audio, floor directing, on-air talent, graphics, and technical Directing. Learn the “how to’s” of creating studio television programs and what is needed to put together a half-hour show. Successful completion of the camp allows students to receive certification approval on both the use of our studio A and B equipment and as possible future TV producers. Participants will also receive a copy of the final student project and information of when it will air on Channel 10. Students are further encouraged to take advantage of their annual FPA membership and volunteer in the various studio shows to improve their skills and gain production experience.

Positions covered in the TV 101 Studio camp include - Studio Camera operator, audio operator, Lighting, Set-Design, Graphics operation, Technical Directing, Floor Directing, Talent, and an overview of post-production work.

TV101 Post Production Camp



Adobe Premiere Video Editing Camp

If you are interested in learning how to tweak and edit videos and better understand the role of a professional video editor this camp is for you. Participants in this camp will learn the functions of the widely used Adobe Premiere video editing software and the essential techniques to become proficient at editing videos. The camp objectives are twofold, the first goal is to teach students the tools and workflow on how to operate the software program and the second is to teach the concepts of basic storytelling to create more compelling TV, film or online videos. Leading to a more rounded editor.

Topics covered in the editing camp include:

Program tools, importing and trimming footage, adding transitions, working with audio and music, using text/graphics, color correction and exporting.

Cost: \$350

NETWORKING

After completion of each camp and the approval of the equipment certifications students can contact the Training Department to be included in our volunteer eGroup. The Training Department will share weekly announcements on behalf of producers looking for crew assistance and information regarding upcoming productions.

Important Note:

Parental Consent Requirement as part of future productions:

After the completion of each camp students between the ages of 12-17 who submit a program proposal idea for their own show must have a parent or legal guardian approve the proposal and give consent. A parent or legal guardian must be present during any future television or radio productions conducted by a minor.

Are there any camps discounts?

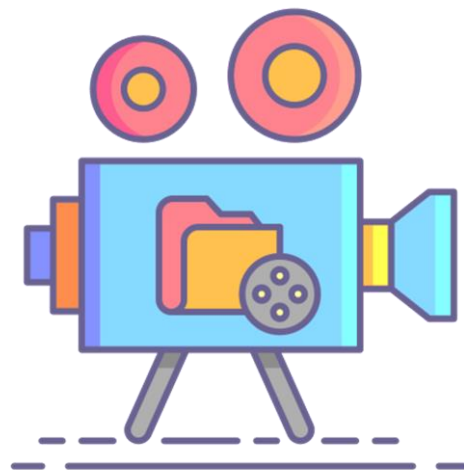
Our summer camp fee includes the yearly membership cost of \$26 dollars and as part of the 2024 camp season we are offering a 10% discount for enrollments completed by April 30th.

What are the camp's withdrawal and /or refund policy?

To withdraw and receive a full refund, your request must be received no later than two business days (48 hours) prior to the camp orientation start date. After the first session, no refunds will be made. However, if availabilities remain we can attempt to accommodate a student and transfer them to one of the next available camps. Please allow two weeks for refunds to be processed.
