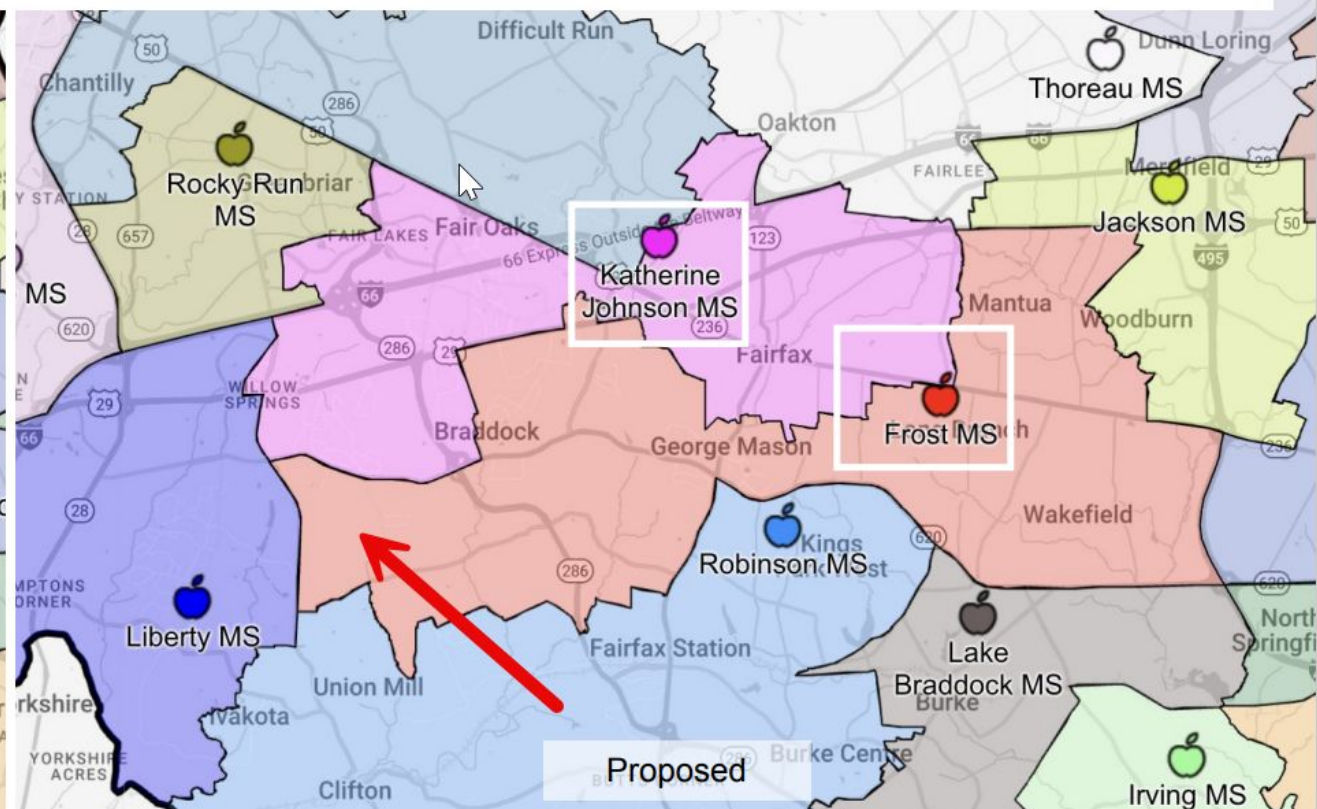
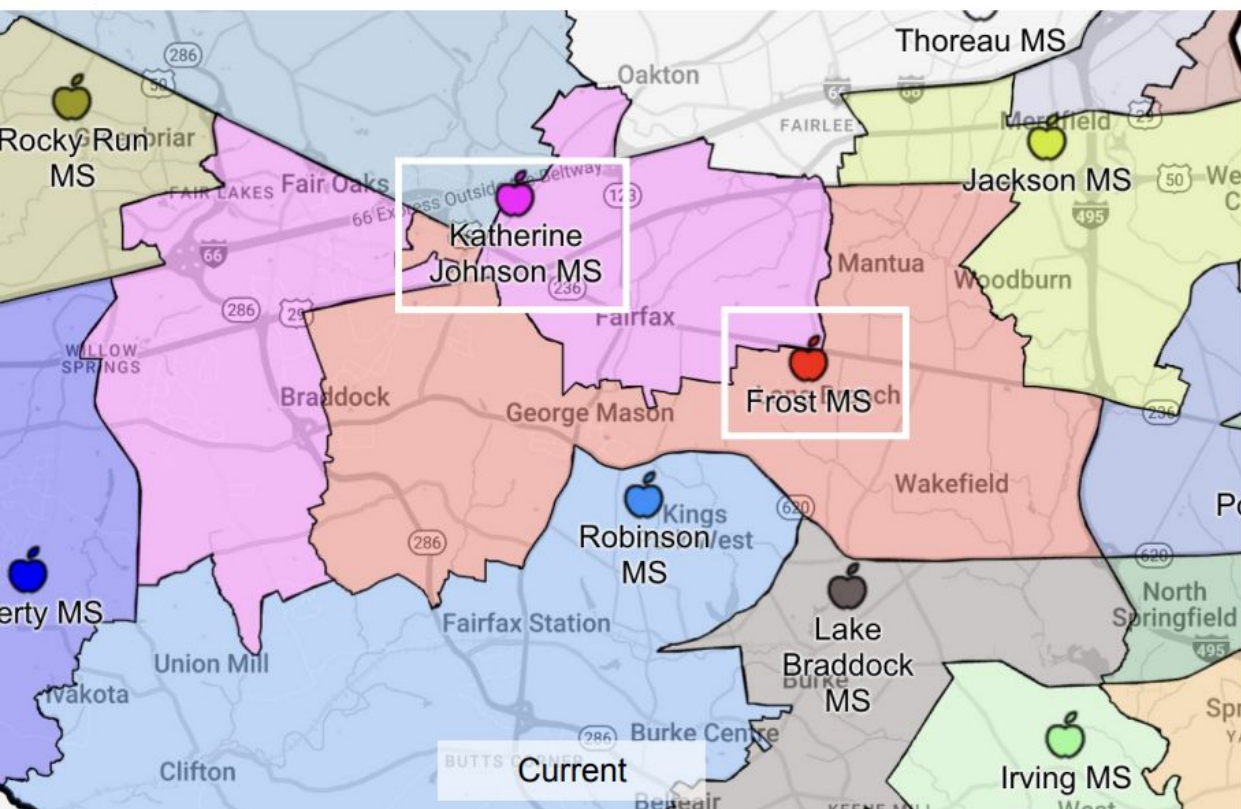




# Middle Schools Impacted by Willow Springs Elementary School Changes (Previous Slide)

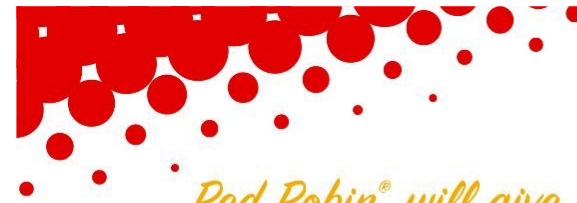

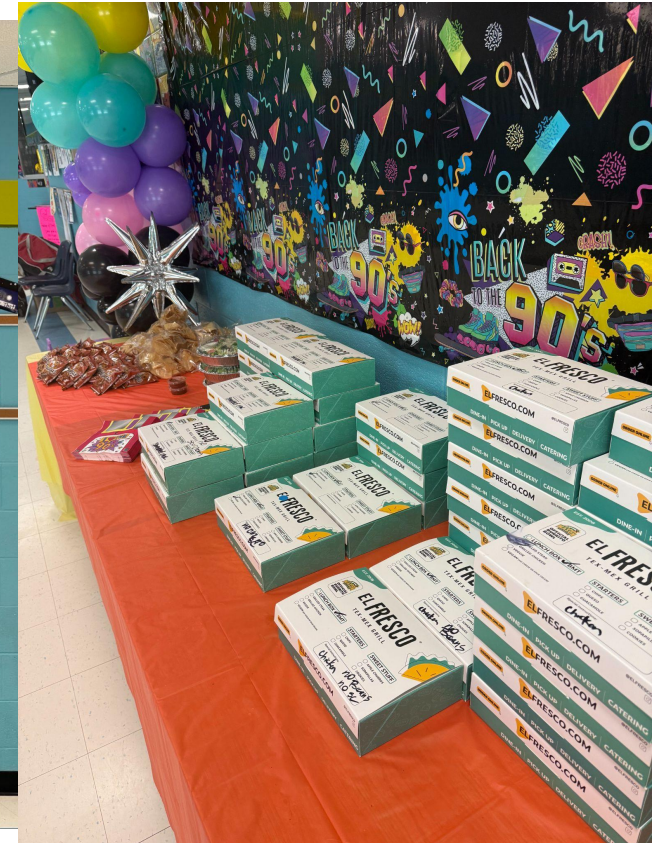
