What We Do:

Registered nurses and Family Support Specialists partner with families to visit them in their home, providing health and wellness education, parenting education and support, child development information, and connection to medical and community resources. Our program is free and voluntary.

Who Do We Serve:

- Families must have either a pregnant mother or children under the age of 7 years old
- Families must live in Charlottesville, Albemarle, Louisa, or Fluvanna
- Families must be at 200% or less of the Federal Poverty Level (or Medicaid-eligible)

What Makes a Ideal Referral:

- Families meet the above criteria
- Families who have needs that can be supported with prevention-based education
- Families who are open and receptive to support
- Families who can consistently be home for monthly home visits
- Families who know they've been referred

What Makes a Less-than-Ideal Referral:

- Families with significant untreated mental health or substance abuse concerns
- Families in significant and chronic crisis
- Families who are unaware they've been referred and who are not open to support
- Families who cannot commit to being available for monthly home visits which would occur between 8-5:30pm Monday through Friday
