



Child Care Subsidy Increases for All Provider Types Effective July 1, 2020

Effective July 1, 2020, the Washington State Department of Children, Youth, and Families (DCYF) will increase child care subsidy base rates for licensed family home, center and licensed exempt family, friend and neighbor (FFN) providers.

- Your July invoice will reflect this rate increase.
- Licensed provider tiered reimbursement will be calculated on the increased base rate.

Claiming a Rate Less than Rate Printed on Invoice

Please review each invoice to confirm the updated rates. By rule, DCYF cannot pay a child care subsidy rate that is more than a provider's private pay rate. You may need to take additional action based on your private pay rates.

- If your invoiced rate is the same as your private pay rate, then no further action is needed.
- If your invoiced rate is more than your private pay rate, please report your rates to DCFY by emailing providerhelp@dcyf.wa.gov or by calling the provider line at 800-394-4571 to have your child care subsidy rate updated.
- You may decrease your rates when claiming through the online portal when you submit a claim.
- Your invoiced rates cannot be corrected by calling Invoice Express when you submit a claim.
