

What is Northwest Justice Project?

The Northwest Justice Project (NJP) is Washington's publicly funded legal aid program. Each year NJP provides critical civil legal assistance and representation to thousands of low-income people in cases affecting basic human needs such as family safety and security, housing preservation, protection of income, access to health care, education, and other basic needs. NJP is a member of the Washington State Alliance for Equal Justice.

What is Health Justice Initiative?

- HJI is a partnership between medical providers and NJP to provide civil legal services to patients.
- HJI serves people in Spokane, Ferry, Stevens, Garfield, Pend Oreille, Lincoln, Whitman, Asotin, and Grant Counties, as well as the Colville, Kalispel, and Spokane Reservations.

What Kinds of Problems Can HJI Address?

HJI can help you with many areas of the law, including:

- Individual Advocacy for Patient Rights
- Public Benefits (welfare, SSI, etc.)
- Special Education
- Disability Rights
- Tenant Rights and Obligations
- Unlawful Detainer and Eviction Actions
- Consumer, Collections, and Legal Financial Obligations
- Guardianships
- Tribal Law
- Family Law

HJI cannot help you with criminal matters.

HJI does not cover certain types of civil law, including personal injury and medical malpractice.

What Can I Expect When I Call HJI?

- You will get a voicemail. Leave a detailed message explaining your issue and be sure to include your contact information so HJI can call you back.
- An NJP screener will listen to your call and call you back within three business

- days. If you do not hear back from someone within three business days, please call back and leave another message.
- When you get a call back, you will be asked for financial and other information to determine whether you are eligible for our services.
- We will ask you for information about the person, business, or agency with whom you are having a problem. This helps us avoid conflicts of interest.
- Your information will be given to HJI staff and a time will be set up to talk with you either by phone or in person.
- Please gather any paperwork you have related to your problem. It will also help if you have important information such as the names, addresses, and telephone numbers of people involved with the problem.
- Based on the information you give us, you may be given advice that could help you to solve your problem on your own.
- ❖ In some cases, we may try to solve your problem through negotiation. The HJI or NJP may be able to represent you if the problem is more complicated. This is decided on a case-by-case basis.

Who Should Contact HJI?

- You have a civil (non-criminal) legal problem; and
- You are not currently working with a lawyer or another legal services provider.
