IMPORTANT PARENT/GUARDIAN UPDATE

Children ages 12 years+, and older, can now get vaccinated against COVID-19

Dear Parent or Guardian:

Children who are 12 and older can now get the COVID-19 vaccination to protect them from

getting the coronavirus. The Pfizer-BioNTech COVID-19 vaccine was approved by the federal government on May 12, 2021. Additional review was conducted by the Western States Scientific Safety Review Workgroup (WSSSRW) and approved the Pfizer vaccine for 12 and older in Washington state.ⁱ



What parents need to know about Pfizer:

- Children ages 12-17 can only get the Pfizer-BioNTech vaccine. The other two vaccines in the U.S. are only available for ages 18 and older.
- The Pfizer vaccine is given in two doses, spaced at least three weeks apart.
- Check with the vaccination site on how you will need to provide consent for vaccinating a minor.
- Follow the vaccination site rules for protecting yourself and others.
 - In preparation for school be sure to contact your child's provider about scheduling COVID-19, other vaccinations, and wellness visits.
 - The Pfizer vaccine is safe and effective in adolescents 12 and up. Just like adults, children may experience some common side effects for 1 to 3 days after vaccination, including sore arm, tiredness, or headache.
