COVID-19 surveillance data are dynamically stored in the Washington Disease Reporting System (WDRS). The data are updated when new information about a case is entered, such as exposure information, change in address, lab data from diagnostic and routine tests, date of death, case information from medical providers, or information from other jurisdictions indicating a person has moved out of Washington. Given the dynamic nature of COVID-19 surveillance data, data reported in the past may not match data reported in present time.

The data in this report is reflective of all cases received as of 11:59 PM 11/20/2020.

Notice:

- On 10/22/2020, we added a table that shows antigen-positive case counts by county. Antigen-positive cases are defined as an individual with a positive antigen test in the absence of a positive PCR test. Confirmed cases are individuals with a positive PCR test. **Hospitalization, death, and testing data are based on PCR results.**
- On 8/25/2020, we added updated testing data reflecting tests rather than individuals. The updated method is applied to the entire time frame covered in the dashboards.

Death counts are no longer updated over the weekend. All death numbers are as reported Friday.
