**Purpose of the proposal and its anticipated effects, including any changes in existing rules:** RCW 43.70.250 requires that the costs of licensing each profession be fully borne by members of that profession. The Office of Financial Management also requires professions to maintain a reasonable cash reserve to cover fluctuations in cash flow and operating expenses. These changes are needed to ensure the department is in line with RCW 43.70.250 and the fees set are sufficient to recover the costs of licensing the professions. These changes will also address the petition from the WA Acupuncture and Eastern Medicine Association (WAEMA) Board requesting the department lower the licensure fees for Acupuncture and Eastern Medicine Practitioners. The department is also proposing modifications in rule language for clarity and consistency.

**Reasons supporting proposal:** Assessments of fund balances were performed to determine if the fund balances were projected to have either too much or too little to maintain levels. These adjustments are needed to maintain the appropriate balance amounts as identified in the assessment. RCW 43.70.250 requires that the costs of licensing each profession be fully borne by members of the profession.
