(ACWSP) Guidance

Issuing Entity: Washington State Department of Health, Environmental Health Programs,
Division of Drinking Water

Description: The guidance document entitled "Abbreviated Coordinated Water System Plan (ACWSP) Guidance" provides information on minimum statutory requirements of elements of RCW 70.116 relating to an abbreviated method of utilizing the Public Water Coordination Act. The purpose of this guidance document is to: help local governments and water utilities develop the ACWSP; identify mandatory elements and processes needed to fulfill the requirements of an ACWSP; discuss the major plan elements and provide clarification on their use and integration; suggest one process which may be used in the development of the plan; and identify the major differences between the development of the ACWSP and the full CWSP. The use of this guideline and its suggested approach is voluntary.
