

Keeping current with training requirements

For Community Residential Providers impacted by training requirements outlined in [RCW 74.39A](#):

- Supported Living
- Group Homes
- Group Training Homes
- Alternative Living
- Companion Homes
- State Operated Community Residential (SOCR)
- Children's Licensed Staffed Residential Homes

Rules for the training requirements are contained in [Chapter 388-829 WAC](#) and additional standards for the adult residential programs are located in [Chapter 388-101D WAC](#).

Plan for Continuing Education Training

Important Note Regarding CE Deadlines

Because the state of Washington is currently in a state of emergency, no Continuing Education credits are currently due. According to WAC 388-829-0087:

“(4) of this section due to the COVID-19 public health emergency. All direct support professionals have 120 days from the end of the public health emergency to complete any

additional CE that may have become due while training waivers were in place in excess of the 12 hours of CE granted in subsection...”


REMINDER: Between **March 1, 2020, and February 28, 2021**, DDA recognizes Direct Support Professionals received, as part of on-the-job training, critical instruction related to hand hygiene, disinfection of high-touch surfaces, protocols for quarantine, the proper use of face coverings, etc.

What does this mean for DDA Contracted Providers?

- You can claim 12 CE credits for either 2021 or 2022. There is no need for you to track curriculum or dates for training.
- You will complete the Community Residential Staff Specialized CE hours form – [see below and the attachment in the GovDelivery message.](#)
