Another key responsibility is as a lead fidelity reviewer for agencies that host an Individual Placement and Support (IPS) supported employment fidelity review.

Dawn also monitors various contracts and assists with planning and facilitating multiple supported employment webinars each month. IPS is the evidence-based practice of supported employment and is utilized by FCS SE agencies per contract with Amerigroup. Prior to joining HCA, Dawn worked for 21 years in a behavioral health agency providing and supervising supported employment services. Dawn writes, "It is interesting to me that once upon a time, I had high anxiety when speaking to groups. Having said that, the thing I like most about my job at this time is public speaking! Darren is a Supported Employment Program Manager for Western Washington. This position allows him to train, support, and mentor agencies to provide IPS Supported Employment, and in the process, extend the message of honoring the whole individual and all their potential.



Darren specializes on the implementation of the Individual Placement of Support (IPS) model of Supported Employment. Over the last twenty-six years, he has provided the behavioral health community with advocacy to promote education, recovery, and resiliency opportunities, and operationalized programs to reduce the impact of poverty on individuals with severe mental illness. Darren's work has also included presentations on the issues of fighting stigma and finding solutions with the Thomas C. Wales Foundation; delivered presentations on employment at the Washington State Behavioral Health Conference, and King County's Recovery and Resiliency: Steppingstone to Wellness Conference. He has also been an active member in the International IPS Learning Community and the Division of Vocational Rehabilitation/Mental Health Cross System state trainings.
